

Report of
The 5th D-8 Agricultural Ministerial Meeting on Food Security

3 December 2014
Istanbul - Turkey

The Government of the Republic of Turkey hosted the 5th D-8 Agricultural Ministerial Meeting on Food Security on 3 December 2014 in Istanbul. Delegates from the People's Republic of Bangladesh, the Arab Republic of Egypt, the Republic of Indonesia, the Islamic Republic of Iran, Malaysia, the Federal Republic of Nigeria, the Islamic Republic of Pakistan, and the Republic of Turkey attended the Meeting. 1. Opening

2. Election of the Chairman and Appointment of the Rapporteur(s)

The Meeting Elected the Minister of Food, Agriculture and Livestock of the Republic of Turkey, H.E. Mr. Mehmet Mehdi Eker as the Chairman. The Meeting also elected a drafting committee, comprising delegates from Turkey and Nigeria with the assistance of D-8 Secretariat.
