



**Memorandum of Understanding on cooperation BETWEEN  
THE D-8 ORGANIZATION FOR ECONOMIC COOPERATION AND  
THE ANATOLIAN YOUTH ASSOCIATION**

**ARTICLE 1- Parties**

The parties to the MOU are D-8 Organization for Economic Cooperation (hereinafter referred to as D-8) and Anatolian Youth Association (hereinafter referred to as AGD).

**ARTICLE 2 – Purpose**

The purpose of this MOU is to provide awareness to young people on D-8.

**ARTICLE 3 - Scope**

The scope of this MOU is to develop a framework for collaboration between D-8 and AGD in accordance with the purpose of this MOU.

**ARTICLE 4- Areas of Cooperation**

Parties agree to promote and extend cooperation and understanding between D-8 and AGD in the joint working areas. The parties agree to cooperate on the following items;

- 1) The parties shall organize joint programs for young people on the mission, objectives and mandate of the D-8 organization.
- 2) The parties shall organize joint programs for promoting the D-8 and stressing its significance for future generations.

**ARTICLE 5 – Responsibilities of Parties**

- 1) The parties agree to engage in mutual knowledge sharing, and to provide for the exchange of scientific publications for educational and research purposes.
- 2) The Parties shall jointly organize scientific activities (such as seminars, conferences, workshops, symposiums, congresses, and distance education programs).
- 3) The Parties shall jointly organize an advanced specialization training programs on D-8 and its cooperation areas and its member states.

**ARTICLE 6 – Responsibilities of AGD**

- 1) AGD shall conduct promotional activities for advanced specialization training program on D-8.



- 2) AGD shall execute application processes for advanced specialization training program on D-8.
- 3) AGD shall complete distance education system software for advanced specialization-training program on D-8.
- 4) AGD shall find and upload the academic program and reading lists to the distance education system in consultation with the D-8.
- 5) AGD shall organize conferences and seminars for the advanced specialization-training program on D-8.

#### **ARTICLE 7- Responsibilities of D-8**

- 1) D-8 shall support in the designing of an academic program for the advanced specialization-training program on D-8.
- 2) D-8 shall share data on potential avenues for hosting the advanced specialization-training program.
- 3) D-8 shall correspond with its member states for the participants who wish to go to D-8 member states for academic study.

#### **ARTICLE 8 – Duration**

This MOU will become valid when it has been signed by the legal representatives of both parties, and it will be valid for a period of two (2) years. The MOU may be extended further if mutual agreement is reached by written consent.

#### **ARTICLE 9 - Execution**

This MOU is executed by the Secretary General of the Developing 8 Organization for Economic Cooperation (D-8) and the Chairman of the Anatolian Youth Association.

#### **ARTICLE 10 – Entry into force**

- 1) This MOU, which consists of three (3) pages and 10 (ten) articles, has been prepared in English as two (2) original copies and shall enter into force on 13/12/2019 when all copies have been signed by the authorized legal representatives of both parties.
