Report Of the 21st Session of the D-8 Council of Ministers 18 December 2024, Cairo

The 21st Council of Ministers was held on 18th December in New Administrative Capital Cairo, Arab Republic of Egypt. Ministers/Representatives from D-8 Member States participated in the meeting. The List of Participants is attached as **Annex-I**.

Statement Dr. Badr Abdelatty Minister of Foreign Affairs, Emigration and Expatriates the 21st Session of the D-8 Council of Ministers 18 December 2024

Excellencies, dear brothers, the D8 Ministers;

Ladies and gentlemen;

At the outset, I wish to warmly welcome Your Excellencies to Egypt, and to the 21st Session of the D-8 Council of Ministers as we prepare together for the 11th D-8 Summit. I also wish to express my sincere appreciation to Ambassador Riaz Hamidullah, the Secretary of the Ministry of Foreign Affairs of the People's Republic of Bangladesh, for his country's relentless efforts to strengthen the work of our organization and foster the spirit of cooperation among us during the Presidency of Bangladesh of the D-8.

I also wish to extend my appreciation to our Commissioners for their tireless efforts in preparation for our meeting today and the D-8 Summit tomorrow, and to H.E. Isiaka Imam, the Secretary General of D-8 and his able team, for the support they have given us to ensure the success of our meetings.

Excellencies,

We meet today amid multiple and interlinked challenges and crises that have disproportionally affected our developing countries. These crises include geopolitical conflicts and tensions, a series of unprecedented and overlapping economic challenges, high levels of debt distress, increasing inflation rates, rising inequality, the adverse impacts of climate change and above all the humanitarian catastrophe in Gaza.

The inhumane Israeli war of aggression against Gaza and the occupied Palestinian territories is without a doubt one of the greatest tragedies of our time, resulting in a grave humanitarian crisis of catastrophic magnitude with over 40 thousand Palestinians losing their lives, of whom two thirds are women and children, more than 1.9 million people forcibly displaced, 60 % of homes destroyed and a complete collapse of the infrastructure.

The Israeli aggression did not stop at Palestine. The same oppressor has continued its relentless violation of international law and the basic principles of humanity to attack Lebanon, Syria and other countries in the region. The economic losses and physical damage resulting from the Israeli aggression in Lebanon are estimated at 8.5 billion US dollars, with almost 100,000 housing units partially or fully damaged. It is for this reason that we took the initiative to hold a special session on Palestine and Lebanon during the work of our Summit tomorrow.

Excellencies, ladies and gentlemen,

Against this backdrop, and in light of these challenges and crises, we must further enhance and strengthen our cooperation in all sectors. In conjunction, we have to exert all efforts to discover new areas and avenues of collaboration, with a view to realize the aspirations of our people, achieve sustainable development and eradicate poverty, while also preparing for other emerging challenges. It is in this context that I wish to highlight the following:

First: We have envisioned that the D-8 summit shall take place under the theme: "Investing in Youth and Strengthening SMEs: Shaping Tomorrow's Economy". We firmly believe that investing in our youth is a direct investment in our future. We need to equip youth with the necessary tools, build their capacities and knowledge, as well as support and nurture youth entrepreneurship. In this regard, we should work together to ensure that our youth can embrace new tools and trends, especially emerging technologies and innovation, such as artificial intelligence.

Second: Egypt is committed to further deepen our cooperation in all fields. We look forward to hosting the first D-8 Ministerial Meeting on health, to discover new avenues of cooperation and explore the various technological advancements in this critical sector. In the same vein, we will also host the fourth D-8 Ministerial Meeting on Tourism, as well as the D-8 Ministerial meeting on Trade. I take this opportunity to share that Egypt will ratify the D-8 Preferential Trade Agreement in the upcoming weeks, as we firmly believe in the utmost necessity of promoting trade and developing a clear roadmap to encourage investments among our taking consideration countries, into the plentiful comparative advantages that we have as a group.

Third: Strengthening our academic and training cooperation is needed now more than ever. We propose establishing a "Network for Institutes of Diplomatic Studies" among the D8 Member States to foster cooperation and expertise, while educating exchange our next generation of Diplomats about new trends and tools. Egypt will launch the "Network Similarly, Economic Think Tanks" to serve as a platform for sharing expertise, best practices and prepare joint studies to assist us in achieving our common economic and developmental efforts.

Fourth: As we meet today, the financing gap to achieve the sustainable development goals stands at 4 trillion dollars annually, while the needs of developing countries to implement their nationally determined contributions are in the range of 5.8 trillion dollars up to 2030. We need to expedite our efforts together, as members of D-8, at different multilateral fora and meetings, to ensure that the necessary means of implementation, including concessional finance, is provided to our countries.

Fifth: While we are working relentlessly to achieve national development plans, we should ensure that the private sector is part and parcel of these endeavors. Our ultimate objective should be to create an enabling environment for the private sector to further contribute to implementing our shared vision. In this regard, D-8 members may consider establishing a "Private Sector Forum". This forum should be a platform for private sector entities in our countries to interact and collaborate, in order to achieve our common aspirations.

Excellencies,

I am confident that our deliberations today, and our Leaders' deliberations tomorrow, will lead to concrete steps to deepen and strengthen our cooperation at all levels and in all sectors, while we aim together to achieve the development of our countries and realize the legitimate aspirations of our people. I wish you all fruitful and successful discussions that pave the way for a brighter future together.

STATEMENT BY H.E., AMBASSADOR ISIAKA ABDULQADIR IMAM, THE D-8 SECRETARY GENERAL, AT THE 21ST SESSION OF THE D-8 COUNCIL OF MINISTERS, CAIRO, 18 DECEMBER 2024

Your Excellency Dr. Badr Abdelatty, the Honorable Minister of Foreign Affairs of the Arab Republic of Egypt, the Honorable Chair of the D-8 Council,

Your Excellencies, Ministers of Foreign Affairs of the D8 Member States,

Distinguished Delegates,

Ladies and Gentlemen,

As-Salam Alaikum and Good Afternoon.

I am honored to address this 21st Session of the D-8 Council of Ministers, to present the status of our organization to the esteemed Ministers.

Let me begin by congratulating the Government of the Arab Republic of Egypt, for the excellent preparation and organization of this Session, as well as the just-concluded 48th D-8 Commission and the upcoming 11th Summit. My utmost gratitude also goes to Egypt for the warm welcome and hospitality, accorded me and my delegation.

Thank you, Your Excellency, Minister Abdelatty.

Before continuing, allow me to congratulate Bangladesh on her exceptional Chairmanship of the D-8, over the past three years. Remarkable achievements were recorded, during their tenure, laying the foundation, for our organization's growth. I extend our best wishes to Egypt, as the D-8 Organization's sitting chairman-in-office.

We are confident Egypt's stewardship will open new frontiers, for enhanced cooperation in the D-8 development agenda.

I would also like to thank all Member States, for their unwavering support, which has enabled me to fulfill my duties as Secretary-General.

Your Excellencies, Distinguished Delegates.

Since this Council's previous session in 2022, our organization has been advancing, our shared cooperation agenda. Among the highlights, since the 20th Session of Council, was the **Extraordinary**Meeting of the D-8 Council of Foreign Ministers, in Istanbul last June. That meeting, generously hosted by Türkiye, deliberated on the Situation in Gaza. This has demonstrated our steadfast support towards, Palestine.

As we gather today, our solidarity for the Palestinians continue to resonate, evidently with the convening of a special D-8 summit session on Palestine and Lebanon, scheduled for tomorrow. Later today, Council will deliberate on the draft Joint Communique on Palestine and Lebanon, which our Leaders, will issue tomorrow.

Honorable Chair, Excellencies, Distinguished Delegates,

Allow me to highlight some of our organization's major achievements, since the last Session of Council.

[Trade]

Trade remains central to our organization. Over the past two years, the D-8 Trade Ministers Council (TMC) has convened twice: once, for its third ordinary session in Dhaka, in March 2024 and, three months later, for an informal meeting in Istanbul. Those meetings were crucial platforms, for renewed commitment from the member states,

to effectively implement the D-8 Preferential Trade Agreement (D-8 PTA).

For instance, Indonesia and Türkiye have commenced trading, under the provisions of the D8 PTA, while other member states are making arrangements, to implement this crucial trade instrument, to enable us meet our objective of reaching 500 billion US Dollars intra-D-8 trade value by 2030.

This year, we adopted the Protocol on Dispute Settlement Mechanism (DSM), an integral part of the PTA. Four Contracting Members have signed the DSM Protocol, while the remaining four are expected to sign it, during the 4th TMC Meeting, which Egypt will host in 2025.

[Agriculture]

Our agriculture and food security cooperation has witnessed significant progress, with the convening of the 7th D-8 Ministerial Meeting on Agriculture, hosted by Bangladesh, virtually, in January 2022. The Ministers addressed the issue of Climate-Smart Agriculture.

Furthermore, a series of webinars on modern technique of agricultural practices, were also hosted by Türkiye and Bangladesh. Nigeria is set to host the 8th Ministerial Meeting on Agriculture and Food Security, in 2025.

We also saw the inauguration of the D-8 Research Center on Agriculture and Food Security (D-8 RCAFS) in Faisalabad, Pakistan, in March 2023. The Centre, is fully operational and has engaged with

the Islamic Organization for Food Security (IOFS), through a Joint Action Plan, for 2024 - 2026.

[Tourism]

In the area of tourism, Pakistan, successfully hosted the 3rd D-8 Ministers of Tourism Meeting in Bhurban Muree, Pakistan. That meeting produced the "Islamabad Declaration on Tourism." As a follow up, we have established the "D8 Tourism City of the Year Award." The City of Antalya, in Türkiye, is the maiden recipient of this award, for 2025. We congratulate Türkiye, on this historic achievement, as we eagerly anticipate Egypt to host the 4th Tourism Ministerial Meeting, in Aswan, next year.

[Transportation]

We are also working to advance our civil aviation cooperation. Let us thank Indonesia and Türkiye, for hosting the 12th and 13th Sessions

of the Directors-General and Experts Working Group on Civil Aviation in Bali and Antalya, respectively. Allow me, Mr. Chair to propose that we also embark on maritime connectivity and explore the Blue Economy Agenda, under the transportation cooperation agenda.

Honorable Chair, Excellencies and Distinguished Delegates, [SME and Youth Development]

We are prioritizing SME and Youth development in our cooperation agenda, as this crucial to the growth of our organization. This aligns perfectly with the theme of the 11th Summit, "Investing in Youth and Supporting SMEs: Shaping Tomorrow's Economy,". SMEs serve as the primary driver of economic growth, in our member states, while 210 million or 20% of our 1.1 billion population, are made up of youth.

Nigeria successfully hosted the First D-8 Forum on SMEs and Health Market in October 2022, to advance the role of SMEs in our economic development. Building on this Forum's success, Nigeria has proposed to establish and host D-8 Center for Small and Medium Enterprises in Abuja, for the benefit of all member states.

On youth development, we hosted the 1st D-8 Youth Ministerial Meeting in Dhaka, Bangladesh, last May, laying the groundwork for a D-8 Youth Council, which Bangladesh will host. Nigeria has committed to host the 2nd Ministerial Meeting on Youth, in 2025.

Honorable Chair, Excellencies, Distinguished Delegates, [Private Sector and External Relations]

Our collaboration with the private sector is expanding, rapidly. For instance, we are collaborating with, Al-Hidayah Group of Malaysia, to

establish the D-8 Creative Economic and Financial Centre, to drive digital economy, sustainable investment and halal economy.

In Türkiye, we are partnering with Arvasya Holding, to explore D8 New Generation Barter Trading, to enhance our intra-trade through counter-trade. In Nigeria, we are discussing the promotion of halal industries, with the Dar Halal Group, while talks are on-going with Invest Nigeria, a private investment management company, to promote intra-D-8 cross-border investments. In Iran, we initiated collaboration with FANAP, an Iranian ICT company, to grow the digital economy, through the First D-8 Digital Economy Forum, planned for 2025, in Iran.

In the area of External Relations, I am proud to report that the D-8 is now relatively well-known, globally. Thanks to active and sustained collaboration with our external partners, particularly the UN and its

Specialized Agencies as well as the OIC and its organs and other international organizations as well as the media. Today, D8 agenda is well advanced, while its visibility has also improved, significantly, as our organization continue to receive invitations, to high-level regional and international events.

[Affiliated Bodies]

Honorable Chair, Excellencies, Distinguished Participants

The D-8 affiliate bodies also recorded, significant progress. The D-8 Technology Transfer and Exchange Network, based in Iran, collaborated with the Ministry of Science, Technology and Innovation of Malaysia, to organize the 6th D8 Technology Investment Meeting in Malaysia, in August, 2024.

The D-8 Network and Pioneer for Research and Innovation (NPRI), hosted by Pakistan, convened the 3rd Meeting of the NPRI, last

month, hosted by the University of in Ilorin, in Nigeria. The NPRI is the D-8 R&D branch, which can be used to support our development agenda. The NPRI welcomed two new members, the University of Ilorin in Nigeria and the Universiti Teknologi Malaysia (UTM).

The D-8 International University, hosted by Iran, also expanded its scope, by offering graduate and post-graduate programs. I call on member states to accredit the programs of the D-8 University, accordingly.

The D-8 Health and Social Protection Program, hosted by Nigeria, successfully conducted a study on therapeutic medicines in the D-8 Member States, with funding from the Islamic Development Bank in 2023. The D-8 HSP is an ideal bastion, for our medical research and development.

The D-8 Chambers of Commerce and Industry (D-8 CCI), held its fourth General Assembly, yesterday, here in Cairo. Last October, one of its members, the Indonesian Chamber of Commerce, organized the D-8 Business Forum, in Jakarta.

Honorable Chair, Excellencies, Distinguished Guests, Ladies and Gentlemen,

With progress come challenges, and I can identify, three of them. **First**, the Secretariat has a manpower shortage. If it is equipped with adequate manpower, the Secretariat can do much more, in achieving the D-8 objectives.

Second, our organization does not have a development budget. Therefore, I propose the establishment of a **D-8 Development Fund**, to address this challenge. I humbly call on this noble Council to support this novel initiative, which, if materialized, will be a game changer, for the D8 organization.

Third, frequent unmet quorum. The success of our endeavors, hinges on the active participation of the esteemed Member States. Regrettably, we have experienced situation, where several of our meetings and activities, have to be postponed, due to lack of quorum. For this purpose, I would like to appeal to our esteemed member states, for increased participation, in our activities and programs.

In conclusion, **Honorable Chair, Excellencies, Distinguished Delegates,** our beloved organization is an ideal platform for robust collaboration. Therefore, as we move forward, under Egypt's chairmanship, let us reaffirm our commitment to strengthening the D-8.

Our shared resolve, will make the D-8 a global economic powerhouse and an influential actor in the Global South, championing the ideals of south-south cooperation. My team and I, at the Secretariat, remain fully committed, to facilitating these improvements, working closely with the support and guidance of the member states and the esteemed Council.

This 21st Session of the Council, under Egypt's effective Chairmanship, and with Your Excellencies' active contribution, will serve as another milestone, in our shared journey of progress and solidarity.

General Statement – Bangladesh

Excellencies,

From conflicts to climate change, today multi-farous global and regional challenges grip the D8 countries. Deadly conflicts afflict this very region, even.

All the crises underline the need for us to act far more resolutely and ingeniously, collectively.

The external challenges – as they exist and evolve – should ask us to re-discover 'collaboration' afresh.

The theme of the Summit echoes aptly with our collective aspirations.

As we finalise the Summit's outcome and the Cairo Declaration, Bangladesh would like to flag a few elements for the Council's reflection:

- To date, D-8 remains essentially inter-governmental. Only exception is the D-8 Chamber of Commerce. Yet, the ways most of countries engage in other regional frameworks, we do see the vitality and benefits of engaging range of stakeholders beyond the Government. Every sectoral meeting we hold or initiative we take, those need to be driven by 'impacts' and 'result orientation'. Many back home suggest for vigorously unpacking collaboration potential through academia and research collaboration under D-8 frameworks, in sectors like trade, agriculture, energy. Given this Summit's focus on youth, we need to consider how do we bring entrepreneurship talents and energy of our youth through so many digital tools and applications.
- With over 550 million youth across D-8 member states, let us re-think how effectively we let our youth innovate, incubate and advance adaptive applications of technology. This applies eminently to scores of Small and Medium Enterprises (MSMEs) across our countries who need financing and hand-holding. Many SMEs in our countries can offer solution to some of the endemic societal challenges or climatic distress. It is time that we think of ways to effectively engage them, to unleash their transformative potential.

- D-8 has existed for long 27 years. It is time that we consider widening mobility amongst our countries, based on certain agreed criterion. We stand to benefit by liberating movement of the entrepreneurs, investors as also academics, experts, Press and Media of established credential or standing. Several peer regional organisations had incrementally gained out of people's mobility, even by introducing annual Travel Card, for instance. This surely can create greater interest and ownership among diverse stakeholders, across society and economy.
- It has been eighteen long years that we have been working on operationalizing D-8 PTA. Egypt's ratification of the PTA is a welcome step. Our private sector however question if it is fitting to reach this level when national, regional and global economic dynamics change far faster. Compared to a decade back even, manufacturing and service sectors in our countries have changed significantly. Most of our countries are aggressively involved on comprehensive bilateral economic partnerships, if not FTAs. It is therefore time that we think beyond a limited PTA towards a comprehensive economic partnership which can truly attract the entrepreneurs, investors, innovators, particularly the youth, in D-8 as a truly dynamic, competitive and impactful economic bloc. That may merit hearing directly from the Chambers and select Industry Associations in the D-8 countries, even ahead of or, on the sidelines of relevant sectoral Ministerial Meetings;
- We welcome Azerbaijan in our midst, as the ninth D-8 member state. Now that D-8 Secretariat has been at work for well over a decade, the Organisation can engage with credible, relevant and interested Regional Development Banks or similar institutions. IsDB, ADB, AfDB, for instance, can bring in wealth of expertise to complement some of our sectoral works.

But to unlock their potentials, we must provide future-proof education system, providing skills, STEM field, digital literacy, creative industries and entrepreneurial skills.
- 7. In line with the theme of this Summit, higher education institutions play a pivotal role in providing opportunities and empowering our youth. In this regard, the Ministry of Higher Education warmly invite all D-8 Member States to participate in our Malaysia's Higher Education Leadership Academy (AKEPT).

On behalf of the Government and people of Nigeria, I would like to extend my hearty congratulations to my brother and dear friend Badr Abdelatty, Minister of Foreign Affairs of the Arab Republic of Egypt, on your assumption of the Chairmanship of the D-8 Council of Ministers. I am confident that under your able leadership, the D-8 will continue to adhere to its principles and objectives. I also

wish to express my deepest appreciation to the Foreign Minister of the People's Republic of Bangladesh, the outgoing Chairman of this Council, for his qualitative leadership while managing the affairs of the council.

- 2. Let me commend the enormous contributions of Ambassador Isiaka Abdulqadir Imam, the Secretary-General of the D-8, and his wonderful team, for deploying their expertise in managing the day-to-day activities of the D-8 Secretariat and working tirelessly to coordinate the workings of the organs of the Organization. Nigeria acknowledges your efforts and the milestones we have reached in the D-8, with you as Secretary General of the Organization.
- 3. Mr. Chairman, this year's theme, "Investing in Youth and Supporting SMEs: Shaping Tomorrow's Economy," is very much more than a slogan. There is a wealth of evidence to show that SMEs are the lifeline for improving household income and moving people out of poverty. And SMEs are, typically, women and youth led, which helps to promote inclusivity and reduce inequality. This is not an abstract exercise. We are looking to draft a blue print to empower and enable people to change their own lives and in the process, promote peace and prosperity.

- 4. SMEs are critical in reshaping our social fabric towards more inclusive, equitable and sustainable growth. They act as a catalyst for knowledge transfer and innovation. Small and nimble, they are faster than other institutions in adopting and adapting to new technologies, including AI.
- 5. This is especially true in Nigeria and other parts of our region, where established values and sense of community are a natural fit with the scale, innovation and identity that SMEs represent. We see this in everything from tech start-ups to the garment sector. Our job in government is to leave it to those best able to do so to create the spark, while we focus on delivering a level playing field. We see the impact of initiatives like the Nigeria Inter-Bank Settlement System in simplifying access to finance. These are the ideas on which we need to build. Startups begin their lives as SMEs, and Moniepoint just became Nigeria's 6th Unicorn about a fortnight ago. Moove is a mobility startup owned by two young Nigerians that helps other young Nigerians to acquire commercial vehicles. Uber just invested in them. There are also SME-Start-Ups in Agri-tech and Health-tech, creating jobs for young Nigerians and women. Not just jobs, but high-quality jobs with higher incomes. Herein lies our comparative advantage.

- 5. The D-8 is working to build a fairer and more sustainable international system. In support of these ideals, Nigeria reiterates its commitment to host the D-8 SME Centre. Plans by the Small and Medium Enterprises Development Agency of Nigeria (SMEDAN) are nearing completion for the Centre's launch in early 2025.
- 6. We are all committed to the D-8's objectives. They are a vital part of efforts to make a more stable and prosperous community. But if we are to deliver, we must ensure sustained funding to provide adequate financial resources for the effective operation of this esteemed multilateral platform. To this end, Nigeria wishes to commend the Secretariat for the proposed D8 Development Fund and call on all Member States to support the initiatives.

Your Excellencies,

7. We must redouble our efforts to end Israel's aggression in Gaza by advocating for immediate, permanent and unconditional cease fire, as well as the ending of the blockade of Gaza to allow unhindered supply of the much-needed humanitarian assistance to the displaced Palestinian people. We must firmly commit to using every available opportunity towards achieving this objective and the entrenchment of a permanent resolution to the Middle East crisis through the establishment of an

independent Palestinian State. This remains the best and only path towards a sustainable peace in the region.

8. In conclusion, I wish to reiterate Nigeria's readiness to deepen cooperation among the D-8 Member States through increased trade and investment, as well as the promotion of people-to-people contact for growth and the socio-economic well-being of our citizens.

- 2. I would like to thank Egypt for the warm hospitality and for hosting this important meeting. The excellent arrangements and dedication of our Egyptian hosts have created the perfect setting for us to discuss ways to enhance economic

cooperation. We welcome Egypt as the new Chair of the D-8 and look forward to working together to promote growth and prosperity. I am confident this session will strengthen our partnerships and lead to meaningful progress for our collective prosperity.

3. I also want to express our gratitude to Bangladesh for their leadership as Chair over the past three years. Their efforts to encourage collaboration and growth among member states have been highly valuable.

Distinguished Ministers, Ladies and Gentlemen

4. Earlier this year, I had the opportunity to engage with you during the Extraordinary Council of Foreign Ministers Meeting on Gaza. Sadly, the situation in Gaza has worsened, with devastating loss of life and injuries to innocent civilians. The continued escalation of violence, including in Lebanon and Syria, is deeply concerning. Pakistan calls for an immediate and unconditional end to the hostilities. The D-8 Council of Minister provides an important forum to discuss ways to respond to the ongoing humanitarian crisis in the Middle East.

Distinguished Ministers, Ladies and Gentlemen

5. Pakistan is committed to increasing economic collaboration and boosting trade within the D-8. I am happy to note here that our cabinet has approved the protocol on dispute resolution mechanism (DSM) of D-8 PTA. The cabinet has also approved its operationalization. We hope to ratify it very soon.

Distinguished Ministers, Ladies and Gentlemen

- 6. Agriculture and food security are critical priorities for Pakistan and the D-8. In March 2023, we inaugurated the D-8 Research Center on Agriculture and Food Security in Pakistan. We hope this center will serve as a hub for innovative research that benefits all member states.
- 7. Tourism is another area with immense potential. In August 2023, Pakistan hosted the 3rd Meeting in Islamabad, which resulted in the Islamabad Declaration on Tourism. This outlines clear commitments to implementing the D-8 Comprehensive Strategy on Tourism.

Distinguished Ministers, Ladies and Gentlemen

8. For the D-8 to grow and thrive, it is vital to welcome new members. Pakistan supports Azerbaijan's application for membership and hope that after the

Commission's approval the CFM will also endorse it. We also hope that the criteria for the membership will be approved by the member states to welcome new members.

9. Finally, we commend the outstanding contributions of the D-8 Secretariat, whose efforts have been instrumental in driving progress and fostering collaboration among member states. Under the leadership of Secretary General Ambassador Isiaka Abdulqadir Imam, the Secretariat has worked tirelessly to advance the organization's goals and deliver meaningful outcomes. As Ambassador Imam concludes his term next December, we express our deepest appreciation for his leadership and wish him continued success.

Distinguished Ministers, Ladies and Gentlemen

- 10. I also take this opportunity to put forward the nomination of D-8 Secretary General from Pakistan, Ambassador Sohail Mehmood, for the term starting from 1st January 2026. He is among the best of Pakistan's Foreign Service officers having wide experience of multilateral diplomacy and has been Pakistan's Foreign Secretary. I hope that the Council of Foreign Ministers will approve his nomination.
- 11. Pakistan is committed to the aims and objectives of the D-8 organization. We look forward to working with all D-8 member states under Egypt's leadership. Together, we can build a stronger platform for economic collaboration and shared success.

Rules of procedures for implementing Article 3 of the D-8 Charter regarding accession of new members to the D-8 Organization

Guided by the purpose and principles of the Charter of D-8 and provisions of the Articles 1, 2 and 3 of the D-8 Charter, following Criteria and Modalities will be applied for granting the membership:

Criteria for independent States as Members

- 1. The applicant States shall commit to adhere to the objectives and principles of the Organization, as contained in Articles 1 and 3.5 of the Charter.
- 2. The applicant State shall possess comparable socio-economic level of development as that of existing member States.
- 3. Without prejudice to the membership drive, in accepting new members, D-8 may consider ensuring the balanced (equitable) geographical representation.

Modalities for Granting Full Membership

- 1. The application of the interested state must be submitted formally in writing to the Secretary-General of the D-8.
- 2. The application shall be accompanied by a formal declaration indicating its willingness to adhere to the purposes and principles of the Organization.
- 3. On receipt, the Secretary-General shall circulate the application to all Member States and submit the application to the Commission for their consideration.
- 4. Subject to the recommendation of the Council of Minister, the Summit may approve the application, by consensus, for granting membership to the D-8 organization.

Rules of procedures for implementing Article 4 of the D-8 Charter regarding granting Observer status to the D-8 Organization

Guided by the provisions of the Article 4 of the D-8 Charter, following Criteria and Modalities will be applied for granting the observer status.

Criteria for Independent States/Countries

- 1. The applicant shall commit to adhere to the objectives and principles of the Organization, as contained in Articles 1 and 2 of the Charter.
- 2. Having the capacity and willingness to do so, the applicant may make a practical and valuable contribution to the Organization i.e., possible contribution to certain projects and / or events to be determined by the D-8 Council of Ministers.

Modalities for Granting Observer status for Independent States/Countries

- 1. The application of the interested state must be submitted formally in writing to the Secretary-General of the D-8.
- 2. The application shall be accompanied by a formal declaration indicating its willingness to adhere to the purposes and principles of the Organization.
- 3. On receipt, the Secretary-General shall circulate the application to all Member States and submit the application to the Commission for their consideration.
- 4. Subject to the recommendation of the Session of the Commission, the Council of Ministers may approve the application, by consensus, for granting an observer status.
- 5. Observer may participate in the opening and closing session of the principal organs and may participate in activities or relevant technical meetings of the Organization.
- 6. Decision to suspend or terminate the observer status may be decided in accordance with the Article 4 (4) of the D-8 Charter.

<u>Criteria for Granting Observer Status to Regional and International</u> Organizations

The observer status may be accorded to inter-governmental Organization with similar objectives and principles to those of D-8.

<u>Modalities for Granting Observer Status to Regional and</u> <u>International Organizations</u>

- 1. Head of the applicant Organization shall submit an official request for the grant of observer status to the Secretary General of the D-8.
- 2. The application shall be accompanied by a formal declaration indicating its willingness to adhere to the purposes and principles of the Organization.
- 3. On receipt, Secretary-General shall circulate the application to all Member States and submit the application to the Commission for its consideration.
- 4. Any particular application for Observer Status should be discussed and decided at a maximum of two (2) Commission meetings.
- 5. In the situation where no consensus could be reached after the two Commission meetings, the application may not be considered further.

DRAFT CAIRO DECLARATION 2024

We, the Heads of State and Government/Representatives of the People's Republic of Bangladesh, the Arab Republic of Egypt, the Republic of Indonesia, the Islamic Republic of Iran, Malaysia, the Federal Republic of Nigeria, the Islamic Republic of Pakistan, and the Republic of Türkiye, forming the membership of the Developing-8 Organization for Economic Cooperation (D-8), gathered in Cairo on 19 December 2024, on the occasion of our Eleventh Summit, being held under the theme, "Investing in Youth and Supporting SMEs: Shaping Tomorrow's Economy."

Reiterating our pledge to advance our shared development goals under the principles of fraternity, peace, dialogue, justice, equality, rule of law, and democracy, established during the founding of the D-8, as encapsulated in our previous Summit Declarations.

Acknowledging our past progress should serve as a catalyst to renew our focus and intensify our efforts in addressing today's challenges, particularly in the light of the evolving global landscape.

Reiterating the value of unity, equality, mutual respect, and economic cooperation, we reaffirm our commitment to advancing partnerships in priority areas of cooperation, including agriculture and food security, energy, science, technology, industry, development of small and medium enterprises, infrastructure, trade, investment and transportation, to promote inclusive and equitable development that benefits our nations.

Reaffirming our shared endeavor to implement the D-8 Decennial Roadmap for 2020-2030 to deepen further economic cooperation, aligned with UN Development Agenda.

Reaffirming our faith in multilateralism and the importance of enhanced cooperation within the D-8 framework and with relevant regional and international organizations, particularly the United Nations, and the Standing Committee for Economic and Commercial Cooperation of the Organization of Islamic Cooperation (COMCEC) including strengthening South-South Cooperation, that is vital for promoting sustainable development, fostering peace, and addressing global challenges such as poverty, climate change, and inequality.

Realizing that the full and Organization-wide operationalization of the Preferential Trade Agreement Among D-8 Member States (D-8 PTA), the Multilateral Agreement among D-8 Member Countries on Administrative Assistance in Customs Matters (D-8 Customs Agreement), the Agreement on "Simplification of Visa Procedures, for the Businessmen of the D-8 Member States" (D-8 Visa Agreement) and transformation of the D-8 PTA into a more progressive instrument, such as a comprehensive economic partnership agreement will propel our economic power to a new height.

Emphasizing the need to promote investment opportunities and to increase intra D-8 trade with efficient mechanisms including on-line platforms, while also committing to inclusive growth, through the promotion of micro, small, and medium-sized enterprises (MSMEs) in

emerging sectors such as digital trade, e-commerce, and fintech, to ensure economic empowerment for all and intensifying efforts in improving logistics, transport, and regulatory frameworks.

Reaffirming our commitment to advancing cooperation in science, technology, and innovation through the existing mechanisms, to study key indicators and assess digital transformation opportunities, including emerging technologies such as artificial intelligence (AI) and the Internet of Things (IoT), to support our objectives.

Highlighting the importance of addressing climate change in the context of sustainable development and poverty eradication.

Recalling decision 14/30 of UNCBD COP14 on cooperation with other conventions, international organizations and initiatives, adopted at the fourteenth meeting of the Conference of the Parties to the Convention on Biological Diversity, in which the parties welcomed the initiative of the Government of Egypt to promote a coherent approach between the United Nations Framework Convention on Climate Change, the Convention on Biological Diversity and the United Nations Convention to Combat Desertification, to address biodiversity loss, climate change and land and ecosystem degradation.

Emphasizing the importance of promoting sustainable agricultural practices, as part of our collective endeavors to ensure food security and safety.

Acknowledging all Member States' participation in the Organization's activities must be strengthened, under the principle of fraternity and dialogue among members, in expanding our cooperation to achieve our shared objectives, and to that end.

We hereby,

- 1. **Appreciate** and commend the People's Republic of Bangladesh for its excellent stewardship and tireless efforts, since taking over the Chair's role in April 2021, which enabled the D-8 Member States to make significant progress in enhancing cooperation in our key areas of cooperation, as well as organizational expansion, visibility, and international collaboration and partnership, and **extend** our profound appreciation to the leadership of the People's Republic of Bangladesh, for their commitment and dedicated efforts in advancing the D-8 objectives, during their chairmanship of the Organization.
- 2. **Express** our heartfelt gratitude to **His Excellency Abdel Fattah-El-Sisi**, Honorable President of the Arab Republic of Egypt, as well as the Egyptian government and people, for successfully hosting the 11th D-8 Summit, and providing such gracious hospitality, and as such, pledge our full support and wish His Excellency the President, tremendous success as the Chair of the D-8 Organization.
- 3. Acknowledge the commendable work of **His Excellency**, **Ambassador Isiaka Abdulqadir Imam**, the Secretary-General of the D-8, during his tenure, which commenced on 1 January 2022, and appreciate his determination and meaningful efforts over the last three years, including, in effectively, managing the D-8 Secretariat.

- 4. Welcome the fruitful collaboration with many national, regional, and international organizations, such as the United Nations, the United Nations Trade and Development (UNCTAD), the United Nations Industrial Development Organization (UNIDO), the Food and Agriculture Organization of the United Nations (FAO), the World Intellectual Property Organization (WIPO), the World Trade Organization (WTO), the United Nations Tourism (UN Tourism), the Organization of Islamic Cooperation (OIC), the Islamic Development Bank (IsDB), the Islamic Organization for Food Security (IOFS), the Standards and Metrology Institute of the Islamic Countries (SMIIC), the Islamic Cooperation Youth Forum, the World Tourism Forum Institute, the Economic Cooperation Organization (ECO) and encourage a more profound and broader collaboration with these organizations, to get support necessary for the realization of initiatives and projects to achieve the D-8 objectives.
- 5. Applaud the establishment of the D-8 Youth Council, which the Government of the People's Republic of Bangladesh will host in Dhaka and call on Member States to support its functioning to foster youth cooperation in the D-8 and, in the same vein, appreciate the Government of the People's Republic of Bangladesh, for hosting the First Ministerial Meeting on Youth on 22 May 2024, and look forward to the hosting of the Second Ministerial Meeting on Youth by Nigeria. Encourages the Member States to organize joint activities in the field of youth by taking best practices into account and invite the Secretariat to coordinate these activities within the framework of "the D-8 Cooperation Action Plan for Youth" to be prepared in line with the proposals of the Member States with reference to the Dhaka Declaration on Youth. Invites the Secretariat and Member States to continue to work in cooperation on the Constitution of the D-8 Youth Council until the Second Ministerial Meeting on Youth.
- 6. **Commend** the Arab Republic of Egypt for selecting "Investing in Youth and Supporting SMEs: Shaping Tomorrow's Economy" as the theme for this Summit, and welcome the initiative proposed by the Islamic Republic of Iran to establish a D-8 mechanism to support the innovative ideas of the D-8 youth, and Iran's readiness to hold exhibitions as well as scientific/technological/entrepreneurship tours and specialized meetings with the participation of the youth from the D-8 Member States.
- 7. **Express** appreciation to the Government of the Federal Republic of Nigeria for their commitment to hosting the D-8 Center for Small and Medium Enterprises in Abuja, including the provision of initial resources to facilitate its operationalization. Recognizing the Center's potential to advance entrepreneurship and collaboration among D-8 Member States, we encourage the timely completion of its setup and call on all Member States to extend their support whether technical, financial or through capacity-building to ensure its effective and sustainable operation.
- 8. **Congratulate** the People's Republic of Bangladesh for organizing the Third Meeting of the D-8 Trade Ministers Council (3rd TMC) in Dhaka on 5 March 2024, as well as the Republic of Türkiye for hosting the Informal Meeting of the Trade Ministers Council of

- the D-8 Member States (Informal TMC) in Istanbul on <u>11</u> June 2024, which marked significant progress in advancing D-8 trade policies.
- 9. **Welcome** the announcement by the Arab Republic of Egypt to host the Fourth Meeting of the D-8 Trade Ministers Council in 2025, to further enhance existing D-8 trade policies especially through the participation and active engagement of SMEs; and to deliberate new mechanisms to expand and diversify trade among D-8 Member States, through digital trade facilitation platforms, e-commerce, and AI driven technologies.
- 10. **Welcome** the upcoming ratification by the Arab Republic of Egypt of the Preferential Trade Agreement Among D-8 Member States (D-8 PTA), marking the monumental milestone that all D-8 Member States are now Contracting Members of the D-8 PTA.
- 11. **Reiterate** the importance of effective implementation and operationalization of the D-8 PTA by all Contracting Members, including organizing capacity-building programs for relevant officials and appreciate that five Contracting Members have completed their internal procedures, to implement the D-8 PTA and call on those ready, to commence trading, under the framework of the D-8 PTA, without delay, to achieve the collective target of its value to at least 10% of the D-8 total external trade value, or at least US\$ 500 billion, by 2030, as outlined in the D-8 Decennial Roadmap for 2020-2030, and welcome the proposal to expand the D-8 PTA scope to meaningfully and equitably cover a wider array of significantly traded products, among the D-8 Member States, to make it more attractive to business entities.
- 12. **Acclaim** the adoption of the Dispute Settlement Mechanism (DSM) Protocol to the Preferential Trade Agreement Among D-8 Member States (D-8 PTA), during the 3rd TMC in Dhaka on 5 March 2024 and its subsequent signing by Bangladesh, Indonesia, Iran, and Türkiye, during the Informal TMC in Istanbul, and call on the D-8 Trade Ministers Council to devise means to expedite the process for the Protocol's entry-into-force, as seamless and as most straightforward as possible.
- 13. **Note with keen interest** the discourse on the need to upgrade the D-8 PTA to a more progressive instrument, such as a comprehensive economic partnership agreement, to enable the D-8 to be a more dynamic, powerful, competitive, and impactful economic bloc, including to venturing into potential sectors for trade in services, in the next phase of cooperation and tasked the D-8 Trade Ministers Council to conduct a study, scoping exercise, and comparative analysis, to identify the modalities and way forward, for the expansion of the D-8 PTA.
- 14. **Applaud** the adoption of the D-8 Trade Facilitation Strategy, during the Third Meeting of the D-8 Trade Ministers Council, which serves as a guideline for the D-8 Member States to strengthen intra-D-8 trade, by facilitating more accessible trade measures and Customs procedures, and call upon prompt implementation among Member States.

- 15. **Congratulate** Nigeria for assuming the Chair of the Supervisory Committee of the D-8 PTA starting in May 2024 and thank Bangladesh for their role as the immediate past Chair of the Committee.
- 16. **Welcome** the proposal to strengthen broader economic cooperation, through regular meetings of the economic ministers and their subsequent technical bodies of the D-8 Member States to provide a clear recommendation on crucial economic cooperation, including various novel ideas, to further promote the achievement of the D-8 economic objectives.
- 17. **Underline** the tremendous potentials of halal economy and commit to work together in boosting collaboration in this sector through capacity building initiatives and exchange of best practices to support the development of SMEs in halal industries.
- 18. **Direct** the D-8 Secretariat to conduct studies to devise ways to facilitate easier movement of businesspeople, among the D-8 Member States, guided by the Agreement on Simplification of Visa Procedures for Businessmen of the D-8 Member States.
- 19. **Emphasize** the importance of enhancing agricultural productivity, improving food security, and fostering rural development through joint initiatives, agricultural innovation, resilient agri-food systems, including sustainable farming techniques, sustainable land and water management practices, and the adoption of modern agricultural technologies, while reaffirming our commitment to fostering agricultural trade and strengthening food supply chains among us, while highlighting the need to increase resilience to external shocks, such as climate change, pandemics, and geopolitical disruptions, and to that end, commend the 7th D-8 Ministerial Meeting on Agriculture and Food Security hosted virtually by the Government of the People's Republic of Bangladesh in Dhaka on 13 January 2022.
- 20. **Commend** efforts by the D-8 Research Center for Agriculture and Food Security (D-8 RCAFS) in Faisalabad, Pakistan, in organizing activities and training programs, under the joint action plan, signed with the Islamic Organization for Food Security (IOFS).
- 21. **Commit** to enhancing cooperation in sustainable tourism, cultural exchange, and heritage preservation, to promote mutual understanding and socio-economic development, as tourism is a vital economic sector, for D-8 Member States and, for such a purpose, encourage Member States to develop joint initiatives, to boost intra-D-8 tourism, such as simplifying visa procedures, improving regional tourism infrastructures, and implementing collaborative marketing strategies.
- 22. **Welcome** the announcement by the Arab Republic of Egypt to host the fourth D-8 Ministerial Meeting on Tourism in Aswan, in 2025, and congratulate the Islamic Republic of Pakistan, for successfully hosting the Third D-8 Ministerial Meeting on Tourism on 5 August 2023.

- 23. **Commend** the D-8 Secretariat for successfully launching the inaugural D-8 Tourism City of the Year Award and congratulate the City of Antalya in the Republic of Türkiye, on its selection as the first D-8 Tourism City of the Year 2025, and express confidence that this initiative will boost tourism, encourage investment, infrastructure development, and cultural exchange, while promoting healthy competition among Member States, and to that end, call on all Member States to support this important initiative and promote travel to Antalya in 2025.
- 24. **Acknowledge** the need to enhance cooperation in the energy sector, including through engagement with the relevant international organizations, to promote the development and application of energy-efficient technologies and renewable energy and to foster private sector investment in new and renewable energy, to assist our countries in their pathways to just transition.
- 25. **Commend** the Organization's effort to improve cooperation in enhancing connectivity, including a more substantive collaboration in air connectivity and civil aviation, and appreciate the Republic of Indonesia for hosting the 12th meeting of the Director General and Experts Working Group on Civil Aviation (DGCA) in Bali, Indonesia, from 20 21 October 2022, and the Republic of Türkiye, for hosting the 13th D-8 Meeting of the DGCA in Antalya, Türkiye, from 12 14 November 2024.
- 26. **Emphasize** that measures taken to combat climate change, including unilateral ones, should not constitute a means of arbitrary or unjustifiable discrimination or a disguised restriction on international trade.
- 27. Call for allocating adequate, predictable and accessible finance from developed to developing countries, for just energy transition, in line with the principles of Common but Differentiated Responsibilities and Respective Capabilities CBDR-RC. Stressing that new industrial development models associated with this transition would require enormous investments in existing and new infrastructure.
- 28. **Underline** the importance of an ocean-based economy to support our shared objectives, while prioritizing the protection of marine biodiversity, promoting sustainable fisheries management, and ensuring the conservation of critical habitats to sustain livelihoods and ecological health by harnessing cooperation in fisheries and aquaculture, renewable ocean energy, seaports and shipping, marine biotechnology, offshore hydrocarbons and seabed minerals, deep sea mining, including through public-private-partnership, to attract investment in this sector.
- 29. **Encourage** cooperation, among D-8 Member States' academic communities and commend the D-8 Secretariat for establishing the D-8 Network of Pioneers for Research and Innovation (D-8 NPRI), chaired by COMSATS University in Islamabad, Pakistan, which, to date, is participated by 28 prominent universities from six Member States, and encourage the remaining Member States to invite their research-focused universities to participate, to

enable the NPRI to play a more significant role in promoting innovation and research as well as advancing commercialization and project-based development, share of experience in developing research strategy, and visit to various research institutions, across all Member States, and as such, we commend the University of Ilorin of Nigeria, for hosting the Third Meeting of the D-8 NPRI in Ilorin, Nigeria, in November 2024.

- 30. **Welcome** the Arab Republic of Egypt's initiative to establish the D-8 Network for Economic Think Tanks, to serve as a platform for sharing information, exchanging ideas, and enhancing partnerships among think tanks in order to develop informed solutions to the pressing economic development challenges, facing the D-8 Member States, foster economic cooperation and trade, promote the sharing of best practices in economic development, and enhance capacity building in areas such as trade facilitation, entrepreneurship, innovation and digital economy and trade.
- 31. **Commend** the cooperation in human resource development, including the institutionalization of Diplomatic Training for the Diplomats from the D-8 Member States, which will serve as an investment for the future, by promoting networking from an early stage and noted with utmost appreciation to Bangladesh, Pakistan, and Türkiye, for already organizing diplomatic training, in their respective institutions, and call on other Member States to organize similar programs.
- 32. **Welcome** the Arab Republic of Egypt's initiative to establish a network for diplomatic institutes and academies in D-8 Member States to foster cooperation among them through [EG] creating a platform for regular dialogue on emerging issues in diplomatic and foreign policy training, encouraging the exchange of ideas among institutes, coordinating on the development of cutting-edge training programs, enhancing the quality and relevance of courses and programs offered by participating institutes, and creating a virtual space for joint discussions on topics such as development, economic diplomacy, food security, energy, trade policies, and climate change.
- 33. **Applaud** the commendable efforts of the D-8 Technology Transfer and Exchange Network (D-8 TTEN) in Tehran, in fostering cooperation among D-8 countries, through encouraging transfer of technology and the exchange of best practices and recognize the significant impact of regular events, organized by D-8 TTEN, such as the Technology Investment Meeting (TIM), the Business & Technology Meeting (BTM), and the Technology Transfer Award (TTA), in promoting innovation and collaboration. Furthermore, we commend the forward-looking proposals put forth by D-8 TTEN, including the D-8 AI initiative and the D-8 Co-Fund Initiative (D-8 CoFI), which aim to strengthen technological advancement and investment, within the D-8 community and call on Member States, to actively engage in and support these initiatives, for the collective progress of our nations.
- 34. **Welcome** the Collaborative Education Initiative by the Arab Republic of Egypt, to strengthen educational and scientific collaboration among D-8 Member States, through

establishing a periodic online competition for university and vocational students in the fields of artificial intelligence, engineering, science and applied technology with the aim to enhance student engagement through the recognition of their skills, and to foster innovation by encouraging students to develop creative solutions to global and regional challenges.

- 35. **Highlight** the huge potential impacts of new and emerging technologies, including AI, on our peoples and economies, we instruct the ICT related Ministries in D-8 to seriously consider the optimal ways and means to utilize these technologies for enhanced resilience, nationally and collectively, against possible future shocks. In this regard, welcome the proposal by the Islamic Republic of Iran that the upcoming meeting of the D-8 ICT Standing Committee, to be hosted by the Islamic Republic of Iran, should start working on the above instruction.
- 36. **Appreciate** the Islamic Republic of Iran for its continued support to the D-8 International University (D-8 IU) in Hamadan and commend the University for its efforts in expanding academic collaboration and fostering international research, through initiatives such as the 'International Bridge Initiative' and its diverse webinars and workshops, and encourage the Member States to support and contribute into its programs and activities.
- 37. Call on the D-8 Chambers of Commerce and Industry (D-8 CCI), to play a more significant role in strengthening economic cooperation, particularly trade and other business activities, through enhancing the productivity and competitiveness of the private sector and facilitating and coordinating business activities, by supporting innovation, investment, and entrepreneurship, as well as promoting cross-border trade and economic cooperation among Member States, and for such an objective, encourage the D-8 CCI to increase business-to-business engagement, among all D-8 Member States, by conducting business forums, one-on-one business matchmakings, business missions, and exchange of information on business opportunities.
- 38. **Welcome** the hosting by the Arab Republic of Egypt of the Fourth General Assembly of the D-8 CCI on the 17th of December 2024, which witnessed the handover of the D-8 CCI Chairmanship from Bangladesh to Egypt.
- 39. **Applaud** the D-8 Health and Social Protection Program (D-8 HSP) for carrying out a study on the revitalization of the therapeutic goods health market and hosting the First D-8 Forum on SME and Health in Abuja on 26-27 October 2022, and encourage Member States to promote trade in healthcare, particularly in pharmaceutical goods to ensure equitable access to health care and health products, and at the same time call on D-8 HSP, the D-8 TTEN, the D-8 NPRI, and the D-8 IU, to work together towards promotion of inter-state knowledge sharing, collaborative initiatives in health technology, and pharmaceutical innovation. In this regard Member States can work towards harmonizing their regulatory framework in line with the World Health Organization (WHO) standards and undertake

- knowledge sharing, as well as collaborative initiatives in health technology and pharmaceutical innovation through mutual recognition agreements (MRAs).
- 40. **Welcome** the proposal by the Arab Republic of Egypt to strengthen D-8 health cooperation, through regular convening of meetings of health ministers and the subsequent technical bodies of the D-8 Member States and welcome the announcement by the Arab Republic of Egypt to host the first D-8 Ministerial Meeting on Health, in 2025, to discuss measures to advance preventative, therapeutic and rehabilitative health care, and to accelerate universal health coverage in D-8 Member States, through the inclusion of women and youth, not only as recipients of health care, but also as partners, in health policy making and implementation, including through utilizing digital technology and emerging technologies such as artificial intelligence.
- 41. **Encourage** the Secretariat to continue promoting private sector initiatives, including the D-8 Payment Card, the D-8 Creative Economy and Financial Center, and the D-8 New Generation Barter Trading. Urge all relevant ministries/agencies and institutions of Member States, to collaborate, closely, with the Secretariat to assess the feasibility of implementing these initiatives.
- 42. **Renew** our shared commitment to enhancing cooperation in disaster management, including strengthening joint efforts in disaster risk reduction, preparedness, and response, through collaborating on early warning systems, knowledge-sharing on best practices, and capacity-building initiatives to mitigate the impact of disasters.
- 43. **Underscore** our resolve to promote the economic empowerment of women, as a key driver of economic growth, and sustainable development, including enhancing opportunities for women in entrepreneurship, leadership, and the labor market, driven by the recognition of the vital role of women, in the economic and social progress of their nations, through eliminating barriers to women's economic participation, provide access to financial resources, and support initiatives that foster skills development and innovation, and task the D-8 Council, to work on this novel endeavor.
- 44. **Reaffirm** our opposition to any unilateral economic sanctions, imposed on D-8 Member States, that undermine global economic stability and violate international legal principles and demand the lifting of such sanctions.
- 45. **Support** the expansion of D-8 membership in accordance with Articles 3 and 4 of the D-8 Charter and appreciate the work concluded by the Council and the Commission to establish criteria and modalities for the new members and observers.
- 46. **Welcome** the Republic of Azerbaijan's accession as a full member in the D-8 Organization, and task the Council of Ministers to oversee the procedures related to its accession.
- 47. **Recognize** the importance of having a stronger and more efficient D-8 Secretariat, to ensure that our collective goals are effectively implemented and, therefore, call upon the

Council of Ministers to implement mechanisms to strengthen the Secretariat's capacity and resources.

- 48. **Endorse** the nomination of the upcoming Secretary-General of the D-8, Ambassador Sohail Mahmood from the Islamic Republic of Pakistan, who will assume office on 1 January 2026.
- 49. **Welcome** the Republic of Indonesia as the next Chair of D-8, and profoundly appreciate its gracious offer to host the 12th D-8 Summit, the date and venue of which will be communicated in due course.
- 50. **Reaffirm** our commitment to promoting peace, prosperity, and sustainable development. In this era of unprecedented global challenges, we must work together to create a more resilient and inclusive future for our people, guided by the values of cooperation, mutual respect, and shared prosperity, and our shared resolve to continue our cooperation, under Egypt's leadership and remain committed to the vision outlined, in the D-8 Decennial Roadmap for 2020-2030.

Draft Joint Communiqué of the Heads of State and Government of the D-8 Member States on the situation in Palestine and Lebanon Cairo, Egypt, 19 December 2024

We, the Heads of State and Government of the People's Republic of Bangladesh, the Arab Republic of Egypt, the Republic of Indonesia, the Islamic Republic of Iran, Malaysia, the Federal Republic of Nigeria, the Islamic Republic of Pakistan, and the Republic of Türkiye, forming the Summit of the Developing-8 Organization for Economic Cooperation (D-8), as well as the Republic of Azerbaijan, gathered in Cairo on 19 December 2024 at the generous hospitality of H.E. Abdel Fattah El-Sisi, the Honorable President of the Arab Republic of Egypt, on the occasion of our 11th Summit, with the participation of H.E. President of the State of Palestine, H.E. the Prime Minister of Lebanon, the Secretary-General of the League of Arab States and the Secretary General of the Organization of Islamic Cooperation, as guests of the Egyptian Presidency.

We reiterate our condemnation of the brutal Israeli aggression and the grave violations of the international law, the international humanitarian law and the human rights law by Israel, against the Palestinian people in the Gaza Strip, which caused an unprecedented humanitarian catastrophe and destruction of disastrous proportion. We warn against the danger of the escalation sweeping the region, the international consequences of the expansion of the Israeli aggression that has lasted for over one year in Gaza, which extended to include Lebanon, and further condemn the violation of sovereignty of the Republic of Iraq, the Syrian Arab Republic and the Islamic Republic of Iran. We also stress that this escalation should not impede the navigation in the Red Sea.

We deplore that since October 2023, over 44,000 Palestinians have been killed, 70% of them are women and children, and 105,000 people have been injured. More than 1.9 million people have been forcibly displaced and nearly 70% of the infrastructure in Gaza is destroyed, leaving almost the entire population without food, clean water, healthcare and basic shelter. Over 1,100 healthcare sites have been severely impacted by the Israeli attacks, leading to the resurgence of diseases. The risk of famine persists across the whole Gaza Strip, with 91% of the population projected to experience high levels of acute food insecurity between November 2024 and April 2025.

We express our concerns that as per the United Nations' report the GDP of the State of Palestine has contracted by around 35% and human development index (HDI) has fallen to 0.64 in 2024 with unemployment potentially rising to almost 50%, and that the HDI in Gaza, in specific, is projected to drop to 0.40, erasing over 20 years of progress.

We call for an immediate, permanent, and unconditional ceasefire in Gaza, support the ongoing efforts in this regard, in particular Egypt, and stress the need to fully implement the UNGA and UNSC resolutions to immediately allow the delivery of humanitarian aid in a broad, safe and unhindered manner, and the full and unconditional withdrawal of Israeli forces from the Gaza Strip. We reiterate, in this regard, the necessity for Israel to lift all restrictions, allow and facilitate humanitarian access to Gaza through its crossings and all available routes, as well to facilitate the provision and distribution of humanitarian assistance throughout the Gaza Strip, including in northern Gaza. We also categorically reject any displacement of Palestinian citizens outside their territory, which is a flagrant violation of International Law, and we call for providing the conditions for safe and unhindered return of displaced persons in Gaza to their homes.

We welcome the adoption of two recent Resolutions pertaining to the inherent rights of Palestinians at the 10th Emergency Special Session of the United Nations General Assembly on 11 December 2024, and urge the international community to operationalize these Resolutions in entirety and without delay.

We affirmed our strong support for the irreplaceable and indispensable role of the United Nations Relief and Works Agency for Palestine Refugees (UNRWA) in Gaza as well as in the rest of the Occupied Palestinian Territory and in host countries, and we reject any hindrance to the work of the Agency, including the Israeli practices aiming at impeding the Agency's lifesaving services.

We welcome the UN General Assembly Resolution ES-10/24 and the Provisional Measures Orders issued by the International Court of Justice, including the Order of 24 May 2024, which reaffirmed all previous provisional measures and indicated that Israel immediately halt its military offensive and any other action in the Rafah Governorate, which may inflict on the Palestinian group in Gaza conditions of life that could bring about its physical destruction in whole or in part and call upon all countries to ensure that the Orders issued by the Court are implemented without undue delay by Israel. We also call for the full implementation of the advisory opinion of the International Court of Justice dated July 19, 2024 towards ending the Israeli occupation, removing its effects, and paying compensation for its damages, as soon as possible.

We express our grave concern as well from the illegal Israeli practices in the West Bank, including East Jerusalem, and reiterate, in this regard, the call to cease all Israeli settlement activities, land annexation, home demolitions, settler violence and military incursions in Palestinian towns of the West Bank. We also stress the necessity of maintaining the legal and historic status quo of the Holy Site in Jerusalem in word and in practice and condemn all Israeli violations in this regard.

The Israeli aggression that was extended to Lebanon and the bombing of Beirut, has also resulted in loss of thousands of innocent civilian lives, massive destruction of houses and infrastructure as well as a grave humanitarian situation. We welcome, in this regard, the ceasefire agreement that came into effect on the 27th of November 2024, and stress that this should contribute to the de-escalation in the region. We also stress the necessity to stop all violations of the agreement and call for the withdrawal of Israeli forces from Lebanon.

The cost of physical damages and economic losses in Lebanon, due to the Israeli aggression, are estimated at 8.5 billion US dollars. Over 4,000 people have been killed and more than 16,000 people have been injured. Lebanon's real GDP growth is estimated to be cut at least by 6.6% in 2024 and almost 100,000 housing units have been partially or fully damaged. Around 1.2 million have been internally displaced, with women, children, the elderly, persons with disabilities and refugees at highest risk.

Mindful of our shared responsibility to stand with Palestine and Lebanon and to alleviate the damage resulted from the Israeli aggression, we express our commitment to providing humanitarian assistance to the Palestinian people, as well as to the Lebanese people, supporting the early recovery, reconstruction and rehabilitation efforts in Gaza and in Lebanon, bilaterally and collectively, and strengthening our support and collaboration with other donor countries and relevant international organizations. We welcome, in this regard, the Cairo Ministerial Conference to enhance the humanitarian response in Gaza, held in Cairo on 2nd of December 2024. We also commit to mobilize overall economic support to both Palestine and Lebanon to enable them to overcome the consequences of the war.

We reaffirm our unwavering support to the struggle of the Palestinian people including the right to self-determination, and the implementation of all UN resolutions related to the Palestinian cause, and stress the necessity to address the root causes of instability in the Middle East through meeting all the legitimate rights of the Palestinian people, and establishing an independent, sovereign, and contiguous Palestinian State along the lines of 4 June 1967, with East Jerusalem as its capital. And we call in this regard for the recognition of the State of Palestine by all states that have not yet done so and fully support its full membership in the United Nations.

We also stress the importance of preserving the sovereignty and territorial integrity of the State of Lebanon and underscore the need to support its institutions, to fully implement the UNSC resolution 1701 (2006) and to enable the deployment of the Lebanese Armed Forces in the south of the Litani River, extending its control over the entire country.

We express our appreciation to the Arab Republic of Egypt for holding a dedicated session on the situation in Palestine and Lebanon and look forward to following-up on the outcomes of our deliberations.
