### **D-8 Tourism Senior Officials Meeting on Nominations for the D-8 Tourism City of the Year Award, Virtually Held on 28<sup>th</sup> August 2024**

The Meeting of the Senior Officials from Tourism Ministries/Departments of D-8 member states was held virtually on 28 August, 2024 to discuss nominations of the D-8 city of the year award.

Mr. Ahmar Ismail, Director I Administrative, Legal and Internal Issues of the D-8 Secretariat, opened the meeting, which was attended by Senior officials from Bangladesh, Egypt, Indonesia, Iran, Malaysia, Pakistan, and Türkiye. The list of participants is attached as **Annex I**.

#### **Agenda Item I - Statement by the D-8 Secretary General**

Mr. Ahmar Ismail delivered opening remarks on behalf of Ambassador Isiaka Abdulqadir Imam, Secretary General of the D-8. He provided a historical perspective on the initiative of the D-8 Tourism City of the Year Award. He also informed member states on the preferences received from Iran and Türkiye on nominations for the D-8 city of the year award for 2025. The statement is attached as **Annex II**.

#### **Agenda Item II- Consideration and adoption of the draft agenda**

#### **Agenda Item III - Discussions on Nominations Submitted by Iran (Kerman), Pakistan (Lahore) and Türkiye (Antalya) for D-8 Tourism City of the Year Award 2025.**

The Secretariat informed member states that, in accordance with the decision of the last Senior Officials Meeting held on 30 July 2024, Iran and Türkiye have submitted their preferences for the nominations for the D-8 City of the Year Award for 2025.

The Secretariat invited member states, in alphabetical order, to share their preferences for Antalya, Kerman, and Lahore in the selection of the D-8 City of the Year Award for 2025.

Bangladesh provided its preference as follows:

- 1- Antalya
- 2- Kerman
- 3- Lahore

Egypt Provided its preferences as follows:

- 1- Antalya
- 2- Lahore
- 3- Kerman

Iran provided its preferences as follows:

- 1- Kerman
- 2- Lahore
- 3- Antalya

Pakistan provided its preferences as follows:

- 1- Lahore
- 2- Antalya
- 3- Kerman

Türkiye provided its preferences as follows:

- 1- Antalya
- 2- Lahore
- 3- Kerman

Indonesia and Malaysia requested extension of timeline for submitting their preferences until the end of September 2024, which was approved by the meeting.

After deliberations, the meeting agreed on the following:

- i. Following Iran's proposal to select the three nominated cities (from Iran, Pakistan, Türkiye) for consecutive years 2025, 2026, and 2027 (one year for each city); member states will inform the Secretariat of their decision on the proposal before the next SOM, scheduled to be held on 30 September 2024.

- ii. The representative of Egypt graciously informed the meeting that the Arab Republic of Egypt will host the upcoming 4<sup>th</sup> Senior Officials and Ministerial meetings. The official announcement for these meetings will be shared with the Secretariat in due course.
- iii. The nominated cities for the D-8 Tourism City of the Year Award (Antalya, Kerman, and Lahore) are tentatively requested to share a list of planned activities for the entire year, which may be discussed at the next SOM (30 September 2024).
- iv. The next meeting of Senior Officials and the Experts from the tourism ministries of the D-8 member states will be organized virtually by the Secretariat on 30 September 2024.

On behalf of the Secretary-General, Mr. Ahmar Ismail, Director I, at the Secretariat, extended his sincere appreciation to the participants for their valuable and substantive contributions.
