Strategic Objective

On 2 November 2018, D8-CCI held its Plenary Assembly in Antalya. The Plenary Assembly adopted the statute of D-8 CCI. Following the Plenary Assembly, with the participation of all D-8 member chambers, a Business Forum was held in Antalya. During the Business Forum, a comprehensive report titled "A global vision for the D-8: How to facilitate B2B interaction within the framework of D-8?" presented by the Economic Policy Research Foundation of Turkey (TEPAV). 5. Miscellaneous

Detailed Minutes

1. Opening Remarks	Sheikh Fazle Fahim, President, D-8 CCI initiated the General Assembly with a reiteration of agendas agreed upon during the Antalya Declaration in Turkiye. He specified that these will be the benchmark for D-8 CCI activities going forward, to fight economic pressures such as supply chain disruption, currency devaluation, volatility of foreign reserves, trade finance, etc, and to uplift all member states. All member states' Chambers of Commerce presidents confirmed the agendas set during the last general assembly meeting in Antalya, Turkiye.
2. Motion of Condolence	All member states agreed upon passing a condolence message for lives lost to the Covid-19 pandemic.
3. Update on D-8 CCI Activities in 2022-2023	 I. The D-8 CCI President spoke about the establishment of the D-8 CCI secretariat in Dhaka, with Ashraful Haq Chowdhury as the Secretary General, who is serving on an honorary basis. For administrative work, interns have been employed. There was a discussion about the lack of resources and funding available to the D-8, as there are no membership fees or any other revenue source for the organisation. Whoever takes up the presidency is responsible for carrying out all the expenses; accordingly, the expenses are being borne by the current President of the D-8 CCI. II. The Antalya Declaration, made in 2021, was circulated in

	April 2022 to record the strategic roadmap for D-8 countries. The President reiterated that this document is being held as the benchmark for the D-8 CCI's future activities; because of the impact of Covid-19, each of our countries is dealing with various economic pressures such as inflation, currency volatility, forex volatility and supply chain disruption. This is why the strategic roadmap is important; by identifying which products and services can be utilized according to the specific strengths of each member state, the support of the national chambers of commerce can be augmented.
	 countries, in the form of product harmonization and standardization, and alternative trade financing such as currency swap and barter to address issues such as foreign reserve and currency volatility. III. It was discussed that a logo is required for the D-8 CCI as there is currently none. All agreed on the need for a logo. It was proposed that each member can contribute proposed logos for the D-8 CCI.
4. D-8CCI Strategic Roadmap to Commemorate D-8 Silver Jubilee with the Support of Member States'	 I. There was an intensive discussion about the processes required to facilitate trade, tourism and resource-sharing among D-8 member states. The main points are outlined below: President of FPCCI called for the need for visa facilitation. President of TOBB upheld the issue of high transportation costs among D-8 members, which must

National Chambers of Commerce	 be decreased. He said that export and import are also dependent upon the reduction of logistic costs; as such, governments should focus on cost reduction. President of ICCIMA spoke about the need for <i>Preferential Trade Agreements (PTAs)</i> among member states and agreed with the President of FPCCI regarding the facilitation of visa processes amongst D-8 member states. He said that the private sector is capable of empowering the public sector and the economy as a whole; for this, PTA must be emphasized. D-8CCI President spoke about the steps currently being taken in collaboration with the Ministries of Home Affairs and Foreign Affairs of Bangladesh to bring about these changes. The President of FBCCI spoke about potential future collaborations among D-8 member states to utilize specific strength areas for this purpose. In this regard, he highlighted the existence of 100+ special economic zones in Bangladesh, which includes high-tech parks as well. The President of D-8 CCI spoke about the significance of establishing alternative supply chains and a visa regime to enhance connectivity among D-8 member states; all present members agreed. 	
	II. It was suggested by the President of KADIN that more frequent meetings among the D-8 CCI heads are required. The next meeting, she suggested, could be the Trade Expo in October, be it virtually, physically or in hybrid format.	

The President of D-8CCI agreed and stated that new goals and KPIs must be set and followed up in each new meeting. He stated that the D-8 CCI members can connect without traveling; virtual and hybrid meetings can be arranged to discuss further activities among the D-8 CCI bodies.	
A consensus was reached by all members that there should be a D-8 CCI meeting every 3 months.	
III. There is a need to promote arbitration among D-8 member states. Arbitration is important for the smooth and uninterrupted development of business, investment and trade. Normally, every chamber has their own arbitration mechanism. However, for development aid, it is worthwhile to consider whether a D-8 arbitration chamber needs to be established.

Consequently, it is difficult to enforce contracts.	
As such, although it is not mentioned in the D8 charter to forgo ICCIA arbitration, all members agreed upon the importance of establishing an alternative dispute resolution mechanism along with suitable new Standard Operating Procedures (SOPs). In this regard, a consensus was reached by all members present; however, further evaluation and examination is required, i.e. a study of the best-practice commonalities and modalities. The need for pegged-price guarantees among member countries was discussed by the President of the D-8 CCI, particularly for energy and food.
