#### Report of the 46<sup>th</sup> Session of the D-8 Commission Istanbul 15-16 February 2023

The 46<sup>th</sup> Session of the D-8 Commission was held from 15-16 February 2023 in Istanbul, Republic of Türkiye. The meeting was chaired by Ms. Wahida Ahmed, the D-8 Commissioner and Director General, International Organizations Wing, Ministry of Foreign Affairs of the People's Republic of Bangladesh. The Commissioners/Delegates from all Member States attended. List of participants is attached as **Annex I.** 

## Agenda Item 1: Opening of the Meeting and welcome statement by the Chair of the People's Republic of Bangladesh

The Chair delivered her opening statement and welcomed the delegates to the 46<sup>th</sup> Session of the D-8 Commission. Her statement is attached as **Annex II.** 

#### Agenda Item 2: Consideration and Adoption of the Draft Agenda

The Commission considered and adopted the agenda of the meeting which is attached as **Annex III**.

## Agenda Item 3: Statement and progress report on activities since July 2022 by the D-8 Secretary-General

The Secretary-General, H.E. Ambassador Isiaka Abdulqadir Imam, delivered his statement by welcoming the Commissioners and Delegates to the meeting. The Secretary-General also presented the progress report on the activities of the Organization on Sectoral Cooperation and External Relations, since July 2022. His statement is attached as **Annex IV**.

#### **Agenda Item 4: Statement by the Heads of Delegation of Member States**

The Heads of delegation of Member States delivered their statements. Their statements are attached as **Annex V**.

### Agenda Item 5: Consideration and approval of financial and administrative matters of the D-8 Secretariat

The Secretary-General presented the Draft Budget proposal for 2023 for approval of the Commission for decision on the following:

- a) Consideration and adoption of the proposed annual budget of the Secretariat for 2023
- b) Budgetary allocation for Assistant Director and Program Officer

After comprehensive discussion, the Commission decided the following:

- a) In view of the global financial situation, the Commission agreed that the 5% increase in the budget of 2023 will be met from General Reserve Fund, allowing ZERO percent increase in the annual contributions of individual member states.
- b) The Commission also approved the allocation for the posts of Assistant Director and Program Officer starting from July 2023.
- c) The contributions of the member states for 2023 will be based on the present contribution scales. However, the Commission tasked the Secretariat to represent the proposal in the next Commission meeting to reassess the scale of contribution in line with Article 12.1 of the D-8 financial regulations which states that, "The scale of assessment of D-8 countries to the annual budget of the Secretariat will be based on the prevailing UN scale of assessment and capacity to pay (GDP), taking into account the experience of other regional organizations".
- d) No fund will be allocated for the Project Support Fund for 2023.
- e) Delegation of Iran clarified that the delay of payment of dues has been caused due to the financial / technical issues related to sanctions, and it is not related to their capacity to pay. In response, the Secretary General expressed

readiness to work with Iran in order to find a solution for early payment of the dues, including through the waiver that may be obtained as was the case in relation to Iran's dues to the United Nations.

The updated budget of the Secretariat for 2023 is attached as Annex VI.

### Agenda Item 6: Discussion on the proposed changes in D-8 Statutory Documents

As per decision of the 45<sup>th</sup> Session of the Commission the Secretary-General presented the suggested updates in the statutory documents and requested the Commission to endorse the proposed amendments.

The Commission deliberated upon the proposed amendments and tasked the Secretariat to prepare a comprehensive paper including the charter of responsibilities, financial and administrative aspects for the senior level post of Deputy Secretary General which was approved at the 20<sup>th</sup> Session of the Commission (Bali, 2006). Minor amendments were endorsed by the Commission as attached as **Annex VII**.

#### Agenda Item 7: Consideration of the status of the D-8 Legal Instruments

The Secretary-General presented an update on the ratification, implementation and operationalization of the D-8 Legal Instruments.

The delegates deliberated on the progress made in their own countries on the status of ratification and/or implementation of these legal instruments namely, (D-8 Charter, D-8 PTA, Visa and Customs Agreements, MoU on Civil Aviation and MoU between SME's and Governmental bodies).

- The Commissioner of Egypt informed the meeting that his country is in the process of finalizing the D-8 PTA and consequently be deposited with the Secretariat.
- The Commissioner of Pakistan informed that a summary on the MoU on SMEs Governmental Bodies was submitted to the Cabinet for approval and will be deposited with the Secretariat once approved.

- The Commissioners of Indonesia and Malaysia informed that they are in consultation with relevant agencies on ratification of the MoU on SMEs Governmental Bodies.

## Agenda Item 8: Discussion on procedure of granting Observer Status and Permitting the Accession of New Members into the organization

The Secretary-General updated the meeting on the progress made by the Working Group meetings on establishing criteria and modalities for granting observer status and allowing the admission of new members into the organization.

After continued discussions, the WG submitted a draft text to the Commission.

The draft text submitted to the Commission was discussed in detail, and in the absence of consensus, the Commission decided to refer the matter to the Council of Ministers for consideration.

## Agenda Item 9: Discussions on the reports presented by the Secretariat regarding proposals from the Member States on the establishment of the following:

- a) D-8 Youth Council
- b) D-8 SME Center

The Secretary-General presented the key findings of the two Working Papers (prepared by the Secretariat) on the proposals of Bangladesh and Nigeria regarding the establishment of the D-8 Youth Council and the D-8 SME Center.

After further discussion, the Nigerian delegation conceded that the Youth Council will be hosted by Bangladesh. The Commission further requested both members to resubmit the concept papers on the proposed youth council and SME center to the Secretariat for sharing with member states after incorporating governing structure, including administrative and financial mechanism.

Agenda Item 10: Discussions on the report presented by the Secretariat regarding the Institutionalization of Diplomatic Training for Diplomats from D-8 Member States

The Secretariat presented the updated paper on Institutionalization of Diplomatic Training for Diplomats from the D-8 Member States.

The Commission deliberated upon the updated paper presented by the Secretariat and decided as follows:

- i. A sequence to host the program will be followed on voluntary basis rather than alphabetically.
- ii. Pakistan offered to accommodate one or two diplomats annually from D-8 countries to attend the existing diplomatic training programs organized by Pakistan.
- iii. Bangladesh informed that their Foreign Service Academy is willing to host the program in line with the proposal of the updated paper presented by the Secretariat and the modalities will be shared with the member states.
- iv. Nigeria is in the process of operationalizing the Foreign Service Academy and modalities will be shared in due course with member states.
- v. Also, Iran proposed to explore other financial resources for funding of the trainings, such as IsDB and other development partners.

## Agenda Item 11: Discussion on the report presented by the Secretariat on Financing mechanism of Affiliate Bodies in D-8 in comparison with similar International Organizations

The Secretary-General presented the Commission with the main findings of the Paper prepared by the Secretariat on Financing Mechanism of Affiliate Bodies, comparing D-8 organization with similar international organizations.

After discussions, the Commission tasked the Secretariat to submit a detailed working paper, which would cover all aspects related to governance, funding, administrative arrangements and their relationship with D-8 Organization.

The Commission urged all Affiliate bodies to continue to explore financial support from international organizations and D-8 Development Partners.

#### Agenda Item 12: Discussion on the governing structure of the affiliated bodies

The Secretary-General requested the esteemed Commission to review and decide upon the suggested structure for the D-8 Technology Transfer and Exchange Network (D-8 TTEN), as received from Ministry of Foreign Affairs of Islamic Republic of Iran. The Commission took note of the proposed document and decided

that the High Council of D-8 TTEN would review the documents for adoption.

Malaysia also submitted its comments on proposed D-8 TTEN governing structure and organizational charter, attached as **Annex VIII.** 

Nigeria informed the Commission that the Governing Council structure of the D-8 HSP in Abuja is being finalized and will be transmitted to the Secretariat in due course.

## Agenda item 13: Endorsement of applications for facility under the Project Support Fund

The Commission decided not to discuss this Agenda item as no fund will be allocated for the Project Support Fund for 2023.

#### Agenda item 14: Brief on D-8 Special Economic Zone by Bangladesh

The Head of delegation of Bangladesh informed the meeting about the progress made on the establishment of the D-8 Special Economic Zone and requested for views based on the presentation which is attached as **Annex IX**.

Member states welcomed and appreciated the proposal from Bangladesh, and suggested that a meeting can be convened with the participation of the relevant authorities from member states.

#### **Agenda Item 15: Progress reports on the Affiliated Institutions of the D-8**

- a) D-8 Health and Social protection Programme office (HSP)
- b) D-8 Chamber of Commerce and Industries (D-8 CCI)
- c) D-8 Technology Transfer and Exchange Network (D-8 TTEN)
- d) D-8 International University
- e) D-8 Network of Pioneers for Research and Innovation.
- f) D-8 Research Centre for Agriculture and Food Security (RCAFS)

HSP, TTEN, NPRI and RCAFS presented comprehensive reports to the Commission. The Commission appreciated the progress achieved so far.

On the request of Nigeria to provide financial support to HSP, the Commission recommended HSP to send a request to the Secretariat through the Foreign Ministry of Nigeria, which will be circulated among all members for their positive consideration.

#### **Agenda Item 16: Progress reports on the following Private Sector initiatives**

- a) D-8 Payment card
- b) D-8 Creative Economy and Financial Center (CEFC)
- c) D-8 Barter Trading system

The delegation from D-8 CEFC presented the progress report on the initiative. After deliberation the Commission welcomed the progress made and enjoined member states to make use of the CEFC to promote the economic activities of the organization.

The Commission were confident, once implemented, the CEFC will generate revenue for the organization.

The Commission expressed its appreciation to the Alhidayah Group and D-8 Malaysia Foundation for its donation to the victims of the Earthquake in Turkiye.

#### Agenda Item 17: Update on the Calendar of Events for 2023-2024

The Secretariat presented the Draft Calendar of Events for 2023-2024 to the Commission. Delegates updated the Commission on their countries' readiness to host the enlisted events. An updated Calendar of Events is attached as **Annex-XI**.

#### Agenda item 18: Date and Venue of the Next D-8 Commission Meeting

Bangladesh will inform the Secretariat on the date of the 47<sup>th</sup> Session of the Commission in due course. The delegation of Bangladesh also informed the meeting that they will not be in a position to continue as Chair beyond April 2024.

Under this Agenda item, the following proposals were discussed:

The Commission deliberated the proposals as follows:

Appreciating Nigeria's proposal on D-8 Energy Forum in Abuja, decided that the proposal should be circulated through the Secretariat for further comments by the member states.

Noting Iran's proposal on the rotation of the D-8 Chairmanship, decided to maintain the established practice of the rotation of the Chairmanship of the Organization.

Noting Iran's proposal on establishment of the D-8 Parliamentary Assembly, decided to focus on already established D-8 Affiliate institutions and avoid duplications with existing parliamentary cooperation.

The meeting adopted Iran's proposed Joint Communique of the D-8 Commissioners on Earthquake in Türkiye and Syria.

The Commission welcomed the proposal of the Secretariat on establishing the D-8 Committees in third countries and international organizations, and urged the member states to share their comments to the Secretariat in due course.

## STATEMENT BY H.E. AMBASSADOR ISIAKA ABDULQADIR IMAM, THE D-8 SECRETARY-GENERAL, AT THE 46<sup>TH</sup> SESSION OF THE D-8 COMMISSION, ISTANBUL, 15-16 FEBRUARY 2023

**Your Excellency Madame Wahida Ahmed**, D-8 Commissioner of the People's Republic of Bangladesh/Chair of the D-8 Commission,

#### **Your Excellencies D-8 Commissioners**,

Distinguished Delegates of the D-8 Member States,

Ladies and Gentlemen,

Assalamu'alaikum warahmatullahi wabarakatuuhu.

Very good morning to you all.

It is a pleasure to welcome all of you to Istanbul for the 46<sup>th</sup> Session of the D-8 Commission. I am grateful that you make and take time to attend this august gathering.

Permit me, Madam Chair, to use this occasion to officially welcome His Excellency **Ambassador Ragui El-Etreby**, Assistant Minister for Multilateral International and Regional Economic Affairs, Ministry of Foreign Affairs of the Arab Republic of **Egypt**, and Her Excellency **Dr. Asima Rabbani**, Director General for Organization for Islamic Cooperation and Economic Cooperation, Ministry of Foreign Affairs of the Islamic Republic of **Pakistan**, who recently joined our family as the D-8 Commissioners.

Before continuing, allow me to extend my deepest condolences to the people and Government of the Republic of Türkiye for the hardship caused by the devastating earthquake on 6 February 2023. I pray may Allah the almighty grants strength and consolation to all affected people. I welcome the swift response from the D-8 Member States in assisting Türkiye during this dire time of need. I trust that those assistances contribute significantly to the Turkish response to the disaster. *Your Excellency Madame Esen Altuğ, please accept the deepest condolences from all of us.* 

My heartfelt sympathies also go to the Government and People of Pakistan following the terrorist attack in Peshawar, Pakistan, that claimed the lives of around 100 worshippers last month. Our hearts go out to the impacted people, and we pray to Almighty Allah to help them recover from the losses and destruction... ameen.

#### **Madame Chair, Excellencies,**

I am pleased to report that our beloved organization has achieved significant progress since the last commission in July 2022. The Secretariat has also completed all the tasks allocated to by the 45<sup>th</sup> Commission and same have been circulated to the member states.

A little more than a year since I assumed the post of the Secretary-General of this organization, we have recorded more activities and engagement in priority areas, including our relations with external partners. All thanks to the Almighty Allah and the Members' active contribution and, of course, also the effective leadership of Bangladesh. I trust you have received the detailed report of such progress. Therefore, allow me, Madam Chair, to provide some highlights of our progress – and also our challenges in progressing further.

On the **sectoral front**, where activities are driven mainly by member states, we noted several activities. I am happy to report that the **Industry and SME**, **Transportation**, **particularly civil aviation**, **and the Creative Economy** sectors organized several activities between July 2022 and February 2023. Those activities were able to come up with notable recommendations that we must follow up on.

For example, during their 12th Meeting in Bali in October last year, the Civil Aviation authorities of our organization agreed to convene meetings of the task forces more frequently, twice every year. Similarly, the SME Forum and Health Market, held in Abuja in October 2022, paved the way for the proposed establishment of a D-8 Centre for Small and Medium Enterprises, which will be a game changer in fast-tracking the development of SMEs in D8. SMEs are known to constitute 90 % of the businesses in the D8 countries.

#### **Madame Chair, Excellencies,**

On **trade**, we are now closer to fully operationalizing the D-8 preferential trade agreement (D-8 PTA). We completed the negotiation for the PTA's Trade Facilitation Strategy and Dispute Settlement Mechanism protocols last year. All that is left to do is convene the Supervisory Committee and the Trade Ministers Meetings to adopt those protocols officially. We look forward to Bangladesh convening these all-important meetings, hopefully in March this year. The Meetings will strike the gavel, marking the organization-wide application of the PTA.

It is essential to add that some Member States have already expressed their readiness to trade under the PTA. For those who are ready, please do so. The D-8 PTA would only be valid if our private sector actively engages and utilize it. For this reason, and to support our endeavor, I want to call upon Member States to invigorate their respective national chambers of commerce to jointly raise the awareness of business entities on the D-8 PTA and its vast potential. Therefore, it is crucial that all efforts should be made at the national, regional, and global levels to publicize the D8 PTA, effectively.

#### **Madame Chair, Excellencies,**

I am happy to report that tremendous progress has been recorded in the area of external relations since our last meeting. We strengthened our engagement with the United Nations by participating in the 77<sup>th</sup> UNGA in September last year. While in New York, I managed to have nine separate meetings, including with the Director-General of the World Trade Organization, the Secretary-General of ASEAN, the Secretary-General of the World Customs Organizations, the UN Under-Secretary-General for Economic and Social Affairs, and senior officers from other organizations. The meetings produced tangible results, which are contained in the detailed report on external relations before you.

Furthermore, we have partnered with UN Specialised Agencies, such as the United Nations Department of Economic and Social Affairs (UN DESA) and the United Nations Conference on Trade and Development (UNCATD), to organize capacity-building programs for stakeholders from our member states. Foremost among such programs is the Capacity-Building Workshop on Implementing New Approaches to e-Government for SDG Implementation, jointly organized by the UN DESA in a face-to-face meeting in November last year here in Istanbul.

The UN DESA provided funding for the Workshop, covering the meeting package, air tickets, and per diem for two participants from each Member State. The total monetary value of the Workshop was approximately 55.000 Euros. Cooperation with UN DESA is the best model of cooperation with other international organizations, where we can tap the resources of other organizations to strengthen our cooperation. And that is what I set to achieve for the forthcoming years.

We also collaborated with MUSIAD, one of the prominent business associations in Türkiye, to organize a business forum in November last year, which was attended by some D8 Ambassadors in Turkiye. All meeting requirements, including venue, were provided for by MUSIAD. To sustain our engagement with this prominent business association which

has over 13.000 members, we signed an MoU during the MUSIAD – D8 Business Summit in November last year to cover the organization of joint programs in diverse economic areas such as energy, agriculture, SME development, health, ICT, etc.

Undoubtedly, our collective efforts on the external front have increased the organization's visibility, substantially. This is evident from the various invitations received to attend high-level meetings in member states and globally. For example, last month, I attended the 26th Council of Ministers of the Economic Cooperation Organization (ECO) in Tashkent, Uzbekistan, at the invitation of the ECO. That meeting afforded me the opportunity to meet with the Honorable Foreign Ministers of Iran and Pakistan, separately, as well as leaders of the ECO, the Conference on Interaction and Confidence Building Measure in Asia (CICA), and a representative of the Asian Development Bank.

Furthermore, the Organization is now being invited to co-organize joint programs in member states and beyond. For instance, the World Intellectual Property Organization (WIPO) has agreed to partner with D8 to jointly organise capacity building program on Intellectual Property for SMEs, while UNCTAD has invited D8 to collaborate for an investment program at the forthcoming World Investment Forum in Abu Dhabi in October 2023. Similarly, D8 has been invited by UNDESA to a joint event on the role of SMEs in attaining the UN Sustainable Development Goals at the margin of the High-level Political Forum on Sustainable Development in New York in July 2023.

The detailed report of the D-8 Secretariat's External Relations is encapsulated in Annex 3.2, which is placed before you, for consideration.

#### Madame Chair, Excellencies Commissioners,

While the progress is there, we also face challenges in moving forward. The conflict on the border between Ukraine and Russia shadowed our previous meeting in Dhaka. Little did we anticipate that it would drag on until today. We must be alarmed by the escalation of the conflict, which exacerbated our well-being and triggered an economic crisis in most of our member states.

I realize that our economies are now under dire stress from those multitudes of crises. I also acknowledge full well that it led to a non-consensual outcome in terms of the organization's budget, including the proposal to increase the salary of the Secretariat's staff, significantly. However, I want to strongly appeal that this august gathering could

positively consider the Secretariat's proposal to increase the budget of the organization, to make ends meet.

Madam Chair, Another critical area that I would like to draw your attention to is the lack of funds to support our projects and programs. The sole source of income of the Secretariat remains the annual contribution from the member states, which is used for the day-to-day running of the Secretariat, including payment of staff salaries and allowances. However, the contribution we receive from Member States barely meets our daily routine expenses.

Today, we are facing a problem to support our Project Support Fund program, which is funded from within the Secretariat's budget. Given our collective resolve to move the organization forward, in line with our 2020 -2030 Roadmap, it is imperative that we begin to explore novel ways to generate additional income for the Organization. We at the Secretariat are working assiduously to explore the possibility of collaborating with Development Partners and donors to finance some of the Organization's activities and projects, including the Project Support Fund initiative. On this note, I would like to humbly request that Member States make a voluntary contribution to the Secretariat in order to fund Projects, initiatives/programs, including the PSF, which must be sustained.

#### Madame Chair, Distinguished Delegates,

The Agenda for today's meeting is quite extensive. The Agenda placed before you are for your consideration, guidance, and decisions. The adopted Agenda reflects many vital issues that must be decided to enable our organization to move forward. With your permission, Madam Chair, I would like to highlight some important agenda items to be discussed today. Chief among the pressing issue is the Organization's budget for 2023, which we shall discuss in agenda item 5. And in line with my earlier statement, I cannot stress enough the importance of agreeing to and adopting the Organization's budget.

We also need to decide on the foreseen expansion of our organization under agenda item 8. I shall commend the Working Group, which met yesterday, for coming up with recommendations on this pertinent issue. The Secretariat also received several valuable proposals and ideas to enrich the Organization, which we will discuss under agenda items 8, 10, 13, and 14. On the other hand, we will also review the already existing initiatives under agenda 15 and ideas on how to govern the initiatives under items 11, 12, and 16.

We must also decide our way forward by deliberating agenda item 18, containing several proposed activities in agriculture, energy, tourism, transportation, information, and communication technology, as well as education, to take place in 2023.

#### Madame Chair, Excellencies, Ladies, and Gentlemen.

Our long list of topics to be discussed reflects our organization's dynamic. It is a testament to how far we have come since the foundation of our organization more than a quarter of a century ago. Yet, we can move further – and faster – with the active contribution of all Member States. Therefore, I call upon all distinguished Commissioners to engage in constructive discussion during our two-day meeting. Be rest assured, Excellencies, that I will contribute my utmost to facilitate the discussion. I will also gladly provide my views when the needs arise.

#### Madame Chair, Excellencies Commissioners, Distinguished Delegates.

To conclude, I want to reiterate my utmost appreciation to you all for participating in this Meeting. Thank you immensely for your continuous support and consideration toward the Secretariat. With your support, I can commit that the Secretariat will execute our mandate to produce the best outcomes for our beloved organization's benefit. And I am fervently sure that all of us at the Secretariat will be able to count on your support in the coming years. Your support will also embolden our shared resolve to achieve our objectives, set out by our founders and reiterated by our leaders.

## Statement by H.E. Ambassador Ragui El-Etreby Egypt's Commissioner to the D-8 Organization

His Excellency Ambassador Isiaka Abdulqadir Imam, the Honorable D-8 Secretary General,

Most distinguished Commissioners, Excellencies, and Ambassadors, Ladies and Gentlemen,

Allow me at the outset to convey on behalf of the government and people of Egypt our deepest condolences and solidarity with Türkiye, its people, and the families of the victims of the deadly earthquake that hit Türkiye. Our thoughts and prayers are for those who lost their lives. We hope for a speedy recovery for both Türkiye and Syria from this tragic and painful situation.

I would also like to convey my appreciation to the current Chair of the D-8, the People's Republic of Bangladesh, for its effective Presidency of the organization. I would also like to commend the tireless efforts of His Excellency Ambassador Abdulqadir Imam and the Secretariat for the advancement of the D-8, and for promoting economic cooperation among the Member States.

#### Ladies and Gentlemen,

As this is the first time for me to attend the D-8 Session of the Commission, after assuming my role as Egypt's D-8 Commissioner in July

2022, I can attest to the fact that the D-8 has achieved some remarkable steps in realizing its long-term objective of creating economic linkages and promoting cooperation in several areas among its Member States. I note with appreciation the level of sectoral cooperation achieved so far by the organization, especially in the area of trade, as the Organization is set to enter a new phase as soon as the Preferential Trade Agreement (PTA) enters into force. I would like to underscore in this regard that the relevant Egyptian authorities are keen on expediting the ratification process of the PTA, preferably before the third D-8 Ministerial Meeting.

Egypt commends many initiatives presented by the organization's Secretariat and Member States to widen the scope of the engagement of the private sector, especially Small and Medium Enterprises, in the fulfillment of economic cooperation between Member States. In this sense, Egypt looks forward to increasing the role of the private sector in providing value added for our sectoral working groups, especially in trade, commerce, and information technology and communication. We also hope that the crystallization of the proposed D-8 SME Center and the D-8 Creative Economy and Financial Center will unleash the untapped creative potential of our private sectors in promoting economic cooperation between Member States.

In the same vein, I express my full support to H.E the Secretary General's idea that we as Member States need to take effective measures to revitalize the D-8 working groups on education, tourism, agriculture, energy, transportation, trade, and information and communication technology by increasing the frequencies of our regular meeting through promoting online hosting of technical meetings.

Regarding the progress report of external relations, Egypt expresses its hope that the work of the D-8 external relation team will continuously increase the visibility of the D-8 organization internationally, and will hence contribute to producing tangible outputs for our organization, especially in terms of elaborating joint programs in areas of expertise and enhancing the capacity building for our teams.

#### **Esteemed Commissioners**,

We have important agenda items at hand, ranging from various proposals to the D-8 budget for 2023, and discussions on important matters, including the discussion on granting observer status and permitting the accession of new members into the organization. We take note of the proposals presented by both Bangladesh and Nigeria to establish the D-8 Youth Forum, and we hope that both countries agree on the host country and provide us with additional details regarding the structure, organization, and goals of the proposed Youth Council. We also would appreciate it if the Islamic Republic of Iran could provide us with further details on the structure of its proposed D-8 Parliamentary Assembly.

Egypt reiterates it's support to the proposal by Bangladesh on the D-8 Special Economic Zones, and we look forward to thoroughly study Egypt's active engagement with this promising idea that we believe will help increase the level of intra D-8 trade among Member States, that currently falls short of our expectations.

Regarding the Draft Budget proposal for 2023, we reiterate our position stated during the last Special Session of the D-8 Commission held virtually in November 2022 that any increase in the Secretariat's budget should not be at the expense of placing any additional financial burdens on our countries, especially since many of our nations are trying to recover from the adverse economic and financial consequences of the Russian-Ukrainian crisis, and its subsequent wave of inflation and fiscal tightening.

Egypt appreciates the progress made by the D-8 affiliated bodies, such as the D-8 Network of Pioneers for Research and Innovation, the Enhancing Cooperation in Science, Technology, and Research among D-8 Countries (ECSTRA D-8), and the D-8 Research Center for Agriculture and Food Security. In this sense, we agree with the Secretariat's recommendations that affiliated bodies should enjoy a certain degree of autonomy to generate revenues and that they should have a defined governing structure. Nevertheless, I would like to underscore that this level of much-needed

independence should always align with the D-8 overarching strategic goals and objectives.

#### Ladies and Gentlemen,

Egypt has always been keen on upholding its commitments to the D-8 goals. Egypt is currently in the process of ratifying the Preferential Trade Agreement (PTA). We will continue our efforts in this regard to speed up the process of ratification by the Egyptian Parliament.

I would also like to highlight that Egypt has ratified many of the D-8's MoUs, particularly that on Civil Aviation and the MoU between SMEs and Governmental bodies. Egyptian officials have been participating in various projects and programs on many sectoral issues within the D-8, such as health, education, tourism, and research.

#### Dear Colleagues,

In conclusion, I would like to express Egypt's commitment to continue working on enhancing the cooperation with the Members of the D-8, with the aim of achieving our common objectives as stated in the D-8 Charter, and I would like to express my wishes for a successful meeting and fruitful discussions that will hopefully allow us to reach an agreement on the key issues before us in the coming two days.

#### Dear Colleagues,

In this Commission meeting, as reflected in the Agenda, we have a lot on our plates. Amongst them is the discussion about possible enlargement of the Organization. As expressed in the past, the Islamic Republic of Iran believes that this is the time to expand the boundaries of our community in line with the Objectives and Principles of the Organization. We have already expressed our support to the membership application by the Republic of Azerbaijan. At the same time, we have been contributing into the development of well-defined criteria and modalities governing application for membership and observership.

As always, the Islamic Republic of Iran remains willing, ready, and determined to lend its utmost support to the objectives and activities of the Organization. In the same direction, we are planning to host some D-8 meetings, including ministerial level meetings, in areas such as SMEs, energy and ICT, etc.

#### Ladies and Gentleman,

Just recently, the Islamic Republic of Iran put forward a couple of new proposals with a view to enhancing the efficiency of the Organization and also to activate the existing potentials of our community of nations.

First, as conveyed to the Member States, this delegation has proposed a new idea of automatic rotation of the D-8 chairmanship; a very widely used method of fixed-term and alphabetic-based rotation. The current practice (holding the COM meeting as the hand-over time for chairmanship) is prone to delays and uncertainty and runs against the spirit of equal and equitable burden-sharing.

Second, out of a conviction that we need to utilize all untapped potentials of the Organization, the Islamic Republic of Iran has put forward a proposal to initiate a D-8 Parliamentary Assembly, or DPA. The very idea was first proposed by His Excellency Foreign Minister Amir-Abdollahian in July 2022 who stated that "the capacity of the parliaments of the Member States should be tapped for the purpose of developing and advancing our cooperation". This delegation believes that making legislative bodies engaged will bring values for our cooperation within the Organization.

We encourage our fellow D-8 Member States to support these i		
and put forward their inputs to further enrich the proposals.

10. The D-8 Member States, in this context, are not immune to these concerning global developments. The political and economic instability in the world indeed has a significant impact on our economies and societies.

#### Full Implementation of the D-8 PTA

- 11. There is also an opportunity within us for the D-8 Member States to come together collectively and address these challenges. As we are all fully aware, we have been discussing and negotiating the D-8 Preferential Trade Agreement, or D-8 PTA, towards its full implementation since 2011.
- 12. This Agreement is a crucial tool for intra-trade growth that aims at increasing economic and trade activities between the D-8 Member States through tariff concessions and the elimination of non-tariff on a mutual basis. Furthermore, once fully implemented, this Agreement would propel our economies by encouraging more D-8-wide investment and improving rules and regulations concerning intellectual property, e-commerce and public procurement.
- 13. Malaysia believes that the Agreement must be finalised and fully implemented as soon as possible. Hence, Malaysia looks forward to the 7<sup>th</sup> Supervisory Committee on D-8 PTA Meeting and the 3<sup>rd</sup> Trade Ministers Council Meeting, scheduled to be held in the first quarter of 2023, and hopes it will be operationalised accordingly.

My fellow Commissioners,

#### D-8 Secretariat's Budgets for 2023

14. As we know, the Commission has been discussing the Secretariat's budget for 2023 during its 45<sup>th</sup> Session in Dhaka, Bangladesh, in July 2022 and during the Special Session virtually held in November last year. However, the discussions on both occasions could have been more fruitful.

- 15. While the different financial capacities of the Member States are understandable, we must acknowledge that the challenge to finalise the 2023 budget stems from the limited financial contribution from its Members. Apart from the growing cost of staff salaries and remuneration, the Secretariat also faces the challenge of filling vacant positions.
- 16. Therefore, Malaysia believes that strengthening the Secretariat is of utmost importance. Once the Secretariat operates at total capacity with the required talents, it can implement all initiatives, programmes and activities in line with our leaders' vision.
- 17. On this note, we believe that under His Excellency Ambassador Isiaka, the D-8 Secretariat, with a lean and dedicated team, will continue progressing effectively and efficiently.
- 18. We are confident that the Secretariat will continue to uphold the principles of good governance, especially in implementing programmes within the mandated financial allocation.
- 19. As an active member of the D-8, Malaysia supports any initiatives aimed at contributing to the overall performance and development of the D-8 economies.

Mdm. Chair, Excellencies, Ladies and Gentlemen.

Progress on Granting Observer Status and Permitting the Accession of New Members into the Organisation and the Membership Application by Azerbaijan

20. Malaysia firmly believes that expanding the D-8 membership would bring the Organisation to greater heights in line with the aspirations of our leaders as stipulated in the Dhaka Declaration 2021 and the D-8 Decennial Roadmap 2020-2030. Hence, we should galvanise our efforts

to ensure a favourable outcome on this issue before our next Leaders' Summit

21. While Malaysia believes specific standards must be adhered to when considering a new application for membership in the Organisation, our action must be seen as sincere in accepting application to expand our Organisation.

#### The D-8 Private Sector Initiatives

- 22. Malaysia acknowledges the importance of an enhanced engagement of the private sector in the organisation's activities: as the main engine for the growth of our economies.
- 23. On this note, as agreed during our 45<sup>th</sup> Session of the Commission, Malaysia hopes that work on the existing private initiatives, namely, the D-8 Payment Card; D-8 Creative Economy and Financial Centre, or D-8 CEFC; and D-8 Barter Trading System; be expedited.
- 24. Malaysia believes these initiatives would create more tangible and progressive results for the benefit of the businesses and further improve the socio-economic levels of our Members.

#### Conclusion

25. I look forward to a fruitful, productive and successful discussion in this Meeting.

4. #### **Your Excellencies**

#### **Honourable Commissioners**

- 5. The 46th Session of the D-8 Commission is taking place at a time when humanity is facing one of the most challenging periods in history, occasioned by the series of events which include COVID-19 Pandemic, ongoing Russian-Ukraine war, destructive climate change, unprecedented financial and economic crisis and natural disasters. This session therefore, provides a unique opportunity to reassess the progress and challenges confronting us as an organization.
- 6. In this regard, Member States need to reaffirm our shared determination and commitment to participate more actively in the activities of the organization. Our renewed effort in delivering a common future based on the commitment made by the founding fathers of this noble platform would ensure shared economic prosperity.

#### **Madam Chairperson**

#### Distinguished Ladies and Gentlemen,

7. The six priority areas of cooperation of the D-8 namely, Trade, Agriculture and Food Security, Industrial, Energy, Transport and Tourism Cooperation would continue to receive deserving attention of the relevant authorities in Nigeria due to their relevance to our national development aspirations, and our commitment to the D-8.

Nigeria, therefore, regards the D-8 as an important platform for economic cooperation and a unique vehicle for South-South and Triangular cooperation.

- 8. As part of our commitment to the lofty ideals of the D-8, Nigeria has initiated and implemented a number of programmes and initiatives at the national level as contributions to enhance cooperation within the organization. These projects include:
  - i) the designation of Nnamdi Azikiwe International Airport Abuja as one of the D-8 partner airports that will provide fast services to citizens of D-8 Member States;

- 9. On the agenda items, Nigeria is ready to engage. We are hopeful that we will arrive at amicable solutions to some of the items that are becoming protracted, especially the budget.

#### Madam Chair.

- 10. To achieve the set objectives of our organization, there is the need for Member States to show more commitment to the activities of the D-8, including the implementation of the Decisions and Agreements reached in the past. Let me also underscore the importance of active intra-D8 trade and the need to remove barriers including strict visa regime among Member States in order to boost trade and commercial engagements.
- 11. Permit me to conclude by placing on record giant strides being recorded by the Secretariat in recent time, especially in the areas of external relations and trade as evidenced in the numerous meetings and productive engagements recorded. We want to urge the Secretariat not to rest in its oars in this regard.
- 12. I thank you all for your attention.

## Statement of the D-8 Commissioner of Pakistan for the 46<sup>th</sup> Session of the D-8 Commission (15-16 Feb 2023)

#### Excellencies, Distinguished Delegates, Ladies and Gentlemen,

At the outset, let me offer my country's deepest condolences for the loss of life and property resulting from the devastating earth quake that struck our brotherly country of Turkiye last week.

Pakistan stands in firm solidarity with Turkiye in the wake of this unprecedented natural calamity. Our leadership has already pledged all possible support in the relief effort. We have mobilized all available resources including winterized tents, blankets and other critical life-saving supplies. Our Urban Search and Rescue Teams trained to operate in disaster hit areas are working on ground in tandem with our Turkish brethren.

We pray to Allah Almighty for forgiveness and mercy of all those who had lost their lives in this catastrophic event.

#### Excellencies,

It is a personal pleasure to be here in Istanbul. Let me also offer our gratitude to the D-8 Secretary General and his team for making excellent arrangements for the meeting.

I would also like to extend our thanks to Bangladesh in steering the work of the D-8, as the Chair, during these turbulent times.

We assure the D-8 Secretary General, H.E. Isiaka Abdulqadir Imam, Pakistan's strong and firm support for all his efforts to strengthen this organization.

I note his emphasis on trade and visibility of the organization, as some of his core priorities. I commend him for making these as his priorities and look forward to hearing actual results from this effort in near future.

#### Excellencies,

Allow me to commence by briefly reflecting on the context of our work today.

There has never been a time when the world was free of a major crisis. At present though, there is a confluence of a series of cascading crises from post pandemic recovery, war and conflicts, to rising polarization within socities and climate change. Unfolding of cost-of-living crisis, rising inequality, looming recession, energy crunch, soaring inflation and supply chain disruptions are some ingredients for a "perfect storm".

Post-pandemic economic recovery is slow, uneven and unequal. A few months ago, we were worried that the world is trading and growth is declining under the weight of war against disease as well as unfolding trade and technology wars. Today they are creaking under the full weight of an actual military conflict.

Instability is being engendered by rising geopolitical tensions and global economic volatility. Power shifts continue in an increasingly fragmented international system, with multilateralism under growing stress.

Inevitably, economies of the Developing countries are worst hit.

Amid these crises, our platform could be a place for exploring opportunities and while integrating the negative impacts of the crises we all face. International cooperation and more so enhanced D-8 cooperation is of paramount importance.

#### Excellencies,

Before I reflect on some of the issues requiring our attention, as part of the agreed agenda, I would like to highlight three important opportunities for our consideration, both at this meeting and in the future.

First, Private sector: I cannot emphasize the important role that the private sector can and must. There is an immense opportunity in engaging the private sector. Our modest progress suggests that a key element of economic cooperation is missing. It is time to explore this opportunity and bring together private sector. I propose that a private sector facility/platform be created to help us determine next step in promoting economic cooperation within the D8.

Second: enhancing connectivity: as a cross regional group of large developing countries, enhancing connectivity is perhaps the most significant challenge we face. We don't and at least in the near future, we cannot have road networks operating amongst us. The two major lines of connectivity are technological and travel and transportation links. Unless we focus on connectivity, we will not be able to accrue the benefit of any of our work. We should consider launching a D8 technological and transportation connectivity roadmap, that focuses on reducing cost of communication, transportation and travel within the D8 countries.

Let me now revert to some of the issues on the agenda.

Decennial Roadmap of 2020-30 provides a framework for increased economic cooperation and partnership. To implement the goals and objectives laid down in Decennial Roadmap, I would like to raise few specific points:

One, the D-8 PTA is very essential to realise the full potential of sectoral cooperation and trade between D-8 member states. Pakistan is committed to the full implementation of the D-8 PTA. But we believe that more than its implementation in the current state, there is a need to revise the offer list / tariff lines in order to realise the true potential of intra-D8 trade. This would also be in line with the target set against the preparatory phase of Decennial Roadmap for 2020-30. We hope that discussions on this issue will conclude soon so as to fully implement the PTA.

Two, the emerging economies of the D-8 member states have huge markets that can attract international investments. However, investment regimes, today, are part of the trade agreement. Therefore, we propose to include D-8 Investment Agreement in the D-8 PTA and would like the negotiations to kick off at the earliest.

Three, it is time, we invigorate all our efforts in the optimal utility of our human resource development, diversification of national economies, developing markets, nurturing our value chains especially agro-business value chains and creating linkages for trade, creating backward linkages and boosting technological transfer, reinvigorate services sectors<sup>1</sup> and our capacity to provide a common voice of the Global South.

<sup>&</sup>lt;sup>1</sup> As of 2019, service sectors average 50% of the D-8 national economies. Egypt and Turkiye have surplus.

Four, we fully endorse the idea of D-8 Payment Card. We believe that the realisation of this concept can be mutually beneficial for all Member States. We have already shared our detailed views on the subject. We would propose that the Secretariat may Commission a study to come up with a way forward while anticipating the challenges that we may face. To move forward, a dedicated team comprised of representatives from Payment Systems Department of Central Banks of all D-8 countries may be formed to materialize the concept as well as implementation plan.

Five, finances play a critical role in the working of any intergovernmental organisation. The Member States have been making annual contribution on the basis of their relative GDP standing. However, over the past two decades, there has been change in their relative GDP standings. Therefore, we believe that there is a need to revise the formula of annual contribution by the Member States. The contribution, we propose, may be based on biennial GDP statistics of member states.

Six, Pakistan welcomes the desire of the Republic of Azerbaijan to become a D-8 as a member. We, once again, fully support Azerbaijan's joining to the D-8 Organization. The expansion of the membership by welcoming friendly countries, with shared objectives and emerging economic, will enhance the avenues for economic cooperation. This will have a net positive impact on the intra-D8 trade, and the economic health of the member states. We hope that we will be able to take the decision during the proceedings of agenda of the D-8 Session of the Commission.

#### Excellencies,

On its part, Pakistan is committed to promoting economic growth, trade and development through cooperation and assistance with all members of the Developing – 8.

Pakistan has ratified five out of six D-8 Legal Instruments and is committed to implement them in letter and spirit. Ratification process from Pakistan on the D-8 MoU on SMEs Governmental Bodies is under process. All codal formalities have been completed and it is expected that we will ratify the agreement during the year 2023.

We are committed to convening the 3<sup>rd</sup> D-8 Ministerial meeting on Tourism. Besides we are ready to hold inaugural meeting of the D-8 Research Centre at the University of Agriculture, Faisalabad, and the meeting of D-8

Network of Pioneers for Research and Innovation (NPRI) at COMSATS University Islamabad during the month of March 2023.

#### Excellencies,

Last year we are celebrated the silver jubilee of the establishment of the D-8. While the pace of this organization has been modest, D-8 has all the ingredients to become a role model for the cooperation entities.

With joint cooperation and partnership, I hope we will be able to realize the vision and objectives of the D-8 organization.

I assure you of my delegation's full cooperation and positive engagement during the proceedings of the Session of the Commission.

#### f) Commission

The Commissioners Meeting of the D-8.

#### g) Secretary General

The Secretary General of the D-8.

#### i) Staff

Personnel of the Secretariat of the D-8 whose emoluments are charged against the Secretariat and are recruited on the basis of the D-8 Staff Regulations.

#### j) Chairman in Office

The rotating chairman of the D-8 Summit, Council of Ministers and Commission.

#### k) Local Staff

**Dated: 15-16 February 2023** 

Staff not included in I and II categories recruited by the Secretariat on the basis of present Regulations.

#### I) Temporary Staff

Staff either directly recruited or seconded by Member Countries or other international organizations whose services are engaged on temporary basis by the Secretariat for special short - term assignment.

m) Headquarters Agreement

The Agreement regarding the legal status of the Secretariat signed with the government of the Republic of Turkey.

## Staff Regulations Chapter IV

#### Classification of Posts, Staff Strength and Job Description

#### Article 5 page 41

5.1 The initial sanctioned staff strength of the Secretariat for the next 5 years shall be based on the table provided in Annex I. The staff strength shall be reviewed and revised from time to time by the Council of Ministers.

#### Annex I

- 5.2 The staff of the Secretariat including the Secretary General shall consist of the following four categories, each category shall be further sub divided in Grades:
- a) Category I (Directing Staff): D3, D2, D1
- b) Category -II (Professional Staff): P3, P2, P1
- c) Category –III (Local Administrative and Technical Staff): A3, A2, A1
- d) Category –IV (Local Service Staff): S1, S2

#### Chapter V Article 9 page 42

9.1 Appointment to other posts in Categories I and II shall be made by the Commission on the basis of alphabetical rotation for a non-renewable term of four years.

These posts shall be advertised by the Secretariat through Ministries of Foreign Affairs of the Member Countries, six months before the expiration of the post, specifying the requisite qualifications and experience for each post as prescribed in Annex-II. Composition of staffs in Category I & Category-II shall not be comprised of officials from the same nationality.

#### Article 10 page 43

10.1 Appointment to Category-III posts shall be made by the Secretary General according to the needs of the Secretariat through a proper selection procedure on the basis of the requisite qualification and experience for each post as prescribed in Annex-II. The terms and conditions of appointment to these posts shall be specified in the relevant contract to be signed by the Secretary General. All local staff under Category-III, and Category-IV shall not enjoy diplomatic immunity and be governed in accordance with Turkish Labour Law and Social Security System.

#### Article 13 page 44

The Salaries and allowances of local staffs will be paid as approved by the Commission.<sup>2</sup>

#### **Health Insurance**

### Education Grant page Article 17 page 45

17.1 Education grant is an expatriate benefit which is payable to directing, and professional staff members, unless they are permanent residents or nationals of the host country of the Secretariat, in respect of 2 (two) dependant child's educational expenses. It is provided to directing staff members who reside and serve at a duty outside his or her home country with an appointment of a minimum period of one year.

#### Airfare and Transportation Allowance

#### Article 18 page 45-46

- 18.3 <u>Transportation of Personal Effects</u>: Directing and Professional staff will be entitled to transportation and personnel effects allowance upon joining and departure. Upon departure, an officer will only be eligible for transportation of personal effects given that he/she has completed two years at the Secretariat.
- 18.4 <u>Home Leave Passage<sup>3</sup></u>: Directing and Professional staff who serve for a period of at least 2 years at the Secretariat, will be entitled to get home leave passage for family members (spouse and maximum two <del>four</del> children aged not more than 18 years) from the Secretariat once in their entire tenure.
- 18.5 Emergency Passage<sup>4</sup>: All Expatriate Staff of the Secretariat will be entitled to get emergency passage for family members (maximum two air tickets) from the Secretariat twice/once in their entire tenure.

Financial Regulations Chapter II Article 6 page 62

6.1 If the Commission is unable to meet or adopt the budget before the beginning of the new financial year, the Secretary General shall be authorized to make payments from the General Reserve Fund to sustain Secretariat's essential functioning on provisional basis for a maximum period of three months on the basis of the budget approved for the previous financial year.

## Application of the Budget, Internal and External Controls Article 10 page 63

The Financial accounts of the Secretariat shall be subject to an external auditing on biannual basis. The audit team may visit the Secretariat for a period of one week, and may comprise the designated auditors of the host country and current and future-chair (if the host country is chairing the Organization, then the audit team will comprise the designated auditors of the host country and future Chair). The expenses of such auditing shall be borne by the sending Member Countries.

### AGENDA ITEM 12: DISCUSSION ON THE GOVERNING STRUCTURE OF THE AFFILIATED BODIES

#### Malaysia's Input:

- 1. Malaysia commends the effort of the D-8 TTEN Secretariat in proposing the D-8 Charter and the Organisation Chart.
- 2. However, Malaysia wishes to highlight that the proposal should be discussed at the High Council Meeting (HCM) of the D-8 TTEN before tabling it to the D-8 Commission.
- 3. Nonetheless, Malaysia would like to highlight several important issues on the proposed Charter:
  - a. On Article 6 of the Charter, it is important to note that the Member States thus far have never committed to constantly provide financial grants, or pay any fees to the D-8 TTEN Secretariat;
  - b. On the final paragraph of the Charter, the D-8 TTEN Secretariat did not attach together the documents containing the preamble, 12 articles, 4 notes, and 8 appendices with the proposed Charter for Member States' reference; and
  - c. The final paragraph also mentioned that "...the proposed Charter will enter into force on the date of approval and notification of the D-8 Secretary-General". So, it would be also much appreciated if your excellencies could kindly request and emphasize your country related focal points to attend to our meetings and increase their participants on our event and programs.



Worsening socio-economic realities in D-8 countries could reverse the attainment of sustainable development goals 1 (no poverty), 2 (zero hunger), 3 (good health and wellbeing)

Knowing that government funding is never enough, we are developing Islamic financing tools to complement such as Zakat

Zakat- as an Islamic financing instrument has proven to help in poverty reduction, improve solidarity and reduce social tensions in society, especially when coupled with waqf and sadaqah financing tools We computed that in Nigeria, this program can collect at least \$3.2 billion annually in Zakat which can lift 4.5 million people out of poverty.


Aim is to pool zakat and widen the payer net, through a web-based platform that ensures effective and seamless distribution

Twelve months of project work is needed to operationalize this plan spanning four phases:

- Phase 1, Design: development of an IT blueprint to onboard payers, recipients, and administrators into one system for ease of transaction and real-time tracking and accountability.
- **Phase 2, Beta release:** testing the prototype to ensure it works to expectations especially maximizing user experience.
- Phase 3, Pre-deployment: pretesting the released version together with the Zakat and cards in a few selected areas towards hitch free deployment
- **Phase 4, Deployment:** Launch the UZF and transition to post-deployment operations.

### Introduction of Soybean as new crop

- 1200-soybean lines tested for five years (2017-2021; spring and autumn).
- Three types of soybean lines were identified for soybean import substitution in Pakistan.
- Erect soybean lines (10) recommended for Soybean-Based Intercropping Technologies.
- Indeterminate soybean lines (17) recommended for maize/sorghum silage.
- Heat-tolerant soybean lines (13) recommended for Southern Punjab and Sindh.
- All recommended soybean types (40) are Protein/Oil enriched. In addition, they have the significant potential to meet the growing poultry and livestock feed requirements.
- Potential import substitution 4 5 billion USD annually.

# Performance of soybean with maize under strip intercropping technology (2017- 2021)

- Soybean (erect-type) produced 1.3-1.5 tons ha<sup>-1</sup> in soybean-based intercropping technology.

- Maize produced 8.0-8.5 tons ha<sup>-1</sup> in soybean-based intercropping technology.

#### CONCEPT NOTE FOR THE D-8 ENERGY FORUM LAGOS, NIGERIA

#### **Background**

 In today's world, people from developed and developing countries face enormous challenges and acute crises in the energy field, albeit in varying degrees of severity. This leads to a further increase in the high prices of food and environmental and climate changes. The Covid-19 pandemic and the Russia-Ukraine conflict exacerbated the challenges further. The world of the 21<sup>st</sup> century is designed with massive industrialization and technological transformation that demands power and energy in vast quantity as its primary driving force. The emergence of the 4<sup>th</sup> Industrial Revolution has further multiplied the energy appetite of the modern world. The pervasive nature of these challenges is undoubtedly beyond the capacity and capabilities of the individual developing nations. Therefore, cooperation in the field of energy is imperative.

Energy use is projected to continue growing until 2030, with oil and gas dominating the energy mix. On the demand side, developing countries will dominate this growth, especially those with sustained, high growth rates. However, there has also been a growing awareness that stable energy markets and efficient use of energy are imperative to make energy accessible and affordable to a larger share of the world's ever-increasing population.

Considering the pivotal role of energy in the development process, the leaders of the Member States of the Developing Eight Organization for Economic Cooperation (D-8) identified energy and mineral resources as one of the six critical areas of cooperation of the D-8. The priority is encapsulated in the D-8 Decennial Roadmap for 2020-2030, where the Leaders set a target that all Member States should enjoy affordable and clean energy, which is encapsulated in one of the United Nations (UN) Sustainable Development Goals (SDGs), specifically SGD-7. The Leaders also delineated strategies to achieve the goal, focusing on energy security, renewable energy, and energy transition.

It should be noted that the Member States of the D8 constitute one seventh (1/7) of the world's population (about 1.1 billion) and about 14% of global trade (700 billion Dollars). Given the nature of their energy demand, the D-8 countries offer vast potential for new investments and market expansion. Cooperation in energy trade, financing for energy sectors, capacity-building programs, and sustainability of supply needs have gained more attention in recent years, particularly with the establishment of the working group of D-8 Member states on renewable energy cooperation.

In view of the foregoing, and in line with the D-8 2030 Agenda to ensure energy security, including providing affordable and clean energy for all the Member States, the D-8 Secretariat came up with the idea of organizing a D-8 Energy Forum in 2023 to bring together leaders from government institutions and businesses from D-8 countries for in-depth discussions

about the latest trends and opportunities available in the energy market of their respective countries with the ultimate aim of leveraging on their areas of complementarities to grow the energy sector collectively.

For this purpose, the D-8 Secretary-General, on the sideline of the D-8 Small and Medium Enterprises (SME) Forum and Health Markets held in Abuja, Nigeria, in November 2022 had initiated discussions with some key stakeholders in the Nigerian energy sector, including the Nigerian Bulk Electricity Trading Plc (NBET) and the Nigerian Chamber of Commerce, Industry, Mines and Agriculture (NACCIMA). The meetings discussed possible cooperation among the D-8 Member States to increase the production and trade of energy and the possibility of partnering with the D-8 Secretariat to organize a private-sector-promoted D-8 Forum on Energy in Nigeria in the second quarter of 2023. The NBET and NACCIMA welcomed the idea of organizing the proposed D-8 Forum on Energy. They noted that the participation of other entities in Nigeria and member countries of the D8 would be beneficial to the event.

#### **Brief Background on NBET and NACCIMA**

NBET

Public Limited Company and has been operating in the Nigerian electricity market since 2011.

It holds a Bulk Electricity Purchase and Resale License issued by the Nigerian Electricity

Regulatory Commission (NERC) and serves as an Intermediary between Generation

Regulatory Commission (NERC) and serves as an Intermediary between Generation Companies (GenCos)/ Independent Power Producers (IPPs) and Distribution Companies (DisCos) in the electricity market. Its establishment was part of the power sector reform

NBET is an agency of the Federal Government of Nigeria (FGN) incorporated in 2010 as a

agenda of the FGN aimed at transforming the sector from a vertically integrated public

monopoly to an unbundled, liberalized, private sector-led electricity market.

 NBET's mandate also includes electricity sale to industrial customers (also known as "Eligible Customers") and international customers. Its establishment and operation over the years has been key to driving investor confidence in the electricity market especially with respect to power generation.

#### **NACCIMA**

NACCIMA was established as a voluntary business association in Nigeria and has been operational since 1960. It has 410 corporate members and currently serves as an umbrella organisation for 64 city/state member Chambers of Commerce within Nigeria, 9 Business Associations, and 5 Bilateral Chambers of Commerce established with other countries.

NACCIMA engages in policy advocacy and seeks to influence public policies affecting the business community with a view to ensuring an enabling business environment in the country.

#### Overview of the Energy Sector in D8

The energy demand in the D-8 Member States is rising rapidly as all the countries are emerging economies with high growth rates. The power consumption of the Member States is dominated mainly by fossil fuels, i.e., oil, coal, and natural gas. Rapid economic and population growth in the past two decades has driven strong energy demand growth and an associated increase in import dependency of most of the D-8 Member States. In recent years, Member States have been trying to diversify their energy mix to reduce their reliance on fossil fuels due to the fact that the source depletion nature of the fossil fuels poses a considerable threat to their energy security and achieving net-zero Green House Gas (GHG) emissions in accordance with the Paris Agreement. Renewable energy sources like nuclear, hydro, solar, wind and bio sources are gaining growing importance.

According to the data published by the International Renewable Energy Agency (IRENA), most of the D-8 Member States fare relatively well in electricity generation. In 2020, Bangladesh produced 85.138 GWh of electricity, with 99% of that amount from non-renewable sources. Egypt had 197.678 GWh of electricity, with 88% coming from non-renewable sources. Indonesia produced 285.899 GWh of electricity, with 83% of its origins being non-renewable. Iran generated 334.587 GWh of electricity in the same year, with 96% of the sources being non-renewable. Malaysia generated 175.995 GWh of electricity in 2021, with 84% coming from non-renewable sources. Nigeria produced 35.331 GWh of electricity, with 77% coming from non-renewable sources. Pakistan generated 137.412 GWh of electricity, with 67% made from non-renewable sources. While Türkiye managed to produce 306.706 GWh of electricity in the same year, 58% came from non-renewable sources.

According to data obtained from IRENA, most of the D-8 Member States are active in energy. The Member States are also embarking upon considerable diversification of their energy mix. In particular, renewable energy has staged impressive growth, with renewable electricity generation tripling in the past decade.

In view of the foregoing, there is a high potential for reciprocity and complementarity among the D-8 Member States, not only in the field of energy trade among themselves but also in exchanging their experiences and best practices for enhancing the capacity of their relevant officials, institutions and companies operating in the energy sector. It is against this background, therefore, that the D-8 Secretariat wishes to organize the proposed Energy Forum in Lagos, Nigeria to explore potential opportunities for the development of the energy sector in D8 countries in line with the D-8 Decennial Roadmap for 2020-2030 and the SDG7.

Nigeria has shown stellar leadership especially in the area of renewable energy policy. At the
United Nations General Assembly conference held in September 2021, His Excellency,
President Muhammadu Buhari, GCFR affirmed that Nigeria is working on a transition to a low
carbon economy, consistent with achieving the Paris Climate Agreement and the Sustainable
Development Goals.

In November 2021, Nigeria enacted the Climate Change Act 2021, which set a Net Zero GHG Emissions Target of 2050-2070. Following that, in February 2022, the government approved an Energy Transition Plan for achieving net zero carbon emissions that set a target for 2060. Nigeria is taking key steps striving to attain the UN Sustainable Development Goals - SDG-7 as well as SDG-13 (Urgent action to combat climate change and its impacts).

#### Basis for collaboration between NBET and NACCIMA in organizing the D-8 Energy Forum

The Guiding Principles outlined in the D-8 Decennial Roadmap for 2020-2030 include amongst others, that "the private sector should be the main engine of growth, with the government proactively creating an enabling environment and providing supportive infrastructure in accordance with national plans and priorities".

Furthermore, the key programs within the Roadmap includes "promoting cooperation between government and chambers, associations, large companies, and other relevant institutions of the Member States to strengthen public-private partnership in contributing to the development of [Small and Medium Enterprises] SMEs." It also includes, "Enhancing participation of the private sector in D-8 cooperation through active involvement of the chamber of commerce association, regular organization of Business Fora, and holding specialized exhibitions and coordinating meetings among chambers of commerce in order to develop potential programmes, etc."

The collaborative work of NBET and NACCIMA in organizing the proposed D-8 Forum on Energy will serve to advance the key mandates of both organisations.

For NACCIMA, it serves to align the business projections and targets of its members with the government's policy especially in the area of energy for industrial purposes. Currently, a misalignment exists between industrial electricity demand and supply in the country, with many businesses substantially relying on self-generation to meet their energy requirements. According to Nigeria's Energy Transition Plan 2022, 80% of operational energy capacity comes from off-grid diesel/petrol generators, which are expensive to procure and maintain and also run on fuel that increases the country's GHG emissions. NACCIMA members will be able to network effectively with their business counterparts from other D-8 countries and gain insight into the business opportunities in these countries.

For NBET, collaborating with NACCIMA in organizing the forum serves to create an institutional alignment with NACCIMA with a view to addressing the key energy

requirements of NACCIMA members and mapping out strategies for addressing these needs in a sustainable manner.

NBET is the Government agency that executes Power Purchase Agreements (PPAs) with IPPs seeking to invest in electricity supply to the grid including renewable energy projects. The company is in the process of establishing an energy exchange leveraging on a cooperation agreement it signed in August 2022 with the Turkiye energy exchange, Enerji Piyasalari İşletme A.Ş. (*EPİAŞ*). NBET is taking the lead to roll out this great initiative that will interest investors and partners across the D-8 member states as it seeks to create a very competitive, efficient and transparent automated marketplace for the trading of electricity and gas within and beyond the country. It is also aimed at facilitating carbon trading and the development of a carbon credit market. Hosting the Energy Forum in Nigeria would provide a discussion forum that would not only be a hub for attracting investors but a perfect platform for crowdsourcing ideas, gaining valuable feedback and upgrading value preposition for various initiatives in the NESI including that of the Energy Exchange.

For the D-8, working with NBET and NACCIMA in organizing the Energy Forum will enable it gain full insight into the opportunities that exist within Nigeria in the energy sector including the area of renewable energy and how other D-8 countries can key into the emerging opportunities in the Nigerian business environment. It will also serve to enlighten D-8 Member States on the policy, legal and regulatory environment for energy investments in Nigeria and how business relationships can be effectively forged and deepened between their respective business/industrial groups.

#### **Objectives of D-8 Energy Forum**

The purpose of the D-8 Energy Forum is to create a platform for businesses in the energy sector, both state-owned enterprises and private sectors from the D-8 Member States, to build networks and collaborate in the energy sector in line with the D-8 2023 Decennial Roadmap. Therefore, the Forum's objectives are to:

Enhance investment in the energy sector;

It is important that the D-8 Energy Forum is not just a one-off event that brings together energy policymakers, practitioners and stakeholders in the D-8 community With a view to sustaining the positive gains of the forum, it is proposed that a D-8 Centre of Excellence in Renewable Energy and GHG emission reduction be established, domiciled in NBET, the agency of the Nigerian government that is best suited to lead its energy-related engagements at the D-8 based on its mandate.

The centre will be a one-stop-shop for providing advisory and technical support to prospective IPPs seeking to invest in renewable energy in Nigeria and gain insight into business opportunities in other D-8 countries in the area of renewable energy. The centre would also target the following objectives:

A. Facilitate the Operationalization of a National policy on Decarbonization in the energy sector. Due to current severe national baseload power supply deficit there is focus on Gas as a transition fuel to provide a bridge to renewable energy. Hydroelectric power will also be crucial in the transition process.

B. Provide Research support, including feasibility studies on renewable energy and applicable technologies (solar, wind, hydrogen, geothermal, tidal and wave energy, biomass

C. Serve as a data aggregation hub for providing high grade energy intelligence to D-8
Member States, to facilitate investment decision-making.

D. Provide a comprehensive interactive map showing the geo-locations of the generation plants, transmission and distribution network, gas pipeline network, energy locations and commercial/industrial energy customers based on their energy requirement, and guide D-8 members seeking to invest in the Nigerian energy market and the broader market within the Economic Community of West African States (ECOWAS).

F. Provide Technical Advisory Support (Legal, Commercial, Financial and Technical) for clean energy projects including existing gas fired power plants retrofitting for waste and heat recovery.

G. Provide support to prospective developers in accessing climate and cleaning energy funds including grant to support target investment that facilitate bilateral transactions for the supply of renewable energy to homes and industries.

H. Facilitate capacity development with government institutions in the energy sphere and experience exchange within the D-8 on global practice.

#### Rotation of the D-8 Chairmanship

#### Proposed arrangement by the Islamic Republic of Iran

#### **Background**

- 1. The strengthening of "the legal and institutional framework" of the D-8 Organization for Economic Cooperation was among the recognized needs when the eight founding Members of the Organization, inspired "to work in an institutional manner towards the full realization of the vast potentials of the Member Countries", agreed to the Charter of the Organization.
- **2.** The Charter of the Organization, throughout of its Articles, has gone to great lengths to set forth the needed roles and Organs, as well as the Rules of Procedure to ensure the effective administration of the Organization.
- 3. Among the defined roles, the Chair of D-8 that "shall preside over all meetings of the principal organs and technical meetings" and "shall exert its utmost efforts to promote the objectives of the Organization" has an eminent role in facilitating the functions of the Organization including, but not limited to, the conduct of meetings of the Principal Organs.
- 4. According to article 6.3 of the Charter, "The Summit is convened once every two years in the territory of one of the Member states by rotation". Article 14.1 of the Charter specifies "Member States hosting the Summit shall assume the D-8 Chair...". In practice, transition of chairmanship has been delayed, in a number of occasions, due to very fact that there has been no volunteer to host the Summit, or the volunteer

country was not in the position to organize the Summit in the expected timeframe. In other words, and as per current practice, if there is no volunteer to host the Summit, or if there is no clear prospect of when exactly the next Summit is convened by the envisaged next chair, the incumbent Chair should continue. This means that to the extent the Summit is delayed, the assumption of chairmanship is delayed, leading to the indefinite extension of the tenure of the incumbent chairman, with extra financial and other burdens. This is against the very spirit of equal/equitable burdensharing and the imperative of an enhanced sense of ownership among the Member States.

#### **Proposal**

As per practice in many regional and international organizations, the D-8 chairmanship should rotate in alphabetical order on 1st January every two years. As per D-8 Rules of Procedure, the Chair presides over the D-8 Principal Organs, including Summit (Rule 8.2 of D-8 Rules of Procedure). Given the fact that the Summit is convened once every two years (Charter and Rules of Procedure), the incumbent chair has a flexibility to organize it when it deems it possible during its chairmanship.

#### D-8 Parliamentary Assembly (DPA)

Proposal by the Islamic Republic of Iran

#### i. Background

- 1. Promotion and enhancement of "joint efforts" towards achieving sustainable development is among objectives of the D-8 Organization for Economic Cooperation whose Member States are "determined to make collective endeavors" for prosperity and welfare of their people and reaching "common economic goals of development". The "D-8 Global Vision" commits Members States "to promote fruitful collaboration and close cooperation in the widest possible fields....and enhance mutually beneficial interdependence within the D-8 community".
- 2. People-to-people relations and expansion of ties between domestic bodies of the Member States, including Parliaments, has an indubitable role in strengthening of "deep-rooted historical affinities" within the Organization. As an organization "committed to forge a common approach" among Member States, D-8 has an obvious interest and advantage in building up closer ties among 8 national legislative bodies. A strong and concerted "legislative support" for D-8 governments in their pushing for economic cooperation is both facilitating and encouraging.
- 3. With these in mind, Foreign Minister Dr. Amir-Abdollahian in his address to the 20<sup>th</sup> Session of the D-8 Council of Ministers on 27 July 2022 highlighted that "the capacity of the parliaments of the Member States should be tapped for the purpose of developing and advancing our cooperation". He proposed that the Secretariat "examines the possibility of holding joint meetings between the parliaments of the eight countries, and even the possibility of setting up a D-8 inter-parliamentary body and expressed the readiness of the Islamic Republic of Iran to lend its support. The

following proposal is intended to open dissuasions on the proposed idea in the Commission.

#### ii. Proposal

The speakers of national parliaments of the Member States may convene a joint meeting, date and venue<sup>1</sup> to be agreed, and start parliamentary cooperation within D-8. They may institutionalize their envisaged cooperation in the form of a parliamentary body to be called, for instance, the D-8 Parliamentary Assembly (DPA) or else.

#### iii. Objectives

- a. To harness potential and capacities that the parliaments, individually and collectively, can offer to assist realization of D-8 noble goals and objectives.
- b. To give parliaments of the Member States the opportunity to establish multilateral parliamentary cooperation and engagement (Parliamentary diplomacy).

#### iv. Functions and Structure

As soon as the D-8 parliaments agree on the establishment of the proposed body, a drafting process should prepare drafts of the main documents, including charter, rules of procedure, structure, etc.

The Commission may discuss an optimal roadmap leading to establishment of the proposed DPA.

#### JOINT COMMUNIQUE OF THE D-8 COMMISSIONERS ON THE EARTHQUAKE IN TÜRKIYE AND SYRIA ON 6 FEBRUARY 2023

We, the Commissioners of the Developing Eight Organization for Economic Cooperation (D-8 Organization) from the People's Republic of Bangladesh, the Arab Republic of Egypt, the Republic of Indonesia, the Islamic Republic of Iran, Malaysia, the Federal Republic of Nigeria, the Islamic Republic of Pakistan, and the Republic of Türkiye, gathered for our 46<sup>th</sup> Session in Istanbul, Türkiye, on 15-16 February 2023, offered our deepest condolences to the people and Government of the Republic of Türkiye for the devastating earthquake that struck Türkiye and Syria on 6 February 2023.

We offered prayers and heartfelt condolences for the departed souls and also wished for the speedy recovery of those who were injured during the earthquake and extended our cooperation during these challenging times. Having witnessed the resilience of the Turkish people, we are confident that Türkiye will successfully move to the recovery and reconstruction phase.

We were encouraged by the demonstration of solidarity by the D-8 Member States in swiftly providing assistance for the disaster response and relief efforts being conducted by the Government of the Republic of Türkiye. We are also confident that the assistance provided would contribute towards emergency response and reconstruction in the affected regions.

Considering that natural disasters at a relatively massive scale happening in many of the D-8 Member States, we also agreed to explore the establishment of a D-8 disaster response and relief mechanism.

#### CONCEPT NOTE

#### D-8 COMMITTEE IN THIRD COUNTRIES AND INTERNATIONAL ORGANIZATIONS

The D-8 Secretariat establishes this concept note to provide the rationale for the proposal to develop D-8 committees in third countries.

#### I. INTRODUCTION

- The D-8 Organization can enjoy broader support and partnership with international partners if it can manage strengthened relations with other countries and international organizations. In addition, support and collaboration can also be garnered if the international community understands the D-8 organization better.
- 2. Furthermore, the D-8 Leaders reaffirmed their commitment to active participation, effective coordination, and cooperation with all relevant regional and international organizations to maximize the realization of the Organization's interests and to contribute to the development of the D-8 Member States, as envisioned in the Dhaka Declaration 2021.
- 3. Upon taking office on 1 January 2022, the D-8 Secretary-General envisioned enhancing the Organization's visibility, both within the D-8 Member States and in the global arena, as one of his twin visions. Accordingly, the outward-looking policy is intended to enhance the organization's visibility. In so doing, the D-8 Secretariat revamp its efforts to forge a stronger relationship with other international organizations and entities.
- 4. The D-8 Secretariat also believes that the Organization must nurture friendly relations with external entities to promote a broader scope of cooperation through mutually beneficial dialogue, partnerships, and tangible collaboration.
- 5. The Organization's enhanced visibility will bring more benefits by making it more widely known. The enhanced visibility would also significantly contribute to achieving the Organizations' objective to improve developing countries' positions in the world economy, diversify and create new opportunities in trade relations, enhance participation in decision-making at the international level, and provide a better standard of living for its citizens.
- 6. Moreover, the D-8 Organization is currently in its second life cycle, comprised of result-oriented and tangible programs in the priority areas delineated in the D-8 Decennial Roadmap 2020-2030. Many of the Organization's projects and programs require significant resources and financial support, which may be obtained from other international entities.
- 7. For example, the United Nations Department of Economic and Social Affairs (UN DESA) provided full coverage to the Capacity-Building Workshop on the New Approaches to E-Government Implementing new approaches to E-government for SDG Implementation, jointly organized by the D-8 Secretariat and UN DESA in Istanbul, on 17-18 November 2022.
- 8. In its effort to enhance the Organization's visibility in the global arena, the D-8 Secretariat is of the view that the D-8 Organization can utilize the diplomatic strength and resources of its Member States to support the promotion of its interest and

identities in the global setting through the establishment of a D-8 committee in a third country or international organization.

#### II. DEFINITION & PROVISIONAL TERMS OF REFERENCE

- 9. The D-8 committee in third countries and international organizations is a mechanism comprising heads of diplomatic missions of the D-8 Member States in a particular third country or in relation to an international organization.
- 10. The committee may conduct activities in a host country or international organization by utilizing resources of the respective mission of the D-8 Member States. The proposed activities must be communicated to the D-8 Commission through the D-8 Secretary-General for consideration by the Commission.
- 11. The committee may meet one every quarter, or more frequently, if deemed necessary.
- 12. The head of mission of the D-8 Member State that chairs the D-8 Organization should assume the position as chair of the D-8 committee in their host country or international organization.

#### III. PURPOSE & OBJECTIVES

- 13. The purpose of a D-8 committee in a third country is to promote the interests and identity of the D-8 Organization in the host countries and international organizations. The committee manages the D-8 Organization external relations with the host countries and international organizations.
- 14. The objectives of the committee is to enhance the D-8 Organization's visibility in the global arena, strengthen cooperation between the D-8 Organization with external parties, and promote the D-8 Organization's interest and identity in the respective host country to support the D-8 Organization's effort to improve its position in the world economy, diversify and create new opportunities in trade relations, enhance participation in decision-making at the international level, and provide a better standard of living.
- 15. Such objectives can be elaborated further as follows:
  - a. Raising awareness of all stakeholders in the host country or international organization towards the D-8 Organization, its objectives, interests, identity, and role toward the international order to the global audience.
  - b. Harnessing stronger partnerships with the host country and prominent institutions to broaden the opportunity of tapping resources for the benefit of the D-8 Organization.
  - c. Coordinating and cooperating effectively with third countries and relevant regional and international organizations to maximize the realization of the Organization's interests.

#### IV. PROCEDURES AND TIMELINE

- The D-8 Commission may deliberate the present concept note during its 46<sup>th</sup> Session in Istanbul, 15-16 February 2023. If the D-8 Commission endorses the proposal, it will forward it to the D-8 Council for consideration during the Council's 21<sup>st</sup> Session in 2023.
- 17. Upon approval by the D-8 Council, the D-8 Secretary-General and the Chair of the D-8 Commission, through consultation with the Member States, will develop specific rules of procedures for the operationalization of a D-8 committee in a third country.
- 18. At the early stage, the D-8 committee in a third country may be established in countries and international organizations with which the D-8 has the strongest interest and interactions. The D-8 Secretariat envisions that, upon the approval by the D-8 Council, for this purpose, committees may be established in the following posts, among others:
  - a. Berlin, Germany, to foster cooperation with the Federal Republic of Germany, particularly the German International Cooperation Agency (GIZ).
  - b. Brussels, Belgium, for the European Union.
  - c. Geneve, Switzerland, for the United Nations Office in Geneve, World Trade Organization (WTO), World Intellectual Property Organization (WIPO), and the United Nations Conference on Trade and Development (UNCTAD).
  - d. Jeddah, Saudi Arabia, for the Organization of Islamic Cooperation (OIC) and the Islamic Development Bank.
  - e. New York, the United States, for the United Nations.
  - f. Rome, Italy, for the Food and Agriculture Organization (FAO) and International Fund for Agricultural Development (IFAD).
  - g. Tokyo, Japan, to foster cooperation with Japan, particularly the Japan International Cooperation Agency (JICA).
  - h. Vienna, Austria, for the United Nations Office in Vienna, the United Nations Industrial Development Organization (UNIDO), and to foster cooperation with the Government of Austria, particularly Advantage Austria.
- 19. For the next step, other committees may be established in other countries and international organizations upon approval from the D-8 Council.

#### V. ACTIVITIES

- 20. A D-8 committee in a third country may conduct activities to support the objectives outlined in this concept note. Proposed activities may include:
  - a. Regular meetings and engagement with the Ministry of Foreign Affairs of the host country or relevant departments of the international organizations to provide updates on the development of the D-8 Organization.
  - b. Joint seminars or workshops with the Ministry of Foreign Affairs, Ministry of Trade, National Chambers of Commerce, or other prominent institutions in the host country to further enhance the visibility of the D-8 Organization in the host country.

- c. Joint cultural activities in the host country's territory or premises of the international organizations, particularly to commemorate the anniversary of the establishment of the D-8 Organization every June.
- d. Engagement with local media and news agencies, such as the production of featurettes on D-8 Organization.

#### VI. CONCLUSION AND RECOMMENDATION

- 21. The D-8 Secretariat views the establishment of the D-8 committees in third countries will contribute to the Organization's effort to enhance its visibility.
- 22. Therefore, the D-8 Secretariat recommends that the D-8 Commission and the D-8 Council consider the present proposal positively.
