The 1st D-8 Senior Officials Meeting on Youth Hosted by the People's Republic of Bangladesh Dhaka, 20 May 2024

Report

The Ministry of Youth and Sports of the Government of the People's Republic of Bangladesh hosted the 1st D-8 Senior Officials' Meeting on Youth in Dhaka on 20 May, 2024. Delegates from the People's Republic of Bangladesh, Arab Republic of Egypt, Republic of Indonesia, the Islamic Republic of Iran, the Federal Republic of Nigeria, the Islamic Republic of Pakistan and the Republic of Türkiye attended the meeting. The list of participants is attached as **Annex-I**.

Before commencing its substantive session, the Meeting offered its deepest condolences to the esteemed Delegate of the Islamic Republic of Iran on the untimely demise of H.E. Ebrahim Raisi, the Honourable President of the Islamic Republic of Iran, and H.E. Hossein Amir Abdollahian, the Honourable Minister of Foreign Affairs of the Islamic Republic of Iran, along with their entourages, which was caused by the tragic incident involving helicopter crash in Iran on Sunday, 19 May 2024. The Meeting also observed a minute of silence as a gesture of condolence and sympathy to the people and Government of the Islamic Republic of Iran.

Agenda Item 1: Opening of the Meeting

The Chair of the Meeting, Dr. Mohiuddin Ahmed, the Secretary of the Ministry of Youth and Sports of the Government of the People's Republic of Bangladesh delivered the opening remarks and officially opened the Meeting. He stressed youth empowerment in every sphere by developing their capacity and ensuring economic development through engaging the young people of the D-8 Member States in innovation, development and technological advancement. He further underscored the formation of efficient and productive youth society through training and excellence at national and international level. His opening remark is attached as **Annex-II.**

Agenda Item 2: Adoption of Agenda

The Meeting considered and adopted the agenda which is attached as Annex- III.

Agenda Item 3: Remarks by the Secretary-General of the D-8

The Secretary-General of the D-8 Organization for Economic Cooperation, Isiaka Abdulqadir Imam, delivered his welcoming remarks. The Secretary-General underlined the need for formulation of a national policy and regulations to prioritize youth entrepreneurship; creation of entrepreneurs' alliance involving the D-8 youth; revaluation of export and import policies for SMEs in D-8 countries to encourage youth entrepreneurs. and improving all forms of education i.e., vocational, formal, digital literacy, and entrepreneurial education among D-8 youth. Agenda Item 4: Remarks by the Heads of Delegation of the D-8 Member States

The esteemed Heads of Delegation of the D-8 Member States delivered their respective national statements on youth highlighting the status of their youth development and outlining the ways and means to enhance youth engagement among the D-8 Member States. The remarks are attached as **Annex- V**.

Agenda Item 5:Consideration and Recommendation of Establishment of D-8 YouthCouncil in Dhaka, Bangladesh

Bangladesh briefed the Meeting on the proposed D-8 Youth Council, including the nature of the Council, its regulation, registered office, membership, the executive committee, rules of procedures for the convening of the Council, decision making process, budget and funding mechanism, as well as the operational manual.

The Meeting principally agreed on the establishment of the D-8 Youth Council in Dhaka, as was approved previously by the D-8 Commission through its 46th Session, held in Istanbul, Türkiye on 15-16 February 2023. The Meeting was of the view that the articles of the Constitution of the proposed D-8 Youth Council needs to be discussed further among the Member States and tasked the Secretariat to share the draft 'Constitution of the D-8 Youth Council' with the Member States again. The Meeting invited the Member States to provide their respective inputs to the draft Constitution with a deadline of one month after receipt of it.

The draft 'Constitution of the D-8 Youth Council' under consideration is attached as Annex-VI.

Agenda Item 6: Presentation on the Best Practices of the D-8 Member States

The Delegates from Bangladesh, Indonesia, Nigeria, Pakistan and Türkiye shared the best practices on the youth development in their respective countries as follows:

- a. The Delegate of Bangladesh made a presentation on Digital Skills for Smart Generations. The Presentation is attached as **Annex-VII**.
- c. The Delegate of Indonesia made a presentation on Blue and Green Economy and Eco Tourism. The presentation is attached as **Annex-VIII.**
- f. The Delegate of Nigeria made a presentation on Climate Resilience Youth Development and Youth Networking. The presentation is attached as **Annex-IX**.
- g. The Delegate of Pakistan made a presentation on Non-Formal Education for Youth. The Presentation is attached as **Annex- X**.
- h. The Delegate of Türkiye made a presentation on Employment Policy for Youth and Entrepreneurship Development. The Presentation is attached as **Annex- XI.**

Agenda Item 7: Establishment of an 'Integrated Youth Database Website'

The Delegate of Bangladesh briefed the Meeting about their proposal of the establishment of an integrated youth database website for D-8 Youth. The Delegate highlighted further the salient features of this website and its role on enhancing networking among the D-8 Youth.

The Meeting principally acknowledged the idea of establishing an 'Integrated Youth Database Website' of the D-8 youth, however, requested Bangladesh to share a detail concept note defining the purposes, objectives, criteria, data type and other relevant features of the database website.

Agenda Item 8:Consideration of the draft of "Dhaka Declaration on D-8 Youth2024" to be adopted by the 1st Meeting of the D-8 Youth Ministers

The Meeting considered the draft "Dhaka Declaration on Youth 2024", after which it endorsed the draft, based on the principle of consensus, for the Draft to be adopted by the Ministers in their Session the following day. The draft Declaration, finalized by the SOM, is attached as **Annex- XII.**

Agenda Item 9: Date and Venue of the 2nd D-8 Senior Officials' Meeting on Youth

The Meeting appreciated the Federal Republic of Nigeria for its gracious offer to host the 2nd Senior Officials' Meeting on Youth. The date and venue of the meeting will be announced in due course.

Agenda Item 10: Any other business

The Meeting noted the proposal from the delegate of Nigeria to enrich the draft Constitution of the D-8 Youth Council and requested Nigeria, through the D-8 Secretariat, to circulate the proposal as part of their enrichment of the Constitution.

The Meeting noted the proposal from the Islamic Republic of Iran to establish a Secretariat dedicated to Youth Empowerment and Skill Development Center in Tehran. However, the Meeting requested Iran to send its proposal officially through the diplomatic channel.

Agenda Item 11: Consideration and Adoption of the Meeting Report

The Meeting considered and adopted the Report of the 1st Senior Officials Meeting on Youth.

Agenda Item 12: Closing of the Meeting

The Meeting was closed with the following statements:

- a. The Secretary-General of the D-8 conveyed profound gratitude to the Government of the People's Republic of Bangladesh for hosting the meeting and warmly thanked Dr. Mohiuddin Ahmed for his competent chairing. He also thanked all delegates for their active participation and contribution to the Meeting.
- b. In his Closing Remarks, the Secretary of the Ministry of Youth and Sports of the People's Republic of Bangladesh, expressed his profound appreciation to all delegates

for their fruitful discussions and commended the constructive outcome of the deliberations.

Distinguished Delegates,

Ladies and Gentlemen,

I am delighted to be back in Dhaka today to attend the First Session of the D-8 Senior Officials Meeting on Youth.

I thank the Government of the People's Republic of Bangladesh, particularly the Ministry of Youth and Sport, for the warm welcome and hospitality accorded to me and my delegation.

I should congratulate the Government of Bangladesh on the excellent arrangement for this Senior Officials' Meeting. I trust we can have constructive discussions to strengthen our cooperation in youth development.

Mr. Chair, Distinguished Delegates

Today's meeting is timely and crucial.

The first importance is that this is the first session of the Senior Officials responsible for Youth from the D-8 Member States. The second importance is that it will provide a solid groundwork for the Ministerial session tomorrow.

Another significance of this meeting is that young people are significant agents of community and national development. They have been at the forefront of leading community initiatives, reshaping the political system, and playing key roles in technological advancement and innovation.

In the D-8, young people constitute around 20% of the total population. Therefore, we must treat these demographics as an asset in achieving the goals and aspirations of the D-8 Organization.

Mr. Chair, Distinguished Delegates

My statement will comprise two main parts: **first**, an overview of the potential for youth cooperation in the D-8, and **second**, the way forward and suggested programs for D-8 Youth Cooperation.

First, you would recall that the Government of Bangladesh organized the 1st D-8 Youth Summit virtually on 21 April 2021 with the theme, "Entrepreneurship for sustainable transformation".

The Summit was organized at the margin of the 10th D-8 Summit. The Youth Summit issued the following recommendations:

- → Formulation of a national policy and regulations to prioritize Youth entrepreneurship.
- → Creation of Entrepreneurs Alliance among D-8 Youth
- → Revaluation of export and import policies for SMEs in D-8 countries to encourage youth entrepreneurs.
- ➔ Improving all forms of education: vocational, formal, digital literacy, and entrepreneurial education among D-8 youth.

The ultimate outcome of the 1st D-8 Youth Summit was the establishment of the D-8 Youth Council, which the ministers will hopefully inaugurate tomorrow.

Mr. Chair, Distinguished Delegates

Second, on the way forward for our youth development.

For the way forward, I want to table some recommendations for consideration of this noble gathering.

First, the Creation of a Youth Leadership Program. We need to create a comprehensive program to nurture youth leadership skills and promote civic engagement. This platform will provide an avenue for future leaders of the D-8 to meet and network. The platform will also provide the youth with the necessary knowledge to contribute to good governance, innovation, and civil stability.

Second, the Inclusion of Youth in the D-8's development of small and medium enterprises (SMEs). To further the development of the D-8's SMEs we need to bring the youths, with their energy, creativity, and digital acumen, on board. Empowering youths within D-8 SME development requires concerted efforts to enhance access to finance, provide tailored skills development, and streamline regulatory processes.

Third, the Promotion of Sports Diplomacy. Sports are arguably a unifier for youths. Sports provide an avenue for interaction and constructive engagements. Therefore, we need to organise sports events and tournaments to help build bridges between nations and promote friendship and understanding among youth.

May I inform this gathering that the Republic of Indonesia has proposed D-8 badminton games to be organized this year. I call on other Member States to organize similar sports events to foster sports diplomacy among D-8.

Fourth, the D-8 Youth Volunteer Program. Similar to the United Nations Volunteer, if instituted, the program will harness the collective expertise of member countries within the D-8 to address pressing socio-economic challenges across member countries and strengthen our multilateral ties. This program will enable the deployment of skilled volunteers in various sectors such as healthcare, education, agriculture, and technology.

Mr. Chair, Distinguished Delegates

Lastly, we look forward to hearing submissions from member states on the following areas: digital skills for the smart generation, green jobs and economic empowerment, blue and green economy and eco-tourism, sport and cultural heritage, technological advancement, climate resilience and youth development, and non-formal education and youth entrepreneurship.

To conclude, Mr. Chair, Ladies and Gentlemen, I am optimistic that this Meeting will forge closer collaboration and knowledge exchange among our Member States, allowing them to collectively address common challenges and share best practices in youth development.

I wish us a successful deliberation for today's meeting. I thank you for your kind attention.






THE FATHER OF THE NATION "BANGABANDHU SHEIKH MUJIBUR RAHMAN"





PREAMBLE

The Developing Eight Organization for Economic Cooperation "D-8" was established on June 15, 1997, with a vision to synergize the economic endeavors of eight developing countries: Bangladesh, Egypt, Indonesia, Iran, Malaysia, Nigeria, Pakistan, and Turkey. The objectives of this global organization are to improve member states' positions in the global economy, diversify and create new opportunities in trade relations, enhance participation in decision-making at the international level, and improve the standards of living of their respective citizens and the group populace.

Youths are the vital force behind development. They have the skills and capacity to make a positive change in the world. Youth and adults are looking for strategies that can be involved in meaningful roles in the policy and decision-making process. Moreover, young people's participation and leadership must be harnessed and mobilized strategically to contribute to civic stability and good governance, which are essential building blocks for a better environment for investment and innovation. The total population of D-8 member states is about 1.1 billion, which is close to 1/7th of the world's total population. On average, 30% of its total population. These youth include rural youth, student youth, political youth, religious youth, economic youth, art and cultural youth, volunteer youth, unskilled youth, illiterate youth, disabled youth, orphan youth, sporting youth, etc. To promote all categories of youth in D-8 member countries, the 10th D-8 summit was held in Dhaka, Bangladesh on 5 April 2021, with the theme "Partnership in a Transformative World: Harnessing the Power of Youth and Technology."

The 10th D-8 summit emphasized national policy constitution, reflection of the voice of youth, ensuring women's empowerment, and sustainable transformation through entrepreneurship, focusing on soft skills and leadership skills.

To create a dedicated youth hub in D-8 countries, sharing expertise and experience through youth networking is required. For this purpose, a D-8 Youth Council is needed to establish and will be responsible for implementing the youth development agenda under the rules, constitutions, provisions, and policies of D-8 Economic Co-operation.

Article -1: Name of the Council

The name of the council will be D-8 Youth Council which is hereinafter referred to as DYC.

Article -2: VISION AND MISSION OF THE COUNCIL

Vision:

To empower and connect young people among the D-8 member states for their better life.

Mission:

- 1. To establish youth in every sphere of life by developing their capacities and ensuring empowerment.
- 2. To engage the young people in skill development, innovation and technological advancement of the member states.

Article-3: OBJECTIVES

The DYC will work to achieve the following objectives:

- I. To build a consolidated platform and network for youths in the member states.
- II. To promote effective cooperation among the youth councils/youth organizations of the member states.
- III. To facilitate and increase communication between the youth and other related organizations by strengthening networking and knowledge sharing among different stakeholders.
- IV. To develop short, medium, long term, programs, projects, plan, policies regarding the youth welfare of the member states.
- V. To enhance the implementation of youth development policies in member states.
- VI. To conduct general research on priority issues for youth development in D-8 member countries.
- VII. To introduce special scholarships in different youth development areas among the D-8 member states.

The DYC at all levels will work to ensure appropriate safeguarding measures protect vulnerable youth or persons at risk involved in the process.

Article-4: Registered office and Location of the Council

The registered office and secretariat shall be located in Dhaka, Bangladesh, in consultation with the D-8 secretariat.

The office of the DYC will work with the D-8 member states as an affiliated body in accordance with the D-8 rules, policies and guidelines.

Article- 5: Legal Status

The Council shall be a non-profit organization, and none of its net income or network shall be used for the personal benefit of its members. The executive committee shall prepare memoranda, protocols, and other legal instruments of the organization. The Council shall use its own logo, subject to the approval of the D-8 Secretariat.

Status of DYC

The D-8 Youth Council is a D-8 youth network for stakeholders to amplify the voices and experiences of young people and to harness and expand their expertise, strength, and ideas to promote youth work.

The operation of the DYC shall, in all respects, be administered in compliance with the D-8 constitution, rules, policies, procedures, and practices.

Article-6: Nature of the Council

The D-8 Youth council will be an affiliate body of the D-8.

Article-7: Advisory Committee of the Council

I) The DYC Advisory Committee will be composed of eight members supporting the work of the council. One member from each member states.

II) The committee will be formed to coordinate and facilitate government cooperation in the respective countries, as well as support the work of the

national youth council executives and other national youth bodies of the member states.

The member of the advisory committee will be nominated by the ministry of youth and sports affair of the respective member states.

Article-8: General Assembly of DYC

The D-8 Youth Council General Assembly shall consist of 41 members (18–35 years of age) regardless of their ethnic origin, color, sex, gender, disability, special needs, marital status, language, or religion from the member states. General Assembly member of the council will be nominated by the Ministry of Youth and Sports/Ministry of Youth Affairs of the Member States.

At least two-fifths of the members of the General Assembly shall make a quorum.

General Assembly is the highest decision maker body of DYC.

Article -9: Observance of the DYC

The DYC shall form an observance committee consisting of one person from each of the member states. The DYC secretariat may invite representatives from organizations that have specific subject-matter expertise relating to the work of the secretariat. All representatives shall be recognized as observers.

- 1. Observers shall have the opportunity to attend the council's general assembly and other events.
- 2. Observers may recommend or support the candidates of the council member but shall have no voting rights.
- 3. Observers shall only take part on the floor at the invitation of the president of the DYC.

Article- 10: Membership Application Form

The General Assembly shall empower the D-8 Youth Council CEC (Central Executive Committee) to develop an application form and procedure with relevant issues. A standardized form and online application process will be developed by the secretariat. Membership approval will be based on an assessment, a due diligence process.

Article-11: Review, Suspension and withdrawal of the membership

A member or observer may withdraw from DYC at any time, giving written notification addressing the president of the council, or may be terminated if any subversive activities are done by the member. It should be recognized by the General Assembly.

Article-12: DYC Executive Committee

The DYC Executive Committee shall be consisted of 15 members elected by voting of General Assembly member of the council. The Electoral board, election and voting rights stated at article-17. The structure of the executive committee having following posts.

The functions and powers of the DYC Executive Committee shall include the following:

a. The Executive Committee will prepare the agenda for the General Assembly.

b. The Executive Committee will propose a program of work for the council and a corresponding budget estimated by the executive officer or as it considers desirable to the General Assembly.

c. The Executive Committee Regular activities on the aim and objectives of the DYC or as defined by the General Assembly.

Duty Charter:

President

i) The DYC president shall perform the functions of the president.

ii) Preside over the meeting of DYC in coordination with the member states.iii) The President shall be responsible for the execution of the DYC's program and also as adopted by the General Assembly through D-8 secretariat.

Vice president

i) Shall cooperate and assist the President of DYC.

ii) In absence of President he/she shall perform the duties of the President.

General Secretary:

i) General Secretary shall manage administrative process.

ii) Shall prepare draft agenda of meeting of DYC.

iii) Arrange and conduct meeting with the consultation of the President.

iv) Preserves all records, documents of DYC.

v) Responsible for co-ordination and co-operation with all members.

Joint Secretary

Provide support to the Secretary and any other duties assigned by the President of DYC.

Treasurer:

Prepare a bi-annual budget and submit it to the DYC executive meeting; conduct expenditures, keeping all financial records and documents; and submit all expenditure records to the general assembly for post-approval.

The executive committee's operation, protocol, and prerogatives will be subject to the TOR as defined.

Secretary International Affairs

Will be responsible for international communication. Build a network among the member states of the youth organization.

Secretary Publication Affairs

Will be responsible for all kinds of documentation, including preparing and publishing periodical journals, magazines, bulletins, newsletters, website etc.

Executive Member:

The executive members will be responsible for the overall conduct of the affairs of the council in their respective member states. In addition, any specific responsibility given by the CEC will be liable for implementation.

Article -13: Youth Delegates of the General Assembly

i) Youth from the D-8 member states will be the delegates to the DYC general assembly.

ii) A youth-led organization may nominate an interested candidate to be a part of the delegation, subject to the approval of the Ministry of Youth and Sports of the member states.

iii) Where the National Youth Council / National Youth Body exists in a country, the council shall designate the national delegation through appropriate authority.

iv) The head of the department of youth development in each member state or the representative shall automatically be a part of the national delegation of the DYC with observer status.

v) The Minister of youth affairs or the representative of the government shall automatically be a part of the national delegation of the DYC with observer status.

vi) The General Assembly is the highest decision-maker when convened as quorum and due to meet biannually.

vii) The General Assembly holds the right to make decisions on the electoral board, General Assembly, financial budget approval, and/or any relevant subject matter of interest beneficial to DYC.

Article -14: Standing Committee

- 1. DYC shall establish a standing committee on thematic issues of the council, which shall support the council in all technical operations and practical works, including innovation, transformation, democracy, education and skills, youth employment and entrepreneurship, peacebuilding, respect and mutual understanding, health and wellbeing, sports for development and peace, tourism and culture, children, and disability issues.
- 2. The committee shall submit a progress report about their activities every two years to the general assembly.
- 3. The standing committee operations, protocol, and prerogative will be subject to the TOR (Terms of Reference) as defined.

Article -15: Secretariat and Appointment of the Officer and Staff

- 1. The D-8 youth council shall establish its permanent secretariat in the host country.
- 2. The Secretariat will recruit executive officer and such staff as may be required as far as resources allow, all of whom shall be persons ranging in age from 18 to 35 years, or in accordance with employment law in the respective country.
- 3. The executive officer will submit a report to the president of the council.
- 4. The executive officer will be accountable for the efficient and effective management of the council as well as for the promotion of the interests of the council and communication with DYC member's observance, the executive committee, standing committee, electoral board, arbitrators, working group, and partners.
- 5. The DYC executive officer will be responsible for office management and international communication.
- 6. The DYC executive officer will serve under a contract that will be signed by the President on behalf of the DYC. Cancellation of the contract will require prior notice from both sides.

Article-16: Meeting and Quorum of the DYC

- 1. The quorum of the Executive Committee of DYC shall be in the one-third presence of the executive members.
- 2. The general assembly shall hold a general meeting every two years. A special session shall be convened by the President of the council at the request of the two-third majority of the delegation in writing.
- 3. The general meeting of the General Assembly meetings shall be held at the venue of the host country unless otherwise determined by the General Assembly.

Article -17: Election and voting rights

- 1. Voting rights and election of the executive and delegation shall be prescribed in the DYC manual.
- 2. Voting shall be by secret ballot via physical or secure online mechanism.
- 3. The president of the DYC shall rotate in alphabetical order among the member states.
- 4. No Country shall hold an elected position of the council for two consecutive terms.
- 5. There shall be a transition period of three (3) months before the new executive assumes office after election at the executive committee. At the end of three (3) months the new executive shall officially assume the charge.

6. Electoral Board:

Electoral Board shall be made by General Assembly of DYC-

Electoral Board Consisting of five (05) members:

Chairman-1 Secretary -1 Member – 3

The DYC will make electoral constitution and duties of the Electoral Board which will contain:

- a. The composition and duties of the electoral board.
- b. Appoint and function of the members of the electoral board.
- c. Selection of the chairman and secretary of the electoral board.
- d. Such other related matter.

7. Arbitrators to the council

- a) There shall be a panel of arbitrators of the council appointed by the host government of the DYC and approved by a simple majority of the general assembly.
- b) The panel of arbitrators shall consist of three (3) youth 18–35 years of age from three member states who will be selected based on merit and relevant expertise.
- c) The arbitrators appointed will be independent and impartial without any direct or indirect conflict of interest, maintaining ethics and integrity at all times.

Article -18: Assets and Property of the Council

The DYC and DYC executives have the responsibility for all properties of the council and shall ensure that assets and resources are used only for their designated purposes.

Article -19: Finance and budget of the council

- 1. The budget shall be administered by the secretariat of the council in accordance with D-8 standards of accounting and accountability.
- 2. The General Assembly shall approve and give final effect to the budget and to the appointment of financial responsibility among the members of the council, subject to such arrangements with the D-8 and other partners as may be provided in the agreement to be entered into within the confines of the constitution.
- 3. The council may accept voluntary contributions, donations, bequests and subventions directly from governments, public and private institutions, associations and private persons philanthropic institutions, subject to conditions specified in the financial constitutions.
- 4. Each Member State shall support the Council with annual Fees (The amount/fees will be decided as per negotiation with D-8.

Article -20: Expenses of Delegates

- 1. Each delegation of its government and institution shall bear the expenses of sending its national delegation to the General Assembly for any activities of the council. Where it may participate to represent the voices of your people at important D-8 youth activities.
- 2. The council shall raise funds or otherwise may seek funding to support delegations subject to availability of funds.

Article- 21: Audit and Accounts

- 1. The executive shall appoint a qualified person or organization to be the auditor of the D-8 Youth Council.
- 2. The report of the audited accounts of the council shall be submitted to the general assembly and before accepting the report it shall require an approval of simple majority of the delegations present.

Article -22: Communication and Confidential Information

1. Prolocutor

Any interactions with the media relating to the council and constituents shall be undertaken solely by persons appointed by the executive committee.

2. Publications

DYC activities, development of technical materials, documents, and policy papers shall be published regularly, which will reflect the views and stated policy of the DYC, but shall not be produced without the approval of executive committee of the DYC.

Article -23: D-8 Youth Council Website:

The D-8 Youth Council will have a webpage that will be housed within D-8 youth's domain. The webpage will include a list of participant entities subject to their consent.

Article-24: Amendment of the Constitution

The terms of reference may be amended from time to time as per the needs of the DYC secretariat. A proposal for amendments to this constitution shall become effective upon receiving the approval of the General Assembly by a two-thirds majority of the council.

Article -25: Dissolution

- 1. Members of the council may decide to dissolve the council through a decision taken at the general assembly by a three-quarters (75%) majority of the delegation of the council.
- 2. Any assets owned by the council at the time of dissolution shall be transferred to the host country's treasury or shall be transferred anywhere in consultation with the D-8 secretariat.

Article- 26: Adoption of the Constitution

- 1. The constitution shall be subject to adoption.
- 2. This constitution shall remain open for signature at the inaugural DYC general assembly.
- 3. The DYC executive officer shall send a certified copy of the text to each of the delegations, members, and affiliated observers of DYC.
- 4. This constitution shall come into force when it is accepted by the delegation of simple majority of the member countries.
- 5. We, the undersigned, duly authorized to that effect, have signed this constitution on behalf of our young people in the D-8 member states.


Soft Skills Considered the Most Important by Employers in Bangladesh



The nature of jobs is changing over time




Future employment growth (%) by sectors in EU27 in 2022-2035







Dhaka Declaration on Youth

the 1st Meeting of the Youth Ministers of the D-8 Member States Dhaka, Bangladesh, 21 May 2024

We, the Ministers of Youth and Sports of the People's Republic of Bangladesh, the Arab Republic of Egypt, the Republic of Indonesia, the Islamic Republic of Iran, Malaysia, the Federal Republic of Nigeria, the Islamic Republic of Pakistan, and the Republic of Türkiye met in Dhaka on 21 May 2024 for the 1st Meeting of the Youth Ministers of the D-8 Member States;

Reiterating our commitments made in Istanbul, Dhaka, Cairo, Tehran, Bali, Kuala Lumpur, Abuja and Islamabad to peace, democracy, progress, dialogue, solidarity, partnership and tolerance as well as moderation as the core values and foundation for achieving economic prosperity and wellbeing of our peoples;

Reaffirming our strong faith in multilateralism, enshrined in the United Nations Charter, and committing to active participation, effective coordination and cooperation with all relevant regional and international organizations in order to maximize the realization of our common interests and underscoring the potential and benefit of South-South Cooperation that contribute to the development of the D-8 Member States;

Emphasizing the importance of youth networking, young people are empowered to expand their horizons, exchange ideas, and cultivate essential skills such as communication, collaboration, entrepreneurship, and leadership to create an environment where individuals can seek guidance, advice, and inspiration from experienced professionals and fellow peers;

Desiring to pursue the objective of sustainable youth development and recognizing the importance of mutual cooperation in possible working areas;

Seeking to explore possibilities to enhance cooperation in banking and financial institutions, training, and capacity building for the youth, through among others, a D-8 youth task force, website development, their role in small and medium enterprises, information and communication technologies;

Commending the People's Republic of Bangladesh for identifying and proposing the need for the D-8 Youth Council and utilizing their human capital as well as augmenting their capacities through the implementation of the Council;

Mindful of the challenges of climate change and its profound impacts due to anthropogenic processes on the growth and developmental aspirations of developing nation-states in particular and expressing our commitment to combined efforts in achieving effective adaptation to climate change through building climate resilience as enunciated by the People's Republic of Bangladesh as the current Chair of the Climate Vulnerable Forum (CVF), to reduce the vulnerability of the people especially youth of the D-8 Member States;

Affirming the importance of enhanced and deepened cross-sectoral cooperation for a more intensive private sector engagement in all youth activities in order to realize the intra-D8 Youth aspirations;

Noting the benefits of tapping into the immense potential of the 'Blue and Green Economy' as well as the principles of circular economy, which could further fuel the growth of the economic pie and boost prosperity across the D-8 Member States.

Expressing our resolution to fight against all threats to economic development as well as peace and prosperity of the D-8 Member States, including, among others, terrorism, sectarianism and extremism in all forms and manifestations;

Confirming our opposition to the catastrophe brought by the attacks of Israel to the Palestinian People, including the youth, throughout Palestine, especially in the Gaza Strip and the West Bank.

Reiterating our opposition to the inhumane acts performed by Israel aiming to make the occupation constant and strip Palestinian People off all their rights, especially their freedoms and right to form a fully independent and sovereign country on their national territory.

Welcoming the Communique named "Solidarity with Palestinian People" adopted at the 47th D-8 Commission on 23 October 2023, United Nations General Assembly's Resolution adopted at the 10th Emergency Special Session on 12 December 2023, OIC Resolution on the Issue of Palestine and Al-Quds Ash-Sharif adopted by the 15th Session of the Islamic Summit Conference on 4-5 May 2024 and recalling the decisions adopted by the United Nations and other international

organizations with regards to the freedom and independence of Palestinian People throughout all their territory.

Do hereby,

- Welcome the establishment of the D-8 Youth Council in Bangladesh with the valuable support of the Member States in the entire process. We also commend the staunch commitment of the Government of the People's Republic of Bangladesh to establish and host the D-8 Youth Council and assure full support for the promotion of the D-8 Youth Council.
- Applaud the efforts of strengthening the best practices of D-8 Member states, especially digital skills for the smart young generation, through green jobs, eco-tourism, sports and cultural activities, technological advancement and innovation, vocational and non-formal education, entrepreneurship and climate resilience for its development.
- Encourage Member States to explore the possibilities of developing a D-8 youth development strategy as an integral process which will be the basis for the work of the D-8 Youth Council.
- Acknowledge the need for continuous and effective collaboration in training and capacity building of D-8 Youth and agree to establish a D-8 Youth Exchange program among the D-8 Member States.
- 5. Invite the Member States to share youth activities with the D-8 Secretariat for exchange of best practices in order to develop the friendship and fraternity bonds among the D-8 youth and to ensure that they are closely acquainted with each other's cultures.
- 6. Request the D-8 Secretariat to prepare "D-8 Cooperation Action Plan for Youth" by 2024 in a way to enable that one or two youth activities are held annually according to the proposals of the Member States.
- Agree to enhance our collective effort to engage the youth and to ensure their participation in the new reality of 4IR as envisaged in the first ever D-8 Youth Summit held on 21 April 2021.
- 8. Appreciate the organization of the "25 Years of D-8: Resilient Youth in Mutual Cooperation" as a part of the D-8 Jubilee in Dhaka, Bangladesh, in 2021.
- 9. Agree to hold D-8 Ministers and Senior Officials Meeting on youth regularly.

- 10. Acknowledge the commendable work done by H.E. Ambassador Isiaka Abdulqadir Imam, the Secretary-General of the D-8 and the D-8 Secretariat in promoting youth empowerment and mainstreaming it in the agenda of the D-8.
- 11. Express profound appreciation to His Excellency Mr. Nazmul Hassan, MP, Hon'ble Minister, Ministry of Youth and Sports, the Government of the People's Republic of Bangladesh, for his excellent chairing of the meeting and for the success during his chairmanship of D-8 Youth.
- 12. Congratulate the Government of the People's Republic of Bangladesh for the excellent preparation and the successful hosting of the 1st Meeting of the D-8 Youth Ministers and the D-8 Senior Officials Meeting on Youth and express utmost gratitude for their warm welcome and hospitality extended to all delegations.
