Report of The 48th Session of the D-8 Commission Cairo, Egypt, 16 December 2024

The 48th Session of the D-8 Commission was held in Cairo, on 16 December 2024, hosted by the Arab Republic of Egypt in its role as the new Chair of the D-8 Organization. The meeting was Chaired by **Ambassador Ragui El-Etreby**, the D-8 Commissioner and Assistant Minister for Multilateral, International and Regional Economic Affairs, Ministry of Foreign Affairs, Egypt.

Commissioners/Delegates from all Member States attended the meeting. The list of participants is attached as **Annex-I**.

Agenda Item 1: Opening.

Secretary-General, Ambassador Isiaka Abdulqadir Imam, opened the meeting by welcoming the delegates. He invited the D-8 Commissioner from the People's Republic of Bangladesh, the outgoing Chair of the Organization, to formally hand-over the Chairmanship to the Arab Republic of Egypt.

Ambassador Ragui El-Etreby, the incoming Chair, warmly welcomed the delegates and reaffirmed Egypt's commitment to collaborative efforts in advancing the Organization's agenda. He expressed gratitude to Bangladesh for its significant contributions as the Chair of D-8 and acknowledged the progress achieved under its leadership.

He further informed the delegates that Egypt has signed the Preferential Trade Agreement, and the Bill for its ratification is currently under active consideration in Parliament, with ratification expected in the near future.

Agenda Item 2: Consideration and Adoption of the Draft Agenda.

The meeting considered its agenda and adopted with amendments. The adopted Agenda is attached as **Annex-II**.

Agenda Item 3: Statement and progress report on D-8 Organization's activities since October 2023, by the D-8 Secretary-General.

Ambassador Isiaka Abdulqadir Imam, the Secretary-General of D-8, presented reports on the Organization's activities since the 47th Commission meeting held in Dhaka, Bangladesh, in October 2023.

The progress reports on Sectoral Cooperation, Trade, and External Relations, along with his statement, are attached as Annex-III.

Agenda Item 4: Statements by the Heads of Delegations

Heads of Delegation from each Member State delivered their remarks, extending their congratulations and appreciation to the Arab Republic of Egypt for assuming the Chair of the D-8 Organization and for hosting the 11th Summit, the 21st Council and the 48th Session of the D-8 Commission in Cairo. The Delegates also expressed their utmost gratitude and congratulate the People's Republic of Bangladesh for steering the Organization during its chairmanship from 2021 until 2024. They also commended the efforts of the Secretariat and the Secretary-General in advancing the Organization's cooperation agenda.

The statements are attached in Annex-IV.

Agenda Item 5: The D-8 Organization Expansion

- a. <u>Consideration of criteria and modalities for new members and observers of the D-8</u> <u>Organization.</u>
- b. <u>Consideration of the membership application from the Republic of Azerbaijan</u>.

The Chair and D-8 Commissioner of Egypt informed the meeting that the criteria and modalities for new members and observers had consensus by seven member states at the last Commission meeting. He informed the meeting that Egypt now also joins the consensus with other member states on both documents.

The Commissioner of Iran proposed minor amendments in the draft criteria and modalities which was accepted by all member states. After incorporating the amendments proposed by Iran, both documents were adopted by the esteemed Commission. The adopted Criteria and Modalities for new members and observers are enclosed as **Annex-V**.

The Commissioner of Indonesia brought to the attention of the esteemed Commission the effect of inclusion of new members and observers into the Organization and sought clarification on its implications on the D-8 Charter.

The Chair sought clarification from the Secretariat on the issues raised by Indonesia. The Secretary General informed that any changes in terms of granting Membership or Observer status, can be reflected as an Addendum to the D-8 Charter. He also pointed out that an appropriate paragraph to this effect is contained in the Declaration as well.

The Chair opened the floor for discussion on membership application from the Republic of Azerbaijan. The meeting adopted Azerbaijan's admission as a full member with consensus and recommended it to the Council of Ministers for approval.

Agenda Item 6: Consideration and adoption of the candidature of the Director-I nominated by the Republic of Türkiye.

The Delegation of Türkiye requested the meeting to defer the nomination for the position of Director-I, stating that the nomination of Türkiye's candidate for the post would be shared with the Member States through the Secretariat in due course.

The Chair and the Commission expressed their appreciation for the contributions of Mr. Ahmar Ismail, the outgoing Director-I of the Secretariat, and extended their best wishes for his future endeavors.

Agenda Item 7: Preparation for the 21st Session of the D-8 Council of Ministers and the 11th D-8 Summit.

The delegate from Egypt updated the meeting on the preparations to host the 21st D-8 Council of Ministers and the 11th D-8 Summit, including protocol and administrative arrangements.

The Secretary General presented the draft agendas for the 21st D-8 Council of Ministers and the 11th D-8 Summit, providing a detailed briefing to the meeting.

Following deliberations, the draft agendas were agreed upon and attached as Annex-VI.

The meeting reviewed and agreed upon the draft Cairo Declaration 2024 after incorporating amendments suggested by member states. The Commission recommended its submission to the Council of Ministers for approval. The agreed upon document is attached as **Annex-VII**.

The Commissioner of the Republic of Türkiye informed the meeting about Türkiye's continued desire to have a permanent post of Deputy Secretary-General in the Secretariat. The Commission decided to discuss the matter in its future sessions in the context of the recommendation made during the 20th Session of the Commission held in Bali in 2006.

Agenda Item 8: Consideration of financial and administrative matters of the D-8 Secretariat.

a) <u>Consideration, adoption, and recommendation of the proposed draft budget of the</u> <u>Secretariat for 2025.</u>

The Secretary-General presented the proposed draft budget of the Secretariat for 2025 for the esteemed Commission's consideration and adoption.

The draft budget had already been agreed upon during a series of virtual 'Senior Officials Meetings' from Ministries of Foreign Affairs of Member States, held on 25 November, 4 December, and 9 December 2024, respectively.

The Commissioner of Iran invited attention of the Commission on revision of the scales of assessed contributions, as well as a need to establish a mechanism for annual increment of the salaries of the Secretariat staff.

Türkiye stated that it was content with the current scale of assessed contributions and pointed out that all the outstanding arrears towards budgetary contributions needed to be paid as a matter of priority. Türkiye further stated that there was no pressing need to discuss the revision at the moment.

Pakistan and Malaysia expressed their agreement to discuss the revision in scales of assessment of member states.

Bangladesh highlighted that a mechanism needed to be proposed to sustain sufficient funds in the General Reserve Fund (GRF).

Indonesia expressed its concern over the salary discrepancies between the Directing Staff position and general/local staff, and the continued utilization of the General Reserve Fund and requested the Secretariat to address those issues.

The Chair decided to discuss any future matters of importance, including the budgetary matters, through virtual meetings of the Senior Officials. It was also decided that Senior Officials Meetings on Budget would be held prior to Commission meetings on a regular basis.

After deliberations, the meeting adopted the proposed draft budget of the Secretariat for 2025 and recommended the 2025 budget, including the GRF, for approval by the Council of Ministers.

The adopted budget is attached as Annex-VIII.

Agenda item 9 - Update on the Calendar of Events for 2025-2026

The Secretariat presented the Draft Calendar of Events for 2025-2026 to the Commission. Delegates updated the Commission on their countries' readiness to host the enlisted events. An updated Calendar of Events is attached as **Annex-XI**.

Agenda Item 10 – Date and Venue for the 49th Session of the D-8 Commission.

The delegation of the Arab Republic of Egypt informed the meeting of its readiness to hold the 49th Session of the D-8 Commission, tentatively during the second quarter of 2025. The exact date and venue will be communicated to all Member States through the D-8 Secretariat in due course.

The Commissioner of Iran reiterated his delegation's proposal that at least one Commission's session per year may be convened in the premises of the Secretariat.

Agenda Item 11: Consideration of the nomination for the next Secretary-General from Pakistan.

The Commissioner from Pakistan presented the nomination of Ambassador Sohail Mahmood by the Government of Pakistan for the position of the Secretary General of the D-8 Organization, starting from 1 January 2026.

The Chair and the Commission commended and appreciated the services of Ambassador Isiaka Abdulqadir Imam and commended his contribution to advancing the agenda of cooperation of the D-8 Organization.

The Commission endorsed the nomination of Ambassador Sohail Mahmood as the next Secretary-General of the D-8.

Agenda Item 12- Consideration of the Joint Communique on the situation in Palestine and Lebanon.

The meeting reviewed and adopted the draft Joint Communique after incorporating amendments suggested by member states. The Commission recommended its submission to the Council of Ministers for approval. The adopted document is attached as **Annex-X**.

Agenda Item 13 - Consideration and Adoption of the Report of the 48th Session of the D-8 Commission

The D-8 Commission considered and adopted the Report of its 48th Session.

Closing of the Meeting.

The meeting expressed its appreciation to the Arab Republic of Egypt for the excellent arrangements made in organizing the Commission meeting, as well as the upcoming Council of Ministers and Summit meetings scheduled for 18 and 19 December 2024, respectively.

The meeting also commended the Chair for his capable leadership in presiding over the meeting and acknowledged the Secretary General and the Secretariat for their outstanding preparations for the meeting and its accompanying documents.

The meeting was closed on Monday, 16 December 2024.

STATEMENT BY HIS EXCELLENCY, AMBASSADOR ISIAKA ABDULQADIR IMAM, THE SECRETARAY GENERAL OF THE DEVELOPING-8 ORGANIZATION FOR ECONOMIC COOPERATION, AT THE 48TH SESSION OF THE D-8 COMMISSION MEETING, IN CAIRO EGYPT – 16-17 DECEMBER 2024.

Ambassador Ragui El-Etreby, Assistant Minister for Multilateral International and Regional Economic Affairs, Ministry of Foreign Affairs of Egypt and Chair of the D8 Commission,

Excellencies D-8 Commissioners,

Distinguished Participants,

Ladies and Gentlemen,

Asalam o Alaikum and very good morning to you all,

It is an honor and privilege for me to address this esteemed gathering of Commissioners of the D-8 Organization, at the 48th Session of the D-8 Commission, here in this vibrant city of New Cairo. Egypt holds a special place in my heart, as I have a deep emotional connection, with this country. One, my late father, His Excellency Ambassador Abdulkadir Muhammad Sambo Imam, served as the Ambassador of Nigeria to Egypt from 1978 to 1984. Two, I completed my graduation, at the American University in Cairo in 1985, which add to my bond, with this remarkable nation.

I would like to start by expressing my gratitude to the Arab Republic of Egypt, our gracious host, for their hospitality and meticulous arrangements for this meeting. We deeply appreciate their efforts in preparing today's and tomorrow's Meeting, as well as the upcoming sessions of the 21st Council of Ministers and the 11th D-8 Summit, scheduled for December 18 and 19, 2024, respectively.

I also congratulate Egypt, on her assumption of the D-8 Chairmanship. This is Egypt's second tenure as Chair of the organization, the first was in 2001. Therefore, I wish to offer my full support and best wishes to Egypt.

Also, I would like to commend the People's Republic of Bangladesh, for the exemplary leadership, during their tenure as Chair, particularly during the challenging times of the COVID-19 pandemic. Despite the unprecedented difficulties, Bangladesh demonstrated resilience and innovation, introducing virtual meetings and successfully hosting the Tenth D-8 Summit, online on 8 April 2021. Under their leadership, significant progress was made toward achieving the goals set by our leaders at the Tenth Summit, and for that, they deserve our deepest appreciation.

I also warmly welcome the newest members of the D-8 Commission family, from **Bangladesh**, **Malaysia**, **Nigeria**, **and Türkiye**. I am confident that our new Commissioners will infuse fresh energy into our work, and their expertise will be deployed for the benefit of enhancing D-8 cooperation agenda.

Honourable Chair, Excellencies, Distinguished Participants, Ladies and Gentlemen,

We are navigating challenging times, as world economy grapple with the burden of conflicts, climate change, unilateral and unjustified trade embargoes, which create imbalances and threaten global stability. These realities, call for an innovative agenda of cooperation, as well as stronger collaboration to support and protect our member states.

Since I assumed the role of Secretary-General of our noble organization, I have prioritized the promotion of both traditional and creative avenues of cooperation, with particular emphasis on fostering private-sector engagement, and integrating it with the public sectors, of our member states. Under my leadership, we have 4 achieved significant milestones, and details of such achievements are contained in the Progress Report, which is placed before you.

However, allow me Mr. Chair, to highlight some of the key achievements, recorded since my assumption of office. These include:

 Trade: In the area of trade, I am happy to report that Türkiye and Indonesia have commenced the implementation of the D-8 Preferential Trade Agreement, since 2022 and 2024, respectively. I look forward to the organization-wide application, of this crucial instrument, to boost our intra-trade.

Also, I am happy to report that Egypt is set to be a Contracting Member of the D-8 PTA very soon, marking a monumental milestone for the D-8, under the Egyptian D-8 Presidency, as all D-8 Member States will soon be D-8 PTA Contracting Members. In the same period, we were able to conclude negotiation on the Dispute Settlement Mechanism (DSM) Protocol of the D-8 PTA, which was adopted during the 3rd D-8 Trade Ministers Council Meeting in Dhaka March, this year. Four D-8 PTA Contracting Members, also signed the DSM Protocol, during the informal meeting of the D-8 Trade Ministers in Istanbul last June.

- Tourism. In the area of tourism, we were able to advance our Tourism Cooperation, with the successful launch of the D-8 Tourism City of the Year Award, in which the City of Antalya in Türkiye, was unanimously selected as the inaugural recipient for 2025.
- **Agriculture:** In the area of agriculture, and food security, we successfully introduced Thematic-Based Agriculture Initiatives

and organized workshops on climate-smart agriculture techniques, hosted by Türkiye and Bangladesh.

Furthermore, we finalized an MoU, with the Islamic Organization for Food Security (IOFS), and successfully inaugurated the D-8 Research Center for Agriculture and Food Security, in Faisalabad, Pakistan. The center now actively collaborates with member states, and partners, like IOFS and FAO.

- Youth. In the area of youth development, I am happy to report that the proposed D-8 Youth Council, which Bangladesh will host, is at the final stage of taking off. Once operationalized, the Youth Council will involve and engage young people, in cooperative efforts.
- External Relations: We have recorded resounding success in the area of external relations, by building strong partnerships, with the International Organizations, such as, the UN, UNCTAD,

UNDESA, OIC, ECO etc. These collaborations have contributed to the work of the D-8, particularly in the areas of developing an e-Government experts' network and enhancing our organization's visibility, globally.

Furthermore, we have leveraged on social and electronic media, to boost publicity and outreach. This has significantly enhanced our organization's image and showcased our activities, in the member states, and globally.

Private-Sector Engagement: We have strengthened our engagement with the private sector in member states, particularly the D8CCI, to promote trade and economic cooperation, as mandated by the 2030 Decennial Roadmap. Initiatives like the D-8 Creative Economy and Financial Center, the New Generation Barter Trading System and the D8 Payment Card, which we are pursuing with vigor, along with our partners in Malaysia and Türkiye, hold great potential for economic integration and trade facilitation, when they become fully operational.

These accomplishments, **Excellencies,** reflect our collective commitment to fostering meaningful cooperation, leveraging innovative strategies, and ensuring sustainable growth for all member states.

Excellencies, Distinguished Participants, Ladies and Gentlemen,

Today's agenda, for discussion, is well-focused, covering key issues of importance, such as the following:

1. Expansion of the Organization:

The esteemed Commission, will review the membership application of the Republic of Azerbaijan, as well as finalize the draft criteria and modalities, for admitting new members and observers to the D-8 Organization.

2. Nomination of the Next Secretary-General and the Director-I Position

The Islamic Republic of Pakistan, will brief the Commission on its nomination for the next Secretary-General, who will assume office in January 2026.

Also, the Republic of Türkiye, will introduce its candidate for the position of Director-I, which will become vacant on August 8, 2025. This position is currently held by Pakistan.

3. Preparations for Upcoming Statutory Meetings:

The Arab Republic of Egypt, will update the Commission on preparations for the 21st Council of Ministers' meeting and the

11th D-8 Summit. Egypt will also present the agendas, for these meetings, seeking the Commission's adoption.

4. Outcome Documents for the 11th D-8 Summit:

As Chair of the Organization, Egypt will introduce drafts of the summit outcome documents, namely, the *Cairo Declaration 2024* and **the** *Joint Communiqué on Humanitarian Crisis and Reconstruction Challenges in Gaza and Lebanon.* The Commission will deliberate on these drafts and forward them, after adoption to the Council of Ministers for endorsement.

5. 2025 Budget Proposal:

The Secretariat, will present its proposed budget for 2025, for the Commission's review and adoption. The budget has been deliberated and endorsed by member states' senior officials and is ready, for further endorsement, by this noble Commission, for adoption.

6. Calendar of Events for 2025 and Beyond:

The Secretariat, will also propose a draft calendar of events, for 2025 and beyond. The Commission will discuss, finalize, and adopt, this calendar of events.

Each of these agenda items is crucial, to advancing the goals and priorities of our organization, and we look forward to productive deliberations and decisions.

Honourable Chair, Excellencies, Distinguished Participants, Ladies and Gentlemen,

In conclusion, I extend my best wishes, for productive deliberations and a successful outcome, for today's meeting, as well as the upcoming statutory meetings—the 21st Council of Ministers and the 11th D-8 Summit meetings—that will follow this Commission session.

5. With a combined GDP of USD 4.8 trillion... D-8 is among the world's largest economies.

6. Yet our intra-trade in 2023 stood at only USD 145 billion... barely reflecting its true potentials.

7. Collective implementation is therefore required to bolster our economic gains.

8. This includes commencing the expansion of offer lists... and organizing trainings and dedicated sessions for entrepreneurs.

9. Second, fostering halal economies.

10. Global halal market is projected to reach USD 10 trillion by 2030.

11. Two D-8 Member States are currently among top 10 exporters to OIC countries.

12. Leveraging this opportunity must begin within our camp.

13. For example, engaging with business communities to broaden halal market access... and working towards mutual recognition of halal standards.

14. Third, on the admission of new members.

15. Expanding D-8 membership could reinvigorate collaboration and boost its global visibility.

16. Such expansion must align with the organization's best interests...as stipulated within D-8 Charter.

17. Lastly, regarding D-8 Secretariat's budget.

18. Sustainable financing for our organization must be a foremost priority, though it must align with economic realities.

19. Indonesia welcomes the agreement reached at the virtual meeting on 2025 budget, and underscores the need to gradually replenish the Reserve Fund.

20. We also commend the Secretariat's initiatives to expand collaboration with other organizations, to ensure efficiency in its works.

21. Addressing financial constraints will enable us to advance cooperation to other critical areas, such as climate change and women's economic empowerment.

22. To conclude, let me reiterate our steadfast commitment to the organization in driving our growth... and contributing effectively to the global agenda.

His untimely passing following a brief illness is a great loss to the Organisation. May his soul rest in peace, and may his family and loved ones find solace and comfort during this time of loss.

Fellow Commissioners,

D-8 Expansion

5. The establishment of D-8 is now coming to its 28th year. It is in our interest to consider the expansion of the Organisation. On the accession of new members, Malaysia wishes to reiterate our stand and remain supportive of Azerbaijan's membership application. Azerbaijan's desire to enhance cooperation with the D-8

Member States and to become a catalyst for new joint initiatives would expand our programmes' reach to more people.

6. Malaysia firmly believes that expanding the D-8 membership would bring the Organisation to greater heights in line with the aspirations of our leaders as stipulated in the Dhaka Declaration 2021 and the D-8 Decennial Roadmap 2020-2030.

7. While Malaysia believes specific standards must be adhered to when considering a new application for membership in the Organisation, our action must be seen as sincere in accepting applications to expand our Organisation.

The D-8 Private Sector Initiatives

8. Malaysia acknowledges the importance of enhanced private-sector engagement in the Organisation's activities. We believe these initiatives would produce progressive results and further improve the socio-economic levels of our Members. Malaysia hopes that work on the existing private initiatives could be expedited.

9. Two Malaysian-led initiatives, the D-8 Creative Economic and Financial Centre (D-8 CEFC) and D-8 Payment Card have made positive progress in the past year and we hope that Member States will be able to utilize the platforms in the near future.

10. On D-8 PTA, Malaysia wishes to inform that we had operationalised D-8 PTA on 1 October 2023.

D-8 Secretariat's Budgets for 2025

11. At our last Senior Officials Meeting, we discussed at length the critical issues concerning the Secretariat's budget for 2025 onwards, particularly concerning the growing cost of the staff's salaries and remuneration.

12. Malaysia acknowledges that the fluctuations and uncertainties in the global economy have indirectly impacted the consumer price index and inflationary rate in Istanbul; and that it necessitates budgetary adjustments.

13. While Malaysia supports the proposed adjustments of the 2025 budget in principle, we view that the matter would require policy decisions by the respective Member States.

New Secretary-General of D-8

14. Malaysia welcomes Pakistan's nomination of the incoming Secretary-General for the term 2026-2029. Malaysia looks forward to working closely with the new Secretary General during his term.

<u>Conclusion</u>

15. Malaysia stands ready and looks forward to working with the Secretariat and all the Member States to build a better future for the D-8 and its people. I wish all of us a successful meeting.

Rules of procedures for implementing Article 3 of the D-8 Charter regarding accession of new members to the D-8 Organization

Guided by the purpose and principles of the Charter of D-8 and provisions of the Articles 1, 2 and 3 of the D-8 Charter, following Criteria and Modalities will be applied for granting the membership:

<u>Criteria for independent States as Members</u>

- 1. The applicant States shall commit to adhere to the objectives and principles of the Organization, as contained in Articles 1 and 3.5 of the Charter.
- 2. The applicant State shall possess comparable socio-economic level of development as that of existing member States.
- *3.* Without prejudice to the membership drive, in accepting new members, D-8 may consider ensuring the balanced (equitable) geographical representation.

Modalities for Granting Full Membership

- 1. The application of the interested state must be submitted formally in writing to the Secretary-General of the D-8.
- 2. The application shall be accompanied by a formal declaration indicating its willingness to adhere to the purposes and principles of the Organization.
- 3. On receipt, the Secretary-General shall circulate the application to all Member States and submit the application to the Commission for their consideration.
- 4. Subject to the recommendation of the Council of Minister, the Summit may approve the application, by consensus, for granting membership to the D-8 organization.

<u>Rules of procedures for implementing Article 4 of the D-8 Charter</u> <u>regarding granting Observer status to the D-8 Organization</u>

Guided by the provisions of the Article 4 of the D-8 Charter, following Criteria and Modalities will be applied for granting the observer status.

Criteria for Independent States/Countries

- 1. The applicant shall commit to adhere to the objectives and principles of the Organization, as contained in Articles 1 and 2 of the Charter.
- 2. Having the capacity and willingness to do so, the applicant may make a practical and valuable contribution to the Organization i.e., possible contribution to certain projects and / or events to be determined by the D-8 Council of Ministers.

<u>Modalities for Granting Observer status for Independent</u> <u>States/Countries</u>

- 1. The application of the interested state must be submitted formally in writing to the Secretary-General of the D-8.
- 2. The application shall be accompanied by a formal declaration indicating its willingness to adhere to the purposes and principles of the Organization.
- 3. On receipt, the Secretary-General shall circulate the application to all Member States and submit the application to the Commission for their consideration.
- 4. Subject to the recommendation of the Session of the Commission, the Council of Ministers may approve the application, by consensus, for granting an observer status.
- 5. Observer may participate in the opening and closing session of the principal organs and may participate in activities or relevant technical meetings of the Organization.
- 6. Decision to suspend or terminate the observer status may be decided in accordance with the Article 4 (4) of the D-8 Charter.

Criteria for Regional and International Organizations as Observers

The observer status may be accorded to inter-governmental Organization with similar objectives and principles to those of D-8.

<u>Modalities for Granting Observer Status for Regional and</u> <u>International Organizations</u>

- 1. Head of the applicant Organization shall submit an official request for the grant of observer status to the Secretary General of the D-8.
- 2. The application shall be accompanied by a formal declaration indicating its willingness to adhere to the purposes and principles of the Organization.
- 3. On receipt, Secretary-General shall circulate the application to all Member States and submit the application to the Commission for its consideration.
- 4. Any particular application for Observer Status should be discussed and decided at a maximum of two (2) Commission meetings.
- 5. In the situation where no consensus could be reached after the two Commission meetings, the application may not be considered further.

DRAFT CAIRO DECLARATION 2024

We, the Heads of State and Government/Representatives of the People's Republic of Bangladesh, the Arab Republic of Egypt, the Republic of Indonesia, the Islamic Republic of Iran, Malaysia, the Federal Republic of Nigeria, the Islamic Republic of Pakistan, and the Republic of Türkiye, forming the membership of the Developing-8 Organization for Economic Cooperation (D-8), gathered in Cairo on 19 December 2024, on the occasion of our Eleventh Summit, being held under the theme, "Investing in Youth and Supporting SMEs: Shaping Tomorrow's Economy."

Reiterating our pledge to advance our shared development goals under the principles of fraternity, peace, dialogue, justice, equality, rule of law, and democracy, established during the founding of the D-8, as encapsulated in our previous Summit Declarations.

Acknowledging our past progress should serve as a catalyst to renew our focus and intensify our efforts in addressing today's challenges, particularly in the light of the evolving global landscape.

Reiterating the value of unity, equality, mutual respect, and economic cooperation, we reaffirm our commitment to advancing partnerships in priority areas of cooperation, including agriculture and food security, energy, science, technology, industry, development of small and medium enterprises, infrastructure, trade, investment and transportation, to promote inclusive and equitable development that benefits our nations.

Reaffirming our shared endeavor to implement the D-8 Decennial Roadmap for 2020-2030 to deepen further economic cooperation, aligned with UN Development Agenda.

Reaffirming our faith in multilateralism and the importance of enhanced cooperation within the D-8 framework and with relevant regional and international organizations, particularly the United Nations, and the Standing Committee for Economic and Commercial Cooperation of the Organization of Islamic Cooperation (COMCEC) including strengthening South-South Cooperation, that is vital for promoting sustainable development, fostering peace, and addressing global challenges such as poverty, climate change, and inequality.

Realizing that the full and Organization-wide operationalization of the Preferential Trade Agreement Among D-8 Member States (D-8 PTA), the Multilateral Agreement among D-8 Member Countries on Administrative Assistance in Customs Matters (D-8 Customs Agreement), the Agreement on "Simplification of Visa Procedures, for the Businessmen of the D-8 Member States" (D-8 Visa Agreement) and transformation of the D-8 PTA into a more progressive instrument, such as a comprehensive economic partnership agreement will propel our economic power to a new height.

Emphasizing the need to promote investment opportunities and to increase intra D-8 trade with efficient mechanisms including on-line platforms, while also committing to inclusive growth, through the promotion of micro, small, and medium-sized enterprises (MSMEs) in

emerging sectors such as digital trade, e-commerce, and fintech, to ensure economic empowerment for all and intensifying efforts in improving logistics, transport, and regulatory frameworks.

Reaffirming our commitment to advancing cooperation in science, technology, and innovation through the existing mechanisms, to study key indicators and assess digital transformation opportunities, including emerging technologies such as artificial intelligence (AI) and the Internet of Things (IoT), to support our objectives.

Highlighting the importance of addressing climate change in the context of sustainable development and poverty eradication.

Recalling decision 14/30 of UNCBD COP14 on cooperation with other conventions, international organizations and initiatives, adopted at the fourteenth meeting of the Conference of the Parties to the Convention on Biological Diversity, in which the parties welcomed the initiative of the Government of Egypt to promote a coherent approach between the United Nations Framework Convention on Climate Change, the Convention on Biological Diversity and the United Nations Convention to Combat Desertification, to address biodiversity loss, climate change and land and ecosystem degradation.

Emphasizing the importance of promoting sustainable agricultural practices, as part of our collective endeavors to ensure food security and safety.

Acknowledging all Member States' participation in the Organization's activities must be strengthened, under the principle of fraternity and dialogue among members, in expanding our cooperation to achieve our shared objectives, and to that end.

We hereby,

- 1. **Appreciate** and commend the People's Republic of Bangladesh for its excellent stewardship and tireless efforts, since taking over the Chair's role in April 2021, which enabled the D-8 Member States to make significant progress in enhancing cooperation in our key areas of cooperation, as well as organizational expansion, visibility, and international collaboration and partnership, and **extend** our profound appreciation to the leadership of the People's Republic of Bangladesh, for their commitment and dedicated efforts in advancing the D-8 objectives, during their chairmanship of the Organization.
- 2. Express our heartfelt gratitude to His Excellency Abdel Fattah-El-Sisi, Honorable President of the Arab Republic of Egypt, as well as the Egyptian government and people, for successfully hosting the 11th D-8 Summit, and providing such gracious hospitality, and as such, pledge our full support and wish His Excellency the President, tremendous success as the Chair of the D-8 Organization.
- 3. Acknowledge the commendable work of **His Excellency**, **Ambassador Isiaka Abdulqadir Imam**, the Secretary-General of the D-8, during his tenure, which commenced on 1 January 2022, and appreciate his determination and meaningful efforts over the last three years, including, in effectively, managing the D-8 Secretariat.

- 4. Welcome the fruitful collaboration with many national, regional, and international organizations, such as the United Nations, the United Nations Trade and Development (UNCTAD), the United Nations Industrial Development Organization (UNIDO), the Food and Agriculture Organization of the United Nations (FAO), the World Intellectual Property Organization (WIPO), the World Trade Organization (WTO), the United Nations Tourism (UN Tourism), the Organization of Islamic Cooperation (OIC), the Islamic Development Bank (IsDB), the Islamic Organization for Food Security (IOFS), the Standards and Metrology Institute of the Islamic Countries (SMIIC), the Islamic Cooperation Youth Forum, the World Tourism Forum Institute, the Economic Cooperation Organization, (ECO) and encourage a more profound and broader collaboration with these organizations, to get support necessary for the realization of initiatives and projects to achieve the D-8 objectives.
- 5. Applaud the establishment of the D-8 Youth Council, which the Government of the People's Republic of Bangladesh will host in Dhaka and call on Member States to support its functioning to foster youth cooperation in the D-8 and, in the same vein, appreciate the Government of the People's Republic of Bangladesh, for hosting the First Ministerial Meeting on Youth on 22 May 2024, and look forward to the hosting of the Second Ministerial Meeting on Youth by Nigeria. Encourages the Member States to organize joint activities in the field of youth by taking best practices into account and invite the Secretariat to coordinate these activities within the framework of "the D-8 Cooperation Action Plan for Youth" to be prepared in line with the proposals of the Member States to continue to work in cooperation on Youth. Invites the Secretariat and Member States to continue to work in cooperation on the Constitution of the D-8 Youth Council until the Second Ministerial Meeting on Youth.
- 6. **Commend** the Arab Republic of Egypt for selecting "Investing in Youth and Supporting SMEs: Shaping Tomorrow's Economy" as the theme for this Summit, and welcome the initiative proposed by the Islamic Republic of Iran to establish a D-8 mechanism to support the innovative ideas of the D-8 youth, and Iran's readiness to hold exhibitions as well as scientific/technological/entrepreneurship tours and specialized meetings with the participation of the youth from the D-8 Member States.
- 7. **Express** appreciation to the Government of the Federal Republic of Nigeria for their commitment to hosting the D-8 Center for Small and Medium Enterprises in Abuja, including the provision of initial resources to facilitate its operationalization. Recognizing the Center's potential to advance entrepreneurship and collaboration among D-8 Member States, we encourage the timely completion of its setup and call on all Member States to extend their support whether technical, financial or through capacity-building to ensure its effective and sustainable operation.
- 8. **Congratulate** the People's Republic of Bangladesh for organizing the Third Meeting of the D-8 Trade Ministers Council (3rd TMC) in Dhaka on 5 March 2024, as well as the Republic of Türkiye for hosting the Informal Meeting of the Trade Ministers Council of

the D-8 Member States (Informal TMC) in Istanbul on $\underline{11}$ June 2024, which marked significant progress in advancing D-8 trade policies.

- 9. Welcome the announcement by the Arab Republic of Egypt to host the Fourth Meeting of the D-8 Trade Ministers Council in 2025, to further enhance existing D-8 trade policies especially through the participation and active engagement of SMEs; and to deliberate new mechanisms to expand and diversify trade among D-8 Member States, through digital trade facilitation platforms, e-commerce, and AI driven technologies.
- 10. Welcome the upcoming ratification by the Arab Republic of Egypt of the Preferential Trade Agreement Among D-8 Member States (D-8 PTA), marking the monumental milestone that all D-8 Member States are now Contracting Members of the D-8 PTA.
- 11. **Reiterate** the importance of effective implementation and operationalization of the D-8 PTA by all Contracting Members, including organizing capacity-building programs for relevant officials and appreciate that five Contracting Members have completed their internal procedures, to implement the D-8 PTA and call on those ready, to commence trading, under the framework of the D-8 PTA, without delay, to achieve the collective target of its value to at least 10% of the D-8 total external trade value, or at least US\$ 500 billion, by 2030, as outlined in the D-8 Decennial Roadmap for 2020-2030, and welcome the proposal to expand the D-8 PTA scope to meaningfully and equitably cover a wider array of significantly traded products, among the D-8 Member States, to make it more attractive to business entities.
- 12. Acclaim the adoption of the Dispute Settlement Mechanism (DSM) Protocol to the Preferential Trade Agreement Among D-8 Member States (D-8 PTA), during the 3rd TMC in Dhaka on 5 March 2024 and its subsequent signing by Bangladesh, Indonesia, Iran, and Türkiye, during the Informal TMC in Istanbul, and call on the D-8 Trade Ministers Council to devise means to expedite the process for the Protocol's entry-into-force, as seamless and as most straightforward as possible.
- 13. Note with keen interest the discourse on the need to upgrade the D-8 PTA to a more progressive instrument, such as a comprehensive economic partnership agreement, to enable the D-8 to be a more dynamic, powerful, competitive, and impactful economic bloc, including to venturing into potential sectors for trade in services, in the next phase of cooperation and tasked the D-8 Trade Ministers Council to conduct a study, scoping exercise, and comparative analysis, to identify the modalities and way forward, for the expansion of the D-8 PTA.
- 14. **Applaud** the adoption of the D-8 Trade Facilitation Strategy, during the Third Meeting of the D-8 Trade Ministers Council, which serves as a guideline for the D-8 Member States to strengthen intra-D-8 trade, by facilitating more accessible trade measures and Customs procedures, and call upon prompt implementation among Member States.

- 15. **Congratulate** Nigeria for assuming the Chair of the Supervisory Committee of the D-8 PTA starting in May 2024 and thank Bangladesh for their role as the immediate past Chair of the Committee.
- 16. Welcome the proposal to strengthen broader economic cooperation, through regular meetings of the economic ministers and their subsequent technical bodies of the D-8 Member States to provide a clear recommendation on crucial economic cooperation, including various novel ideas, to further promote the achievement of the D-8 economic objectives.
- 17. **Underline** the tremendous potentials of halal economy and commit to work together in boosting collaboration in this sector through capacity building initiatives and exchange of best practices to support the development of SMEs in halal industries.
- 18. **Direct** the D-8 Secretariat to conduct studies to devise ways to facilitate easier movement of businesspeople, among the D-8 Member States, guided by the Agreement on Simplification of Visa Procedures for Businessmen of the D-8 Member States.
- 19. Emphasize the importance of enhancing agricultural productivity, improving food security, and fostering rural development through joint initiatives, agricultural innovation, resilient agri-food systems, including sustainable farming techniques, sustainable land and water management practices, and the adoption of modern agricultural technologies, while reaffirming our commitment to fostering agricultural trade and strengthening food supply chains among us, while highlighting the need to increase resilience to external shocks, such as climate change, pandemics, and geopolitical disruptions, and to that end, commend the 7th D-8 Ministerial Meeting on Agriculture and Food Security hosted virtually by the Government of the People's Republic of Bangladesh in Dhaka on 13 January 2022.
- 20. **Commend** efforts by the D-8 Research Center for Agriculture and Food Security (D-8 RCAFS) in Faisalabad, Pakistan, in organizing activities and training programs, under the joint action plan, signed with the Islamic Organization for Food Security (IOFS).
- 21. **Commit** to enhancing cooperation in sustainable tourism, cultural exchange, and heritage preservation, to promote mutual understanding and socio-economic development, as tourism is a vital economic sector, for D-8 Member States and, for such a purpose, encourage Member States to develop joint initiatives, to boost intra-D-8 tourism, such as simplifying visa procedures, improving regional tourism infrastructures, and implementing collaborative marketing strategies.
- 22. Welcome the announcement by the Arab Republic of Egypt to host the fourth D-8 Ministerial Meeting on Tourism in Aswan, in 2025, and congratulate the Islamic Republic of Pakistan, for successfully hosting the Third D-8 Ministerial Meeting on Tourism on 5 August 2023.

- 23. **Commend** the D-8 Secretariat for successfully launching the inaugural D-8 Tourism City of the Year Award and congratulate the City of Antalya in the Republic of Türkiye, on its selection as the first D-8 Tourism City of the Year 2025, and express confidence that this initiative will boost tourism, encourage investment, infrastructure development, and cultural exchange, while promoting healthy competition among Member States, and to that end, call on all Member States to support this important initiative and promote travel to Antalya in 2025.
- 24. Acknowledge the need to enhance cooperation in the energy sector, including through engagement with the relevant international organizations, to promote the development and application of energy-efficient technologies and renewable energy and to foster private sector investment in new and renewable energy, to assist our countries in their pathways to just transition.
- 25. **Commend** the Organization's effort to improve cooperation in enhancing connectivity, including a more substantive collaboration in air connectivity and civil aviation, and appreciate the Republic of Indonesia for hosting the 12th meeting of the Director General and Experts Working Group on Civil Aviation (DGCA) in Bali, Indonesia, from 20 21 October 2022, and the Republic of Türkiye, for hosting the 13th D-8 Meeting of the DGCA in Antalya, Türkiye, from 12 14 November 2024.
- 26. **Emphasize** that measures taken to combat climate change, including unilateral ones, should not constitute a means of arbitrary or unjustifiable discrimination or a disguised restriction on international trade.
- 27. **Call for** allocating adequate, predictable and accessible finance from developed to developing countries, for just energy transition, in line with the principles of Common but Differentiated Responsibilities and Respective Capabilities CBDR-RC. Stressing that new industrial development models associated with this transition would require enormous investments in existing and new infrastructure.
- 28. Underline the importance of an ocean-based economy to support our shared objectives, while prioritizing the protection of marine biodiversity, promoting sustainable fisheries management, and ensuring the conservation of critical habitats to sustain livelihoods and ecological health by harnessing cooperation in fisheries and aquaculture, renewable ocean energy, seaports and shipping, marine biotechnology, offshore hydrocarbons and seabed minerals, deep sea mining, including through public-private-partnership, to attract investment in this sector.
- 29. Encourage cooperation, among D-8 Member States' academic communities and commend the D-8 Secretariat for establishing the D-8 Network of Pioneers for Research and Innovation (D-8 NPRI), chaired by COMSATS University in Islamabad, Pakistan, which, to date, is participated by 28 prominent universities from six Member States, and encourage the remaining Member States to invite their research-focused universities to participate, to

enable the NPRI to play a more significant role in promoting innovation and research as well as advancing commercialization and project-based development, share of experience in developing research strategy, and visit to various research institutions, across all Member States, and as such, we commend the University of Ilorin of Nigeria, for hosting the Third Meeting of the D-8 NPRI in Ilorin, Nigeria, in November 2024.

- 30. Welcome the Arab Republic of Egypt's initiative to establish the D-8 Network for Economic Think Tanks, to serve as a platform for sharing information, exchanging ideas, and enhancing partnerships among think tanks in order to develop informed solutions to the pressing economic development challenges, facing the D-8 Member States, foster economic cooperation and trade, promote the sharing of best practices in economic development, and enhance capacity building in areas such as trade facilitation, entrepreneurship, innovation and digital economy and trade.
- 31. **Commend** the cooperation in human resource development, including the institutionalization of Diplomatic Training for the Diplomats from the D-8 Member States, which will serve as an investment for the future, by promoting networking from an early stage and noted with utmost appreciation to Bangladesh, Pakistan, and Türkiye, for already organizing diplomatic training, in their respective institutions, and call on other Member States to organize similar programs.
- 32. Welcome the Arab Republic of Egypt's initiative to establish a network for diplomatic institutes and academies in D-8 Member States to foster cooperation among them through [EG] creating a platform for regular dialogue on emerging issues in diplomatic and foreign policy training, encouraging the exchange of ideas among institutes, coordinating on the development of cutting-edge training programs, enhancing the quality and relevance of courses and programs offered by participating institutes, and creating a virtual space for joint discussions on topics such as development, economic diplomacy, food security, energy, trade policies, and climate change.
- 33. **Applaud** the commendable efforts of the D-8 Technology Transfer and Exchange Network (D-8 TTEN) in Tehran, in fostering cooperation among D-8 countries, through encouraging transfer of technology and the exchange of best practices and recognize the significant impact of regular events, organized by D-8 TTEN, such as the Technology Investment Meeting (TIM), the Business & Technology Meeting (BTM), and the Technology Transfer Award (TTA), in promoting innovation and collaboration. Furthermore, we commend the forward-looking proposals put forth by D-8 TTEN, including the D-8 AI initiative and the D-8 Co-Fund Initiative (D-8 CoFI), which aim to strengthen technological advancement and investment, within the D-8 community and call on Member States, to actively engage in and support these initiatives, for the collective progress of our nations.
- 34. Welcome the Collaborative Education Initiative by the Arab Republic of Egypt, to strengthen educational and scientific collaboration among D-8 Member States, through

establishing a periodic online competition for university and vocational students in the fields of artificial intelligence, engineering, science and applied technology with the aim to enhance student engagement through the recognition of their skills, and to foster innovation by encouraging students to develop creative solutions to global and regional challenges.

- 35. **Highlight** the huge potential impacts of new and emerging technologies, including AI, on our peoples and economies, we instruct the ICT related Ministries in D-8 to seriously consider the optimal ways and means to utilize these technologies for enhanced resilience, nationally and collectively, against possible future shocks. In this regard, welcome the proposal by the Islamic Republic of Iran that the upcoming meeting of the D-8 ICT Standing Committee, to be hosted by the Islamic Republic of Iran, should start working on the above instruction.
- 36. **Appreciate** the Islamic Republic of Iran for its continued support to the D-8 International University (D-8 IU) in Hamadan and commend the University for its efforts in expanding academic collaboration and fostering international research, through initiatives such as the 'International Bridge Initiative' and its diverse webinars and workshops, and encourage the Member States to support and contribute into its programs and activities.
- 37. **Call on** the D-8 Chambers of Commerce and Industry (D-8 CCI), to play a more significant role in strengthening economic cooperation, particularly trade and other business activities, through enhancing the productivity and competitiveness of the private sector and facilitating and coordinating business activities, by supporting innovation, investment, and entrepreneurship, as well as promoting cross-border trade and economic cooperation among Member States, and for such an objective, encourage the D-8 CCI to increase business-to-business engagement, among all D-8 Member States, by conducting business forums, one-on-one business matchmakings, business missions, and exchange of information on business opportunities.
- 38. Welcome the hosting by the Arab Republic of Egypt of the Fourth General Assembly of the D-8 CCI on the 17th of December 2024, which witnessed the handover of the D-8 CCI Chairmanship from Bangladesh to Egypt.
- 39. **Applaud** the D-8 Health and Social Protection Program (D-8 HSP) for carrying out a study on the revitalization of the therapeutic goods health market and hosting the First D-8 Forum on SME and Health in Abuja on 26-27 October 2022, and encourage Member States to promote trade in healthcare, particularly in pharmaceutical goods to ensure equitable access to health care and health products, and at the same time call on D-8 HSP, the D-8 TTEN, the D-8 NPRI, and the D-8 IU, to work together towards promotion of inter-state knowledge sharing, collaborative initiatives in health technology, and pharmaceutical innovation. In this regard Member States can work towards harmonizing their regulatory framework in line with the World Health Organization (WHO) standards and undertake

knowledge sharing, as well as collaborative initiatives in health technology and pharmaceutical innovation through mutual recognition agreements (MRAs).

- 40. Welcome the proposal by the Arab Republic of Egypt to strengthen D-8 health cooperation, through regular convening of meetings of health ministers and the subsequent technical bodies of the D-8 Member States and welcome the announcement by the Arab Republic of Egypt to host the first D-8 Ministerial Meeting on Health, in 2025, to discuss measures to advance preventative, therapeutic and rehabilitative health care, and to accelerate universal health coverage in D-8 Member States, through the inclusion of women and youth, not only as recipients of health care, but also as partners, in health policy making and implementation, including through utilizing digital technology and emerging technologies such as artificial intelligence.
- 41. Encourage the Secretariat to continue promoting private sector initiatives, including the D-8 Payment Card, the D-8 Creative Economy and Financial Center, and the D-8 New Generation Barter Trading. Urge all relevant ministries/agencies and institutions of Member States, to collaborate, closely, with the Secretariat to assess the feasibility of implementing these initiatives.
- 42. **Renew** our shared commitment to enhancing cooperation in disaster management, including strengthening joint efforts in disaster risk reduction, preparedness, and response, through collaborating on early warning systems, knowledge-sharing on best practices, and capacity-building initiatives to mitigate the impact of disasters.
- 43. Underscore our resolve to promote the economic empowerment of women, as a key driver of economic growth, and sustainable development, including enhancing opportunities for women in entrepreneurship, leadership, and the labor market, driven by the recognition of the vital role of women, in the economic and social progress of their nations, through eliminating barriers to women's economic participation, provide access to financial resources, and support initiatives that foster skills development and innovation, and task the D-8 Council, to work on this novel endeavor.
- 44. **Reaffirm** our opposition to any unilateral economic sanctions, imposed on D-8 Member States, that undermine global economic stability and violate international legal principles and demand the lifting of such sanctions.
- 45. **Support** the expansion of D-8 membership in accordance with Articles 3 and 4 of the D-8 Charter and appreciate the work concluded by the Council and the Commission to establish criteria and modalities for the new members and observers.
- 46. Welcome the Republic of Azerbaijan's accession as a full member in the D-8 Organization, and task the Council of Ministers to oversee the procedures related to its accession.
- 47. **Recognize** the importance of having a stronger and more efficient D-8 Secretariat, to ensure that our collective goals are effectively implemented and, therefore, call upon the

Council of Ministers to implement mechanisms to strengthen the Secretariat's capacity and resources.

- 48. Endorse the nomination of the upcoming Secretary-General of the D-8, Ambassador Sohail Mahmood from the Islamic Republic of Pakistan, who will assume office on 1 January 2026.
- 49. Welcome the Republic of Indonesia as the next Chair of D-8, and profoundly appreciate its gracious offer to host the 12th D-8 Summit, the date and venue of which will be communicated in due course.
- 50. **Reaffirm** our commitment to promoting peace, prosperity, and sustainable development. In this era of unprecedented global challenges, we must work together to create a more resilient and inclusive future for our people, guided by the values of cooperation, mutual respect, and shared prosperity, and our shared resolve to continue our cooperation, under Egypt's leadership and remain committed to the vision outlined, in the D-8 Decennial Roadmap for 2020-2030.

Joint Communiqué of the

Heads of State and Government of the D-8 Member States

on the situation in Palestine and Lebanon

Cairo, Egypt, 19 December 2024

We, the Heads of State and Government of the People's Republic of Bangladesh, the Arab Republic of Egypt, the Republic of Indonesia, the Islamic Republic of Iran, Malaysia, the Federal Republic of Nigeria, the Islamic Republic of Pakistan, and the Republic of Türkiye, forming the Summit of the Developing-8 Organization for Economic Cooperation (D-8), as well as the Republic of Azerbaijan, gathered in Cairo on 19 December 2024 at the generous hospitality of H.E. Abdel Fattah El-Sisi, the Honorable President of the Arab Republic of Egypt, on the occasion of our 11th Summit, with the participation of H.E. President of the State of Palestine, H.E. the Prime Minister of Lebanon, the Secretary-General of the League of Arab States and the Secretary General of the Organization of Islamic Cooperation, as guests of the Egyptian Presidency.

We reiterate our condemnation of the brutal Israeli aggression and the grave violations of the international law, the international humanitarian law and the human rights law by Israel, against the Palestinian people in the Gaza Strip, which caused an unprecedented humanitarian catastrophe and destruction of disastrous proportion. We warn against the danger of the escalation sweeping the region, the international consequences of the expansion of the Israeli aggression that has lasted for over one year in Gaza, which extended to include Lebanon, and further condemn the violation of sovereignty of the Republic of Iraq, the Syrian Arab Republic and the Islamic Republic of Iran. We also stress that this escalation should not impede the navigation in the Red Sea.

We deplore that since October 2023, over 44,000 Palestinians have been killed, 70% of them are women and children, and 105,000 people have been injured. More than 1.9 million people have been forcibly displaced and nearly 70% of the infrastructure in Gaza is destroyed, leaving almost the entire population without food, clean water, healthcare and basic shelter. Over 1,100 healthcare sites have been severely impacted by the Israeli attacks, leading to the resurgence of diseases. The risk of famine persists across the whole Gaza Strip, with 91% of the population projected to experience high levels of acute food insecurity between November 2024 and April 2025.

We express our concerns that as per the United Nations' report the GDP of the State of Palestine has contracted by around 35% and human development index (HDI) has fallen to 0.64 in 2024 with unemployment potentially rising to almost 50%, and that the HDI in Gaza, in specific, is projected to drop to 0.40, erasing over 20 years of progress.

We call for an immediate, permanent, and unconditional ceasefire in Gaza, support the ongoing efforts in this regard, in particular Egypt, and stress the need to fully implement the UNGA and UNSC resolutions to immediately allow the delivery of humanitarian aid in a broad, safe and unhindered manner, and the full and unconditional withdrawal of Israeli forces from the Gaza Strip. We reiterate, in this regard, the necessity for Israel to lift all restrictions, allow and facilitate humanitarian access to Gaza through its crossings and all available routes, as well to facilitate the provision and distribution of humanitarian assistance throughout the Gaza Strip, including in northern Gaza. We also categorically reject any displacement of Palestinian citizens outside their territory, which is a flagrant violation of International Law, and we call for providing the conditions for safe and unhindered return of displaced persons in Gaza to their homes.

We welcome the adoption of two recent Resolutions pertaining to the inherent rights of Palestinians at the 10th Emergency Special Session of the United Nations General Assembly on 11 December 2024, and urge the international community to operationalize these Resolutions in entirety and without delay.

We affirmed our strong support for the irreplaceable and indispensable role of the United Nations Relief and Works Agency for Palestine Refugees (UNRWA) in Gaza as well as in the rest of the Occupied Palestinian Territory and in host countries, and we reject any hindrance to the work of the Agency, including the Israeli practices aiming at impeding the Agency's lifesaving services.

We welcome the UN General Assembly Resolution ES-10/24 and the Provisional Measures Orders issued by the International Court of Justice, including the Order of 24 May 2024, which reaffirmed all previous provisional measures and indicated that Israel immediately halt its military offensive and any other action in the Rafah Governorate, which may inflict on the Palestinian group in Gaza conditions of life that could bring about its physical destruction in whole or in part and call upon all countries to ensure that the Orders issued by the Court are implemented without undue delay by Israel. We also call for the full implementation of the advisory opinion of the International Court of Justice dated July 19, 2024 towards ending the Israeli occupation, removing its effects, and paying compensation for its damages, as soon as possible. We express our grave concern as well from the illegal Israeli practices in the West Bank, including East Jerusalem, and reiterate, in this regard, the call to cease all Israeli settlement activities, land annexation, home demolitions, settler violence and military incursions in Palestinian towns of the West Bank. We also stress the necessity of maintaining the legal and historic status quo of the Holy Site in Jerusalem in word and in practice and condemn all Israeli violations in this regard.

The Israeli aggression that was extended to Lebanon and the bombing of Beirut, has also resulted in loss of thousands of innocent civilian lives, massive destruction of houses and infrastructure as well as a grave humanitarian situation. We welcome, in this regard, the ceasefire agreement that came into effect on the 27th of November 2024, and stress that this should contribute to the de-escalation in the region. We also stress the necessity to stop all violations of the agreement and call for the withdrawal of Israeli forces from Lebanon.

The cost of physical damages and economic losses in Lebanon, due to the Israeli aggression, are estimated at 8.5 billion US dollars. Over 4,000 people have been killed and more than 16,000 people have been injured. Lebanon's real GDP growth is estimated to be cut at least by 6.6% in 2024 and almost 100,000 housing units have been partially or fully damaged. Around 1.2 million have been internally displaced, with women, children, the elderly, persons with disabilities and refugees at highest risk.

Mindful of our shared responsibility to stand with Palestine and Lebanon and to alleviate the damage resulted from the Israeli aggression, we express our commitment to providing humanitarian assistance to the Palestinian people, as well as to the Lebanese people, supporting the early recovery, reconstruction and rehabilitation efforts in Gaza and in Lebanon, bilaterally and collectively, and strengthening our support and collaboration with other donor countries and relevant international organizations. We welcome, in this regard, the Cairo Ministerial Conference to enhance the humanitarian response in Gaza, held in Cairo on 2nd of December 2024. We also commit to mobilize overall economic support to both Palestine and Lebanon to enable them to overcome the consequences of the war.

We reaffirm our unwavering support to the struggle of the Palestinian people including the right to self-determination, and the implementation of all UN resolutions related to the Palestinian cause, and stress the necessity to address the root causes of instability in the Middle East through meeting all the legitimate rights of the Palestinian people, and establishing an independent, sovereign, and contiguous Palestinian State along the lines of 4 June 1967, with East Jerusalem as its capital. And we call in this regard for the recognition of the State of Palestine by all states that have not yet done so and fully support its full membership in the United Nations.

We also stress the importance of preserving the sovereignty and territorial integrity of the State of Lebanon and underscore the need to support its institutions, to fully implement the UNSC resolution 1701 (2006) and to enable the deployment of the Lebanese Armed Forces in the south of the Litani River, extending its control over the entire country.

We express our appreciation to the Arab Republic of Egypt for holding a dedicated session on the situation in Palestine and Lebanon and look forward to following-up on the outcomes of our deliberations.
